#### **Abstract**

The Forum of Labour Market Ministers has been actively engaged in supporting various strategies to address youth employability and related issues. One of the initiatives, led by the Government of Alberta and Human Resources Development Canada, is the gathering of additional information on various types of surveys of youth which are being conducted in the provinces and territories.

The goal of this project is to determine the type of youth-related surveys currently in place in Canada, to avoid the duplication of surveys among provinces and to allow the sharing of good ideas.

Each province was asked to complete one questionnaire for each of its surveys conducted during calendar years 1996, 1997 and 1998 and related to youth aged roughly 15 to 24. The subjects covered by the surveys were youth labour market, youth earnings, education/training, skills, and school-work transitions.

Eight provinces participated in the project, providing the 32 surveys described in the following pages.

## Résumé

Le Forum des ministres du marché du travail s'est consacré activement à appuyer diverses stratégies abordant la situation de l'emploi chez les jeunes et les questions qui y sont connexes. Une des initiatives, entreprise par le gouvernement d'Alberta et Développement des ressources humaines Canada, est la collecte de renseignements additionnels sur divers types d'enquêtes réalisées auprès des jeunes dans les provinces et territoires.

L'objectif de cette démarche est de déterminer le type d'enquête portant sur les jeunes en cours au Canada en ce moment, afin d'éviter le recoupement d'enquêtes dans les provinces et permettre la mise en commun de bonnes idées.

Chaque province a été priée de remplir un questionnaire pour chacune des enquêtes réalisées durant les années civiles 1996, 1997 et 1998 portant sur les jeunes âgés de plus ou moins 15 à 24 ans. Ces enquêtes abordaient des sujets tel que les jeunes et le marché du travail, l'éducation/la formation, les compétences et les transitions école-travail.

Huit provinces ont participé au projet, donnant lieu aux 32 enquêtes dont il est question dans les pages qui suivent.

## Follow-up of 1995 and 1996 High School Graduates

#### Department or agency responsible for the survey:

Newfoundland Department of Education

#### Survey objectives and purposes:

To provide information on the post-graduation activities of high school graduates of 1995 and 1996 and determine why students do or do not pursue further education beyond high school.

#### Main topics covered/variables listing/information:

Post-graduation activities of high school graduates, reasons for not attending, plans of graduates not pursuing a postsecondary education, expected level of education, funding sources, financial barriers, first choice of program.

### **Collection period:**

Fall 1995 (September - January) for the 1995 graduates and summer 1997 (June - September) for the 1996 graduates.

#### **Reference period:** —

Type of survey: Individual student

**Target population/coverage:** All high school graduates for 1995 and 1996.

#### Sample size:

1995 = 69681996 = 7251

**Data collection method:** Telephone survey

#### Methodology:

Graduate database was linked with all available postsecondary databases in the department to determine where graduates went after graduation. All graduates not found/matched were interviewed via telephone.

**Historical information:** Only surveyed in fall 1996 and summer 1997.

#### **Survey limitations:**

Approximately 950 students in the 1995 survey and approximately 850 students in the 1996 survey could not be reached neither through linking of databases or via telephone.

## Post Secondary Graduates Follow-up Survey of 1998 Graduates

#### Department or agency responsible for the survey:

Newfoundland Department of Education, Division of Corporate Planning and Research

#### Survey objectives and purposes:

To provide high quality labour market information in support of career and program planning.

#### Main topics covered/variables listing/information:

This survey collects detailed program level information on graduate employment, earnings, outmigration, student loans and length of job search, and describes graduates opinions of their investment of time and money in their program.

Collection period: February 1999 to June 1999

Reference period: July 1997 to December 1998

**Type of survey:** Telephone interviews

#### **Target population/coverage:**

Census of all post secondary graduates in Newfoundland from the University, public colleges and privates colleges.

#### Sample size:

7,927 graduates; 4,853 respondents

**Data collection method:** Telephone survey

#### Methodology:

- Telephone survey using DASH which is a Computer Assisted Telephone Interviews (CATI) tool;
- Attempted census;
- Up to fifteen follow up calls; and
- Spoke to graduates directly

#### **Historical information:**

This survey has been done for the graduates of 1994 to 1998, therefore a longitudinal study is possible. There were a lot of similarities from year to year.

In 1997, the MPHEC (Maritime Provinces of Higher Education Commission) did a similar study of 1996 university graduates.

#### **Survey limitations:**

Student interviewers; addresses and phone numbers of graduates were a year old; and response rates by program were generally always acceptable except for the PhD programs in 1996.

## Nova Scotia Community College Graduates Follow-up Survey

#### Department or agency responsible for the survey:

Nova Scotia Department of Education and Culture

#### Survey objectives and purposes:

To gather information on the labour market experiences of graduates approximately one year after completing their training.

#### Main topics covered/variables listing/information:

- For those employed: Graduates supply occupational information, including the relationship to training received.
- For those unemployed: Graduates supply information on the nature of their job search and reasons for their unemployment.
- Program evaluation is another main topic.

## **Family Mosaic**

#### Department or agency responsible for the survey:

Nova Scotia Department of Community Services and Human Resources Development Canada

#### **Survey objectives and purposes:**

To determine the impacts of family structure on outcomes for young people.

#### Main topics covered/variables listing/information:

Currently undertaking the fifth data collection for this longitudinal research project that was initiated in 1978. The primary strength of the Family Mosaic project is that it provides a wealth of information on both children and their families that can now be linked to outcomes in adult life. Data collection have been conducted from the time of birth, and will, with the next data collection, continue into adulthood. The early process of this project included information on issues such as family income, parental education, social support networks, childcare arrangements, and children's intellectual and social development at age 10. The final report will examine how family structure and related conditions experienced during childhood have affected the outcomes for young adults in areas such as physical health, quality of life, education, employment and social/civic responsibility.

Quasi-experimental design comparing random samples of children half of who were born to oneparent families and half of who were born into two-parent families.

## **Survey of New Brunswick Community College Non-Completers**

#### Department or agency responsible for the survey:

Department of Education (1998 onwards), previously the former Department of Advanced Education and Labour.

#### Survey objectives and purposes:

The purpose of the project is to interview the students who did not complete their program at the New Brunswick Community College (NBCC). The intent was to conduct the survey on an annual basis, beginning in 1997, however after two reports the project was cancelled, due to disappointing results and the difficulty in managing the project.

Each year the Department conducts surveys of New Brunswick Community College graduates (the *Survey of [previous year] NBCC Graduates* and the *Three-Year Graduate Follow-Up Survey*). The graduate surveys collect information from those who successfully completed (graduated from) their training program during the previous calendar year and three years previously. The Survey of Non-Completers contacted those who were enrolled in a program that was scheduled to terminate during the previous calendar year who did not successfully complete their chosen program.

The results of the Survey of Non-Completers were to be used to develop comparative profiles of non-completers and graduates. Some analysis and comparison between types of programs (regular and non-regular) and across categories (status) of non-completers was included. The survey required approximately fifteen to twenty minutes per interview.

#### Main topics covered/variables listing/information:

Non-completers were asked the same questions as the graduates plus approximately twenty additional questions. During the interview graduates are asked about their labour force activities since completing their training program. They are also asked to evaluate various aspects of their training experience at the New Brunswick Community College. The survey required approximately fifteen minutes to complete an interview with a respondent. The Department required a minimum 60% response rate for this survey.

#### The indicators were:

- Comparative demographic profile
- Motivations for leaving
- Prevention of program exits
- Likelihood of return to NBCC
- Changes suggested by respondents regarding:
  - ♦ College admission services
  - ♦ Students services / financial aid
  - ♦ Quality of instruction
  - ♦ Program content
  - ♦ Counselling and student support services
  - ♦ Library services
  - ♦ Other changes

- Post-exit labour force activity, specifically:
  - ♦ Overall employment
  - ♦ Overall labour market profile
  - ♦ Labour force status in reference week
  - ♦ Reference week employment
  - ♦ Unemployment in the reference week
- Post-exit educational experience
- Comparative information about non-completers and graduates

Collection period: Two-week period, last two weeks of June 1997 and 1998.

**Reference period:** First week of June (the week prior to the collection period).

**Type of survey:** Individuals (New Brunswick Community College non-completers)

#### **Target population/coverage:**

The Survey of Non-Completers contacted those who were enrolled in a program scheduled to terminate during the previous calendar year (including those who did not successfully complete the first or second year of a two-year program and those who did not successfully complete the first, second or third year of a three-year program). The final status of these students, in the Department's Student Information System, was "unsuccessful," "withdrawal," "cancellation," or "incomplete." Between 25 and 30% of the students who enrol in the first year of NBCC programs do not successfully complete the final year of the program (target population size: approximately 1000).

Approximately 55% of the survey population is under the age of 24.

#### Sample size:

There is no sample. The surveying consultant attempted to contact the entire survey population. The Department required a response rate of 60%.

**Data collection method:** Telephone survey

#### **Methodology:**

The surveying company used Computer Assisted Telephone Interviews (CATI) to record responses. The data was compiled in SPSS format. The report and text are in WordPerfect format.

#### **Historical information:**

The survey is conducted annually. The *Three-Year NBCC Graduate Follow-up Survey* and the *Survey of [previous year] NBCC Graduates* (also conducted annually) served as companion surveys, providing valuable comparative analysis. NBCC graduates are surveyed one year and three years following completion of their training. Non-completers were surveyed one year following the scheduled completion of their training. The NBCC has been conducting graduate follow-up surveys since 1983.

#### **Survey limitations:**

The survey was discontinued in 1999 due to various reasons. Primarily, results remained the same year after year, thus there was little justification to continue. The project was also very difficult to manage. Non-completers were not easily identified in the Student Information System and there were many inconsistencies. The survey had negative connotations with respondents, thus compromising the survey's integrity. Response rates were too low—the requirement of 60% was never met—to justify the survey.

## Women Cyberspace Career Fair Survey

#### Department or agency responsible for the survey:

Department of Advanced Education and Labour, New Brunswick Community Colleges

#### **Survey objectives and purposes:**

Measure the impact of a one-day Information Technology (IT) career fair targeted for young women (Grades 10-12). Did the career fair have an impact on their career choices?

#### Main topics covered/variables listing/information:

- Educational objectives field of study, institution type, have they ever considered IT fields;
- Perception of IT careers;
- Current access to computers; and
- Parent's careers/jobs.

#### **Collection period:**

First survey administered May 1997 (few minutes prior to the event) Second survey administered September 1997 (follow-up survey)

Reference period: N/A

Type of survey: —

#### **Target population/coverage:**

Females attending Grades ten through 12. Most were in Grade 11 (70%), second highest Grade 12 (29%) and, the rest were in Grade 10 (1%).

**Sample size:** We targeted a Census for both surveys.

#### **Data collection method:**

First survey was delivered to all participants. They had a few minutes to complete before it was returned to organizers.

Second survey was a mail-in survey.

Methodology: —

Historical information: N/A

#### **Survey limitations:**

The second survey caused more problems because it was a mail-in, the response rate was very low (as expected) and the mail-out had to be co-ordinated through the Department of Education as they did not want to release the addresses. It is not completely certain that all the surveys were mailed since it dealt with schools from across the province.

## Survey of New Brunswick Community College Graduates<sup>1</sup>

#### Department or agency responsible for the survey:

Department of Education (1998 onwards), previously the former Department of Advanced Education and Labour

#### Survey objectives and purposes:

The Department of Education (previously under the responsibility of the Department of Advanced Education and Labour) has conducted an annual graduate follow-up survey since 1983. This graduate follow-up information is the Department's key indicator of the labour market success of its graduates, and thus a valuable in-house planning tool. Most graduates will have been in the labour force for approximately one year when asked to participate in this survey. The [Current Year] Survey of [Previous Year] New Brunswick Community College Graduates report provides the results of the survey.

#### Main topics covered/variables listing/information:

During the interview graduates are asked about their labour force activities since completing their training program. They are also asked to evaluate various aspects of their training experience at the New Brunswick Community College. The survey takes approximately fifteen to twenty minutes per interview.

In its present format, the report consists of three sections. The first section contains an introduction, a statement of the methodology and survey highlights. In the second section survey results are presented separately for each program and program location. This section of the report is approximately 240 pages in length. The third section consists of summary tables of selected survey results including graduate assessments and a glossary of terms.

- Comparative labour force participation and employment rates (comparison with results of previous surveys)
- Employment in New Brunswick
- Employment related to training
- Employment comparison between regular and co-op programs

**Collection period:** Two-week period, last two weeks of June, annually.

#### **Reference period:**

Second week of June, annually (the week prior to the collection period). To allow historical comparisons, questions on employment situation during the first week of March (reference period of older surveys) are also asked.

**Type of survey:** Individuals (Graduates of New Brunswick Community College)

#### **Target population/coverage:**

The survey includes graduates of both regular training programs and non-regular training programs that are twenty weeks or longer. The surveying company has advised us that respondents are losing interest and becoming impatient towards the end of the survey.
