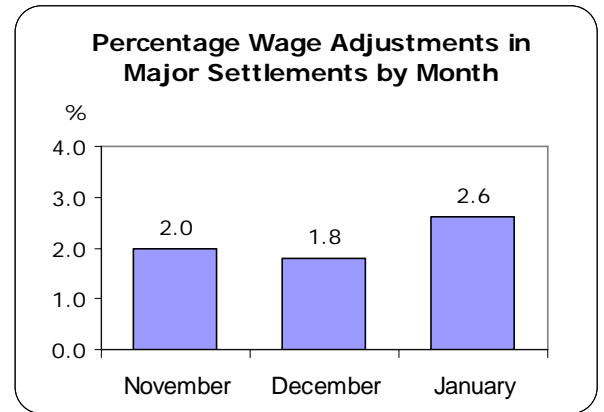

## Wage Settlements Covering 500 or More Employees

### January 2010

Major collective bargaining settlements in January 2010 provided base-rate wage adjustments averaging 2.6% annually over the contract term. The results are based on a review of 13 settlements and cover 16,380 employees.



When the parties to these settlements previously negotiated, contract duration averaged 37.2 months and the resulting wage adjustments averaged 2.9%, compared to the 2.6% in their current round of settlements and average contract duration of 37.7 months.

In January 2010, wage increases were larger in the public sector than in the private sector. Wage adjustments in the public sector averaged 2.8% (10 agreements covering 12,750 employees) and in the private sector 2.1% (3 agreements covering 3,630 employees).

In the public sector, 6 of the 10 settlements were in Atlantic Canada and they accounted for 60.6% of the employee coverage in that sector; wage adjustments in Atlantic Canada averaged 2.3%. Four agreements with Nova Scotia Association of Health Organizations provided 3,530 health-sector employees with wage adjustments averaging 1.9%.

The New Brunswick Association of Nursing Homes Inc. provided 2,800 employees with a wage increase averaging 2.5%. Overall, wage adjustments in the public sector ranged from 1.8% for 600 employees with the Niagara Parks Commission to 4.5% for 3,150 teachers with the Winnipeg School Board.

In the private sector, Maple Leaf Fresh Foods in Manitoba provided 2,220 plant and maintenance employees (accounting for 61.2% of the private sector employee coverage) with a wage adjustment averaging 2.2%.

Wage adjustments in the federal jurisdiction averaged 3.3% (a single agreement, MVT Canadian Bus Inc. in British Columbia).

The January 2010 average annual wage adjustment of 2.6% was higher than the adjustment of 1.9% in the Consumer Price Index (CPI).

In the following tables, COLA is the abbreviation for Cost-of-Living Allowance.
