Under the authority of the *Pest Control Products Act*, Health Canada's Pest Management Regulatory Agency (PMRA) has concluded that the removal of the restriction for use on barley grown for feed only to the product label of Accord Dry Flowable Herbicide, containing technical grade quinclorac, is acceptable. The specific uses approved in Canada are detailed on the label of Accord Dry Flowable Herbicide, *Pest Control Products Act* Registration Number 25118.

The evaluation of this quinclorac application indicated that the end-use product has merit and value and the human health and environmental risks associated with the new uses are acceptable. Details regarding the registration can be found in the corresponding Evaluation Report that is available in the Pesticides and Pest Management section of Health Canada's website, under Public Registry, Pesticide Product Information Database.<sup>1</sup>

Before registering a pesticide for food use in Canada, the PMRA must determine the quantity of residues that are likely to remain in or on the food when the pesticide is used according to label directions and that such residues will not be a concern to human health. This quantity is then legally established as a maximum residue limit (MRL). An MRL applies to the identified raw agricultural food commodity as well as to any processed food product that contains it, except where separate MRLs are specified for the raw agricultural commodity and a processed product made from it.

Consultation on the proposed MRL for quinclorac is being conducted via this document (see Next Steps, the last section of this document).

To comply with Canada's international trade obligations, consultation on the proposed MRL is also being conducted internationally by notifying the World Trade Organization, as coordinated by the Standards Council of Canada.

The proposed MRL for quinclorac in Canada in or on food, to be added to the MRLs already legally established, is as follows.

#### **International Situation and Trade Implications**

MRLs may vary from one country to another for a number of reasons, including differences in pesticide use patterns and the locations of the field crop trials used to generate residue chemistry data. As per Table 2, the proposed MRL for quinclorac in Canada differs from the corresponding tolerance established in the United States (tolerances are listed in the Electronic Code of Federal Regulations, 40 CFR Part 180, by pesticide). Currently, Codex Alimentarius MRLs<sup>2</sup> have not been established for quinclorac on any commodity. A listing of all established Codex MRLs is available on the Codex Alimentarius Pesticide Residues in Food website.

The PMRA will consider all comments received before making a final decision on the proposed MRL for quinclorac and posting a corresponding Established Maximum Residue Limit document in the Pesticides and Pest Management section of Health Canada's website.
