<u>CMHC'S EXTERNAL RESEARCH PROGRAM</u> PROGRAMME DE SUBVENTIONS DE RECHERCHE DE LA SCHL

The objective of the CMHC External Research Program (ERP) is to encourage and enable researchers in the private and non-profit sectors to put forward and carry out relevant, innovative, and high quality housing research projects. Under the Program, financial contributions are made annually to support research investigations into important questions, problems, and issues affecting Canadian housing. CMHC is interested in receiving applications on topics related to existing CMHC housing research.

Applicants to the External Research Program must be Canadian citizens or have permanent resident status in Canada. Independent researchers as well as those employed in Canadian universities, institutions, private consulting firms, the professions and the housing industry may apply for these grants. Full-time students at the graduate or under-graduate level are not eligible to apply. Students may be hired to assist in conducting the research, but under no circumstances may they take over responsibility for the direction of the work or the quality of the final report.

Individuals who are full-time federal, provincial or municipal government employees may apply. However, to be eligible, an applicant must apply as a private consultant, and the proposed research must not be part of, or interfere with his/her regular work. CMHC employees are not eligible to receive grants under this Program.

En vertu de ce programme, de l'aide financière est versée annuellement pour appuyer les travaux de recherche sur des questions et des problèmes d'importance liés à l'habitation au Canada. La SCHL est intéressée à recevoir des demandes pour des projets reliés à la recherche existante de la SCHL sur habitation.

Tout candidat au Programme de subventions de recherche doit être citoyen canadien ou résident permanent du Canada. L'étudiant au baccalauréat, à la maîtrise ou au doctorat qui poursuit des études à temps plein n'est pas admissible au PSR. Il peut devenir adjoint à la recherche mais ne peut, en aucun cas, assumer la direction des travaux ou être responsable de la qualité du rapport final.

Les employés permanents des gouvernements fédéral, ou provinciaux ou des administrations municipales peuvent soumettre des demandes de subvention en vertu du Programme. Toutefois, pour être admissible, un candidat doit soumettre une demande à titre de consultant privé, et son projet ne doit avoir aucun rapport avec ses activités professionnelles ni ne compromettre son travail régulier. Les employés de la SCHL ne sont pas admissibles à des subventions de recherche dans le cadre de ce programme.
