In Geneva, Ms. Tougas is working on the application of international humanitarian law to private military companies.

### WHAT IS IT?

The Department of National Defence is looking for qualified individuals to join the Policy Group at National Defence Headquarters in Ottawa. The Policy Officer Recruitment Programme is designed to recruit and develop talented Policy Officers to meet the unique demands of the defence policy environment.

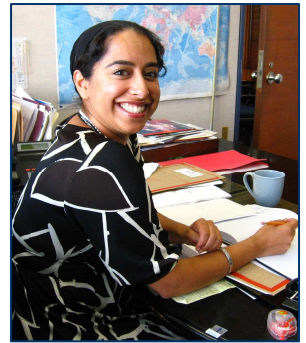
### ARE YOU QUALIFIED?

# The Security and Defence Forum (SDF)

The SDF is a program of the Department of National Defence mandated to develop a domestic competence and national interest in defence issues of current and future relevance to Canadian security.

## Scholarships and Internships

Through the SDF, the Department of National Defence funds a series of awards, both scholarships and internships, to foster interest in and knowledge of security and defence issues among young Canadian scholars.

Each year, the Department awards:

- up to eight MA scholarships valued at \$10,000 each;
- up to five PhD scholarships valued at \$20,000 – \$22,500 each;
- two Post-Doctoral fellowships valued at \$35,000 each;
- Aboriginal scholarship funding up to \$10,000; and,
- up to four internships valued at \$35,000 each.
