Under the authority of the *Pest Control Products Act*, Health Canada's Pest Management Regulatory Agency (PMRA) has granted conditional registration to technical grade metrafenone and the end-use product Vivando SC Fungicide for use on grapes. The specific uses approved in Canada are detailed on the product label of Vivando SC Fungicide, *Pest Control Products Act* Registration Number 29765.

Corresponding MRLs were proposed in the consultation document published on 14 May 2012, Proposed Maximum Residue Limit PMRL2012-12, *Metrafenone*. The PMRA received no comments in response to this consultation.

To comply with Canada's international trade obligations, consultation on the proposed MRLs was also conducted internationally by notifying the World Trade Organization, as coordinated by the Standards Council of Canada. No comments were received as a result of the World Trade Organization consultation impacting the proposed MRLs.

The following MRLs for metrafenone take legal effect in Canada as of the publication date of this document
