Under the authority of the *Pest Control Products Act*, Health Canada's Pest Management Regulatory Agency (PMRA) has granted conditional registration to technical grade fluopicolide and the end-use products Fluopicolide 4 SC Fungicide and Presidio Fungicide for use in Canada on various commodities. The specific uses approved in Canada are detailed on the product labels of Fluopicolide 4 SC Fungicide and Presidio Fungicide, *Pest Control Products Act* Registration Number 30050 and 30051, respectively.

Corresponding MRLs were proposed in the consultation document published on 22 May 2012, Proposed Maximum Residue Limit PMRL2012-16, *Fluopicolide*. The PMRA received no comments in response to this consultation.

To comply with Canada's international trade obligations, consultation on the proposed MRLs was also conducted internationally by notifying the World Trade Organization, as coordinated by the Standards Council of Canada. No comments were received as a result of the World Trade Organization consultation.

The following MRLs take legal effect in Canada as of the publication date of this document and either replace or are in addition to the MRLs currently established for fluopicolide.

<sup>a</sup> The MRL replaces the currently established 16 ppm MRLs for head lettuce and leaf lettuce and adds MRLs for the remaining commodities in the crop group.

<sup>b</sup> A 0.02 ppm MRL is currently established for all commodities in Crop Subgroup 1D, tuberous and corm vegetables, except potatoes. This MRL action establishes the same MRL in or on potatoes, thereby including all tuberous and corm vegetables in Crop Subgroup 1C.
