2011 Census of Population: Language

On October 24, 2012, Statistics Canada released the fourth and last round of data from the 2011 Census of Population, which provide an up-to-date profile of Canada's language diversity.

The findings are available in an online report <u>Linguistic Characteristics of Canadians</u>. It examines the evolution of languages in Canada between 2006 and 2011.

Specifically, the report releases findings on changes in the use of immigrant languages, as well as developments in Canada's linguistic duality, that is, English and French both as mother tongue and language spoken most often at home.

Three companion reports are also available. They analyze Aboriginal languages, immigrant languages and the presence of French in Canada and the provinces and territories.

at the changes over the last 15 years in the composition of stepfamilies and their characteristics in terms of conjugal history.

The socioeconomic characteristics of the parents in stepfamilies are compared with those of lone parents and parents in intact families. The financial difficulties encountered by stepfamilies are also examined. The GSS is one of the few sources of data that can be used to conduct a retrospective study of family-related topics at the national level for this population.

Social participation and the health and wellbeing of Canadian seniors

The article is from Statistics Canada's latest online issue of <u>Health Reports</u>. It examines the relationship between the number of social activities in which seniors "frequently" participate and three measures of health and well-being: self-perceived health, loneliness, and life dissatisfaction. The extent to which social support mediates the effect of social participation on health and well-being is considered. In addition, for the first time in a nationally representative Canadian study, reported barriers to greater social participation are examined. The data for this analysis are from the 2008/2009 Canadian Community Health Survey — Healthy Aging.

<u>Health Reports</u> is a peer-reviewed journal of population health and health services research. It is designed for a broad audience that includes health professionals, researchers, policymakers, and the general public.
