The development and maintenance of the *Aboriginal Canada Portal* is an ongoing partnership between the Government of Canada and six national Aboriginal Organizations: the Assembly of First Nations; the Congress of Aboriginal Peoples; the Council for the Advancement of Native Development Officers; the Inuit Tapirisat of Canada; the Métis National Council; and the Native Women's Association of Canada.
