Annex 2 — Complaints and Enquiries

Among other things, OSFTs External Communications and Media Relations group is responsible for dealing with enquiries or complaints consumers may have with respect to federally-regulated financial institutions and pension plans.

In 1992, the legislation applicable to federally-regulated financial institutions was amended to include a requirement that financial institutions establish and follow specific procedures for handling consumer complaints. These procedures must be readily available to customers and must include information on how to contact OSFI.

When a customer contacts OSFI with a complaint or enquiry, several courses of action may be taken OSFI's Complaints and Enquiries officers will analyze the situation, and when possible, offer suggestions on how to handle the situation. The officers can often respond directly to enquiries which are of a general nature. However, some enquiries or complaints can be very specific in nature or are related to a specific financial institution. In these cases, the officer may direct the customer to a particular individual within the financial institution. Many financial institutions have an internal ombudsman who can provide an impartial appeal process if the customer is dissatisfied with the initial

response to his/her complaint or enquiry.

OSFI's toll-free telephone line, which has been available to the public for the last three years, has resulted in a significant increase in the number of incoming calls. OSFI continues to receive and process a large volume of written correspondence. Furthermore, the amount of correspondence received through OSFI's Internet web site is increasing rapidly.

During 1996-97, OSFI's External Communications and Media Relations group received 3,599 complaints and 9,685 enquiries. The tables on the following page provide additional statistical detail with respect to the complaints and enquiries received.
