- Financial audits verify that the government keeps proper accounts and records and presents its information fairly.
- Special examinations verify that Crown corporations have the necessary systems and practices to safeguard their assets, adequately manage their resources, and operate effectively.

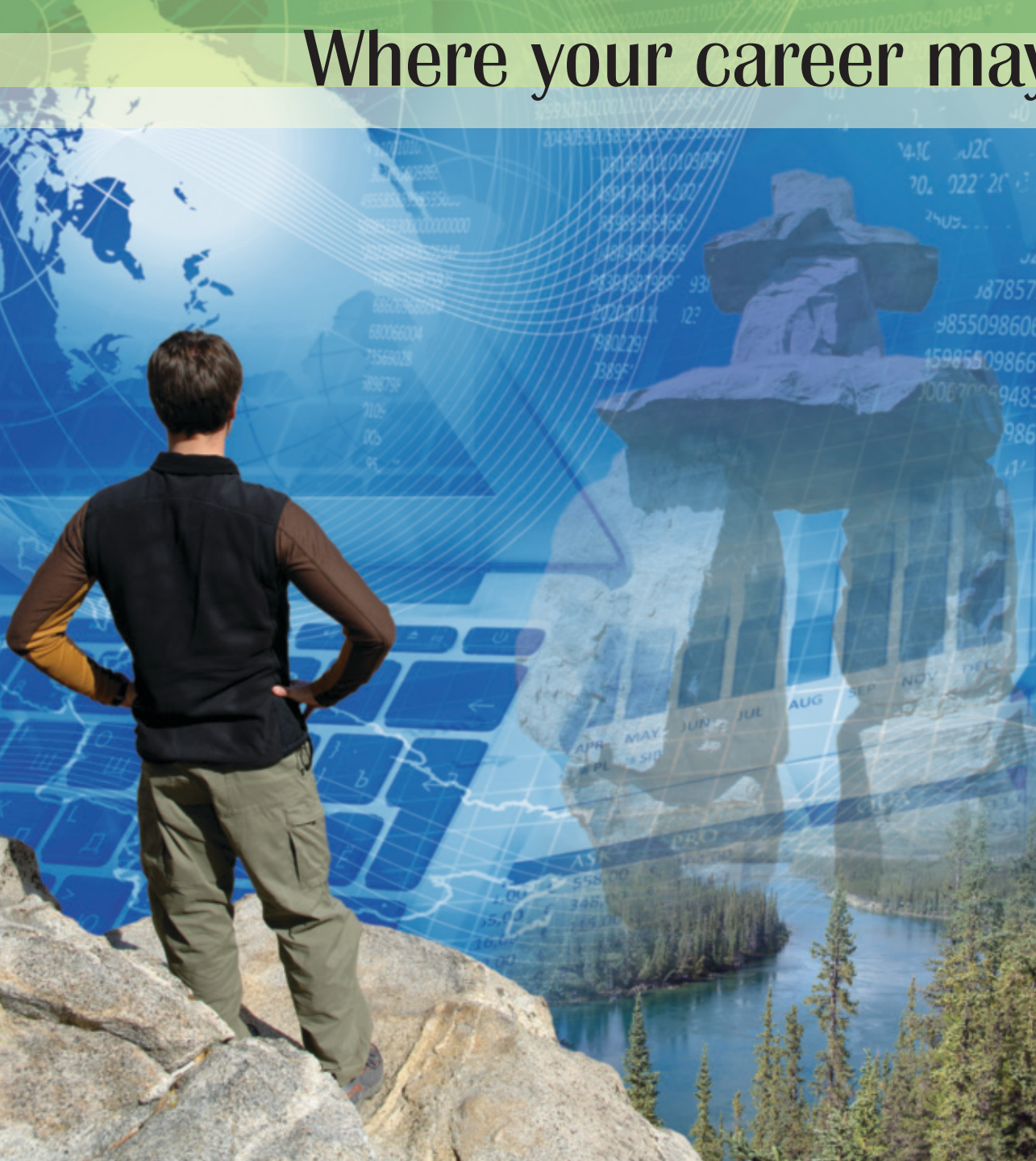
