## Great Lakes — St. Lawrence River Water Levels **Water Level Update and Meeting Information**

As shown in the water level information table provided below, at the beginning of September 2013, the levels of lakes Erie and Ontario were a few centimetres above their 1918-2012 long-term beginning-of-September average water levels. The levels of lakes Superior and St. Clair were a few centimetres below their respective beginning-of-September average levels while the level of Lake Michigan-Huron remains well below average. The levels of

all of the lakes began this September higher than they were at the same time last year.
