this year's recipient. BJC was formed in 2002 to represent Canada in the International Bone and Joint Decade launched by the World Health Organization in 2000 as a global partnership to reduce the impact of musculoskeletal (MKS) health issues. The WHO has since extended the decade to 2020 due to the growing burden. BJC received the award in recognition of its outstanding contribution over the last ten years in engaging stakeholders in the MSK health community, developing and implementing national models of care, and building research capacity. We are pleased to recognize the outstanding work of Bone and Joint Canada with this award. They are an important partner and have contributed greatly in moving research into action and fostering the development of young MSK researchers.

The CIHR-IMHA Knowledge Translation Award honours and supports exemplary knowledge translation efforts and activities of an exceptional individual, team, or organization that has made an outstanding contribution to increasing the application of research findings, improving the health of Canadians, health services and products, or strengthening the health care system in the field of MSK health.

November is Osteoporosis Awareness Month

s a former radiography educator, and Director of Education of the International Society of Radioaraphers and Radiological Technologists (ISRRT), I have always been deeply involved in my professional association locally, nationally, and internationally. Upon my retirement, I wanted to continue my involvement

as a volunteer, but didn't know where to start. As luck would have it, while attending a Bone China Tea, I sat beside a woman representing the British Columbia (BC) Division of Osteoporosis Canada (OC), and the rest is history! I was quickly encouraged to join the BC OC branch and to become a speaker.

> When one realizes that fractures from osteoporosis are more common than heart attack. stroke and breast cancer combined, the need for community education forums for the general public becomes clear.

While I do not have osteoporosis, I was diagnosed with osteopenia or low bone mineral density, which can be a precursor to osteoporosis. As a result, I followed a course of medication that has improved my bone strength. My mother, however, was not so lucky. It wasn't until she suffered vertebral fractures pulling a sheet from the washing machine that she was diagnosed with osteoporosis.

Unfortunately, this type of story is far too common. Through my work with the COPN (Canadian Osteoporosis Patient Network) alonaside many truly committed individuals who devote considerable time to the work of Osteoporosis Canada we hope to reduce the frequency of stories like this.

More recently, I also became an **IMHA** Research Ambassadors (RAs). As a committee, the RAs complete the review for the annual IMHA Research Ambassador Knowledge Translation Award. This award is given to researchers who write outstanding lay abstracts for their grants. Because lay abstracts are readily available to the public, it is very important that they are well written. Through this award, IMHA hopes to encourage researchers to write lay abstracts that provide a comprehensive summary of their research in easy to understand language.

Did you know

The total cost of osteoporosis in Canada was \$2.3 billion in 2010. This is not surprising given that the 30,000 Canadians who experience a hip fracture each year spend an average of 23 days in hospital and rehabilitation centres at an average acute care cost of \$20,000 per patient. Nearly a quarter of these end up in long-term care facilities leading to \$600 million in annual costs with additional costs attributable to the 170,000 other fragility fractures per year of the spine, wrist, shoulder, pelvis and other bones. Knowledge Translation Corner

It Doesn't Have to Hurt: Strategies for Helping Children with Shots and Needles

New knowledge translation video based on pain research funded, in part, by CIHR



o parent likes to take their child for shots and needles. So why is it that, despite numerous proven and accessible interventions to manage pain in children, fewer than five percent of children get any kind of pain relief for common needle procedures?

In this short YouTube video, produced by Dr. Christine Chambers and her team, a young child advises her mother on some simple, evidence-based things that she can do – and shouldn't do – to help make the experience less stressful and painful. The video was inspired by a desire to reach parents directly and empower them to advocate for proper pain management for their children, says Dr. Chambers.

Dr. Christine Chambers, PhD is a clinical psychologist, Canada Research Chair in Pain and Child Health, and Professor in the Departments of Pediatrics and Psychology & Neuroscience at Dalhousie University in Halifax, Nova Scotia, Canada. She is based in the Centre for Pediatric Pain Research at the IWK Health Centre. Dr. Chambers' research examines developmental, psychological, and social influences on children's pain, with a focus on family factors in pediatric pain and pain measurement in children.



Knowledge Translation Corner

This knowledge translation project involves the development and dissemination of a video-based education tool addressing the cause and prevention of falls in seniors. While applicable to a wide range of stakeholders, this interactive tool has been designed specifically for educating nurses, care aides, and physical therapists who work with older adults in LTC. The unique and powerful aspect of the tool is the inclusion of video footage of real-life falls (collected under our primary CIHR operating grant) in a set of "case studies" which focus on current knowledge and best practices

related to issues such as fall risk screening, mobility and balance assessment, exercise, fall-related injuries (especially hip fracture and head trauma), environmental hazards, and hip protectors. This unique approach of using video-cap-

tured falls to improve the education of front-line care providers on the cause and prevention of falls has a strong likelihood of reducing the frequency and severity of falls in the LTC environment.
