

## 2006 Census Housing Series: Issue 20 Métis Households: Housing Conditions and Core Housing Need

### INTRODUCTION

This Research Highlight examines the housing conditions of Métis households (see text box: Definitions of Métis and Aboriginal households) in Canada based on custom data from the 2006 Census.

Housing conditions are assessed using CMHC's measures of acceptable housing and core housing need (see text box: Acceptable Housing and Core Housing Need). Household

characteristics and housing conditions of Métis at the national and provincial or territorial levels for owners and renters are examined.

#### Definitions of Métis and Aboriginal households

- A **Métis household** is any Aboriginal household in which at least one member reported being a Métis.
- An **Aboriginal family household** is any household in which at least one spouse, common-law partner, or lone parent self-identified as Aboriginal, or at least 50% of household members self-identified as Aboriginal. If any member of the family household identified as Indian (Status or Non-Status), Métis, or Inuit, then the household is classified accordingly. An **Aboriginal non-family household** is any household in which at least 50% of household members self-identified as Aboriginal. If any member of the non-family household identified as Indian (Status or Non-Status), Métis, or Inuit, then the household is classified accordingly. There are cases where two or more identity groups are represented in the same household. For example, a household with one Métis and one Inuit spouse will be counted as both a Métis and as an Inuit household. This approach enables each of the Aboriginal identity groups to be fully counted, but it also means that identity subtotals should not be summed as they will add to more than the total of all Aboriginal households.

#### Acceptable Housing and Core Housing Need

The term acceptable housing refers to housing that is adequate in condition, suitable in size, and affordable.

- **Adequate** housing does not require any major repairs, according to residents.
- **Suitable** housing has enough bedrooms for the size and make-up of resident households, according to National Occupancy Standard (NOS) requirements. Enough bedrooms based on NOS requirements means one bedroom for each cohabiting adult couple; unattached household member 18 years of age and over; same-sex pair of children under age 18; and additional boy or girl in the family, unless there are two opposite sex children under 5 years of age, in which case they are expected to share a bedroom. A household of one individual can occupy a bachelor unit (that is, a unit with no bedroom).
- **Affordable** housing costs less than 30% of before-tax household income. For renters, shelter costs include rent and any payments for electricity, fuel, water and other municipal services. For owners, shelter costs include mortgage payments (principal and interest), property taxes, and any condominium fees, along with payments for electricity, fuel, water and other municipal services.

A household is in **core housing** need if its housing does not meet one or more of the adequacy, suitability or affordability standards and it would have to spend 30% or more of its before-tax income to pay the median rent of alternative local market housing that meets all three standards.

The universe of households<sup>1</sup> tested for core housing need includes only private, non-farm, non-band, non-reserve households with incomes greater than zero and shelter cost-to-income ratios (STIRs) less than 100%. Shelter costs for farm households are not separable from costs related to other farm structures. Shelter costs are not collected for households whose housing costs are paid through band housing arrangements (both on- and off-reserve). Additionally, STIRs for households with income less than or equal to zero, or STIRs that are equal to or greater than 100% are considered uninterpretable by CMHC for the purpose of measuring affordability.

The 2006 Census identified 12.4 million households in Canada, of which 11.8 million were private, non-farm, non-band households reporting positive incomes and with shelter cost-to-income ratios (STIRs) less than 100%. Among the 11.8 million such households, 401,145 were Aboriginal households including about 156,000 Status Indian, 78,000 Non-status Indian, 205,000 Métis, and 16,000 Inuit households. This Research Highlight examines the housing conditions and household characteristics of these Métis households.<sup>2</sup>

## Métis households are growing at a faster rate than non-Aboriginal households

The number of Métis households increased about 150% from 81,820 in 1996 to 204,845 in 2006 (see table 1<sup>3</sup>). This was a faster rate of growth than for non-Aboriginal households which grew by 16% over this period. While growth due to natural increase is a key factor, a portion of Métis household growth may be attributable to changes in self-reporting of Métis identity from one census to another.<sup>4</sup> Changes in self reporting of identity are known as “ethnic mobility.” The increased awareness of changes to Métis rights could be a reason for high ethnic mobility among the Métis. For example, the Supreme Court of Canada’s 2003 decision in *R. v. Powley* provided greater rights for the Métis under section 35 of the Constitution Act, 1982.<sup>5</sup> Métis households accounted for 1.8% of all Canadian households in 2006.

The ethnic mobility discussed above may be a factor in the changes in household housing conditions reported below.

Between 2001 and 2006, Métis household growth rates were positive for all provinces and territories (see table 2). Among provinces and territories, Nova Scotia recorded the strongest percentage growth in the number of Métis households at 205%. Ontario and Alberta accounted for the highest percentage share of the increase between 2001 and 2006, at 25% and 19%, respectively.

In 2006, the highest percentages of Métis households lived in Ontario (21%), Alberta (21%), Manitoba (18%), and British Columbia (16%).

### Most Métis households live in urban areas

The great majority (68%) of Métis households lived in urban areas consisting of census metropolitan areas (CMAs) and census agglomerations (CAs)<sup>6</sup> (see figure 1). About 97,230 or 48% of Métis households were located in

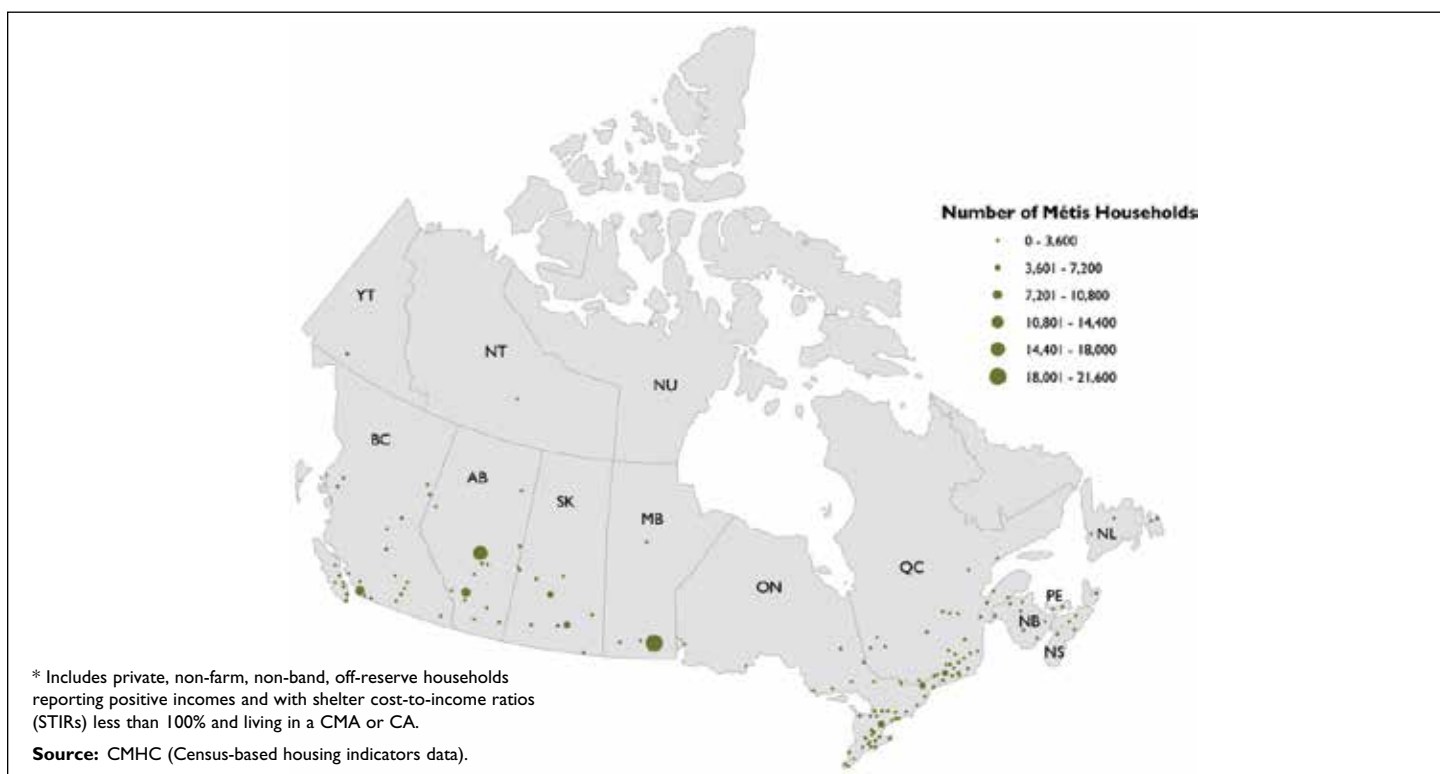
Canada's 33 CMAs alone. Among CMAs, Winnipeg had the highest number of Métis households with 21,260, followed by Edmonton (14,455), Vancouver (8,680), Calgary (8,420), Saskatoon (5,055) and Ottawa-Gatineau (4,900).

The proportions of urban households which were Métis households varied across CMAs and CAs (see figure 2). Prince Albert, a CA in Saskatchewan, had the highest concentration of Métis households at about 21%, and Winnipeg had the largest concentration of any CMA, at about 8%.

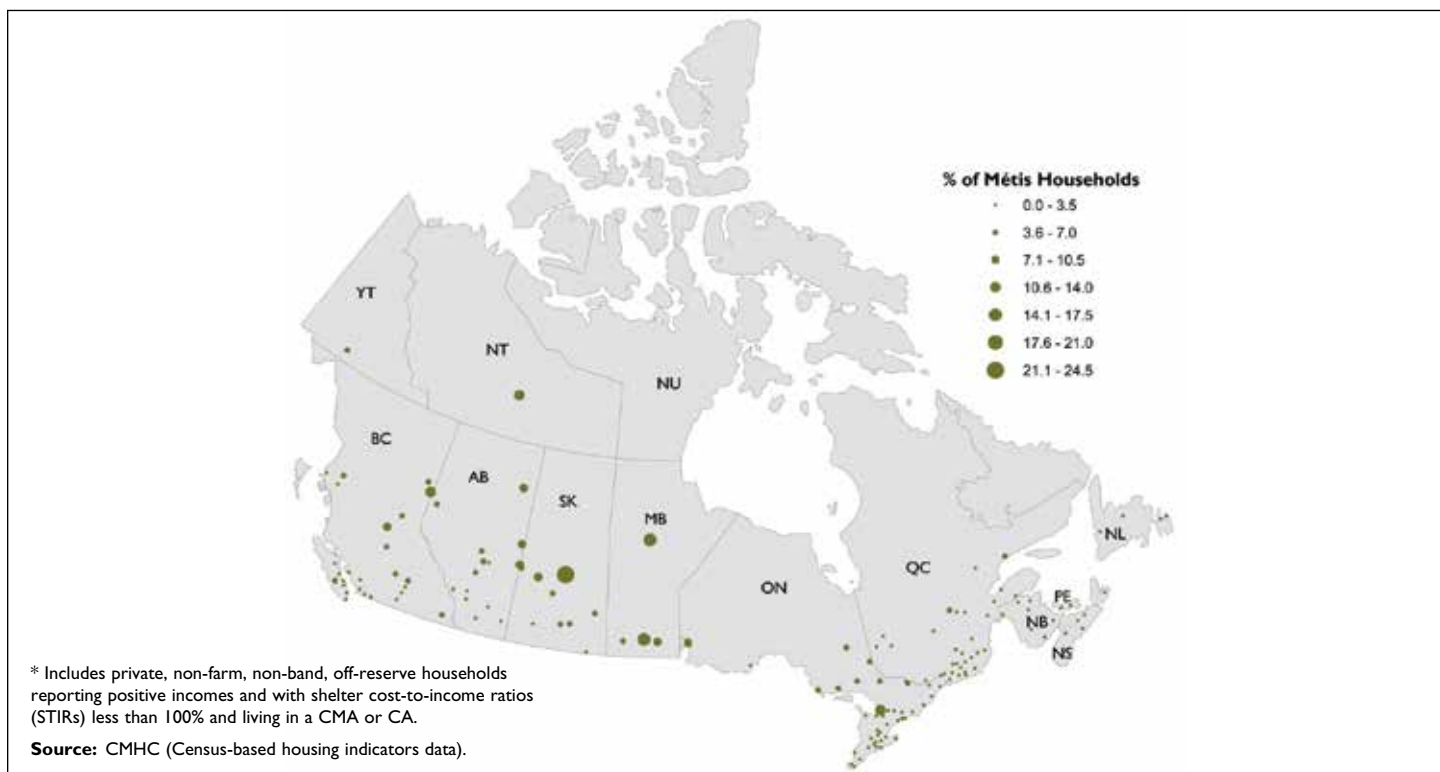

Urban Métis households generally were relatively young. In 2006, among households living in urban areas (CMAs and CAs), a higher proportion (29%) of Métis urban households had a household maintainer<sup>7</sup> aged 15-34 years than did non-Aboriginal urban households (15%).

### Métis tend to live in family households

In 2006, a higher proportion of Métis households lived in family households (80%) than did non-Aboriginal households (70%) (see table 3). About 15% were single-parent households, compared to 10% for non-Aboriginal households. The great majority (81%) of Métis single-parent households were female-led households.

### Homeownership rate among Métis households are increasing, but are lower than for non-Aboriginal households

In 2006, 62% of Métis households owned a home, up from 58% in 2001, and compared to 70% of non-Aboriginal households. In 2006, 19% (or 38,865) of Métis households owned their home outright (without a mortgage), compared to 30% of non-Aboriginal households.

Métis households in Newfoundland and Labrador have the highest rates of homeownership, at 76%; those in Quebec, British Columbia and Northwest Territories the lowest, at about 60% each (see table 4).

A non-family household consists either of one person living alone or of two or more people who share a private dwelling but who do not constitute a family.

## Housing conditions of Métis households continued to improve

In 2006, 64% of Métis households lived in dwellings that met all three housing standards (that is, adequacy, suitability, and affordability), up from 61% in 2001 (see figure 3). Affordability was a problem for 21% of Métis households, crowded housing conditions for 8%, and inadequacy for 13%.<sup>9</sup>

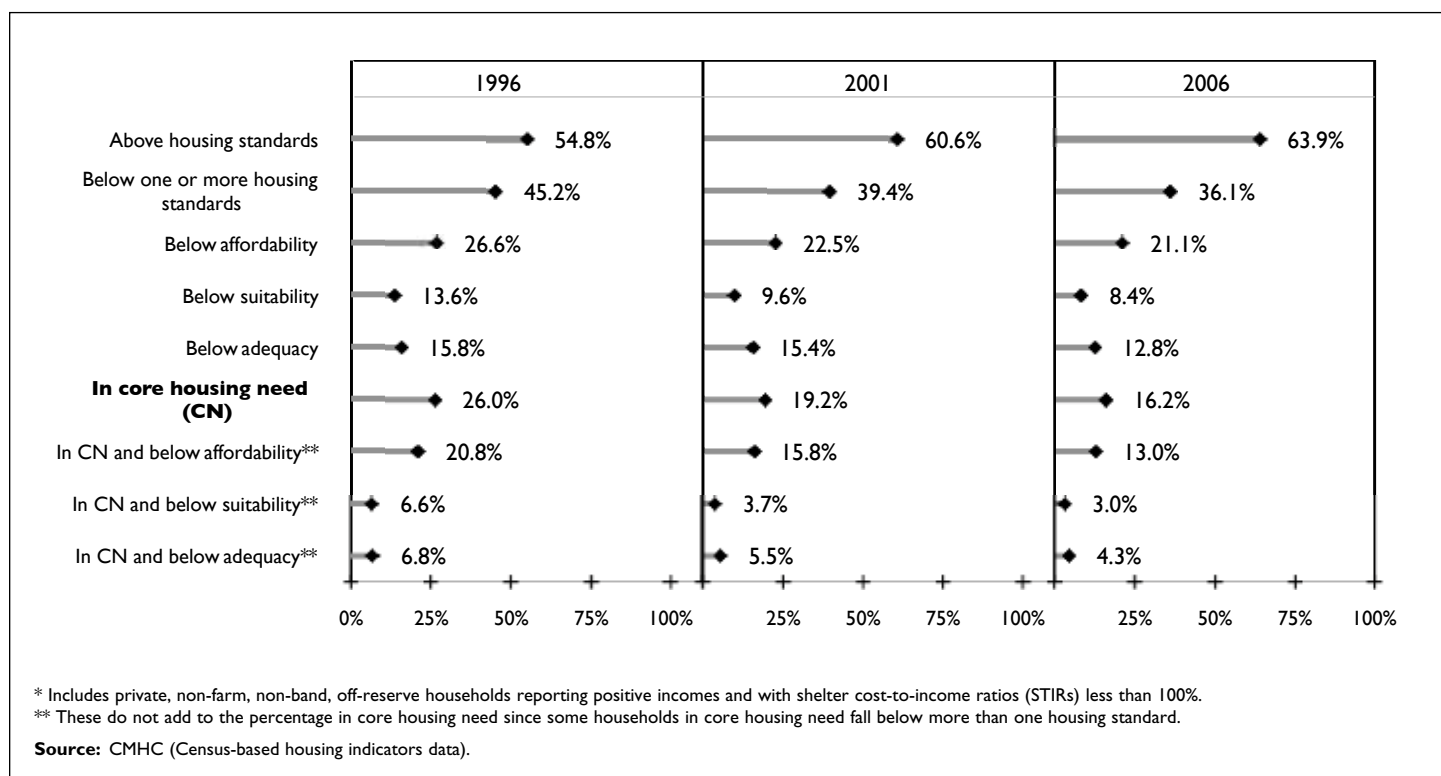
Although 36% of Métis households lived below one or more of the housing standards in 2006, the majority of these households had the income capacity to obtain acceptable housing. When these latter households are combined with those living above standards (64%), about 84% of Métis households either lived in, or had sufficient income to access, acceptable housing in 2006, compared to 81% in 2001, and to 88% for non-Aboriginal households in 2006.

Métis households experienced a decrease in the incidence of core housing need of 9.8 percentage points over the ten-year period, from 26.0% in 1996 to 16.2% in 2006 (see figure 4). Between 2001 and 2006, the incidence of core

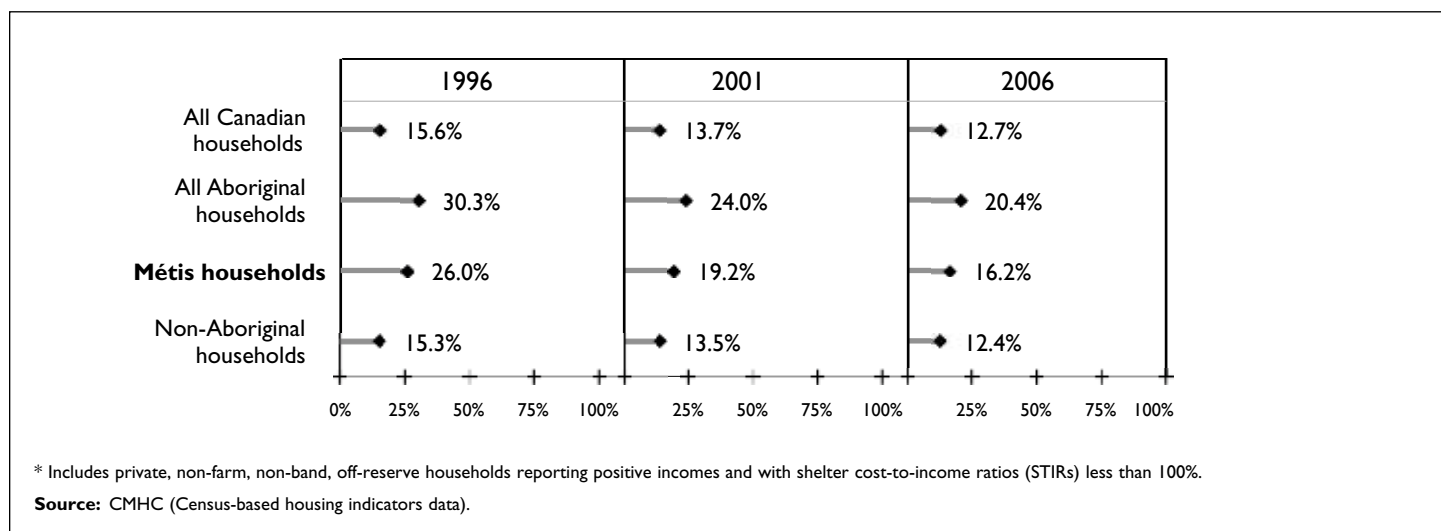
housing need for Métis households declined by 3.0 percentage points from 19.2% to 16.2%, much more than the 1.1 percentage point decline for non-Aboriginal households. However, the incidence of core housing need for Métis households in 2006 at 16.2% remained higher than that of non-Aboriginal households (at 12.4%), and the absolute number of Métis households in core housing need increased by about 8,480 between 2001 and 2006.

Between 2001 and 2006, only Yukon experienced an increase in the incidence of core housing need of Métis households (see table 5). The largest decrease in the incidence of core housing need of Métis households occurred in New Brunswick and British Columbia (6.3 and 5.8 percentage points, respectively). In 2006, the incidence of core housing need ranged from 11.4% in Prince Edward Island to 21.5% in Yukon.

Both Métis renters and owners are more likely to be in core housing need than their non-Aboriginal counterparts. In 2006, about 30% of Métis renter households and 8% of owner households were in core housing need, compared to about 27% of non-Aboriginal renter households and 6% of non-Aboriginal owner households (see table 6). Renter households have greater difficulty finding acceptable housing than homeowners mostly because of lower household income (see table 7).

In all provinces and territories, more Métis renter households were in core housing need than owner households. Yukon had the highest incidence of renter households in core housing need (45%); New Brunswick recorded the lowest incidence at 23% (see appendix table 1 for detailed geographic data by tenure). Between 2001 and 2006, the incidence of core housing need increased for Métis owner households in Yukon, Saskatchewan, Manitoba and Alberta.

### Affordability, suitability, and adequacy of housing occupied by Métis households in core housing need

For Métis households, as with non-Aboriginal households, not meeting the affordability standard is a far more common reason for being in core housing need than housing that is unsuitable (that is, crowded) or inadequate (that is, in need of major repairs). About 13% of Métis households were in core housing need and failed to meet the affordability standard (either alone or in combination with another standard), while about 3% of Métis households were in core housing need because of not meeting only the suitability standard and/or the adequacy standard (see appendix table 2 for data by tenure).

Over the ten year period from 1996 to 2006, the proportion of Métis households falling into core housing need due to affordability problems declined from 20.8% to 13.0% (see figure 3).

In 2006, the average shelter cost-to-income ratio (STIR) for Métis households in core housing need was 44.7% compared to 49.0% for non-Aboriginal households in core housing need (see table 7).

While affordability is affected by both shelter costs and income, lower average household income is the reason for affordability problems among Métis households in core housing need; they reported \$20,172 in before-tax income, only 28% of the \$72,879 reported by Métis households not in core housing need (see appendix table 3 for detailed geographic data by tenure). About 60% of the Métis households in core housing need relied on government transfer payments for income.

Between 2001 and 2006, the average household income of Métis households in core housing need increased by 18% while the average shelter costs rose by 15%.

## Lone-parent Métis households had a relatively high incidence of core housing need

In 2006, 38.5% of lone-parent Métis households were in core housing need (see figure 5). The incidence of core housing need for lone-parent Métis households varied from 51.1% in Nova Scotia to 24.4% in New Brunswick.

For Métis households, the highest incidence of core housing need among all household types was recorded for renter lone-parent family households, at 49.5% (see appendix table 4 for detailed geographic data by tenure).

## Housing conditions of Métis households in census metropolitan areas (CMAs)

In 2006, the incidence of core housing need was 17.0% for Métis households in CMAs, down from 19.8% in 2001 (see table 8). The percentage of Métis households living in core housing need varied from 31.3% in Trois-Rivières to 8.9% in Saguenay (see appendix table 5 for detailed geographic data by tenure).

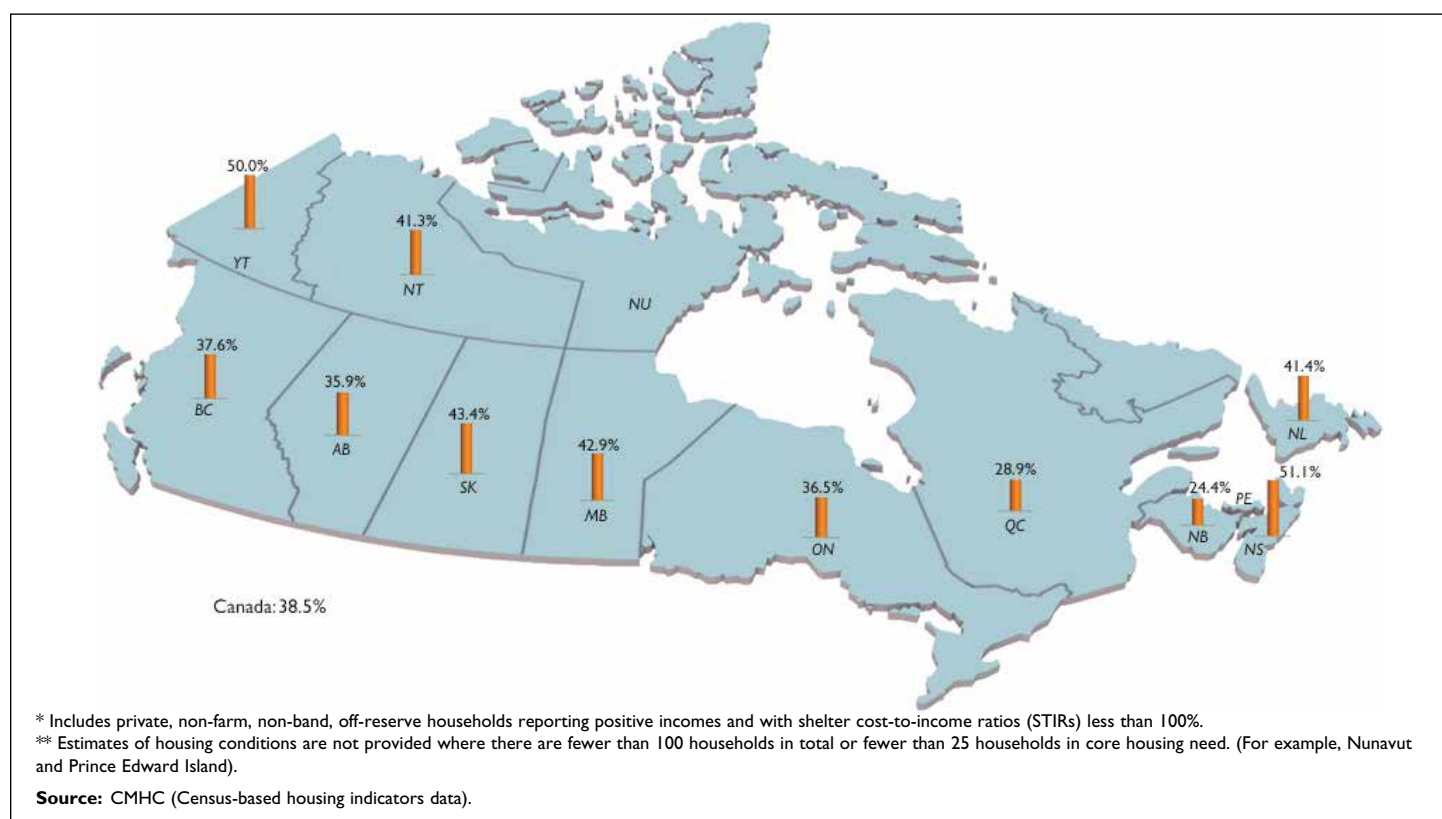
## Summary

The number of Métis households increased by about 60% between 2001 and 2006; a portion of this growth may be attributable to an increased tendency to self-identify as Métis. In 2006, about 16.2% of Métis households were in core housing need, compared to 12.4% of non-Aboriginal households. The incidence of core housing need among Métis households declined by 3.0 percentage points between 2001 and 2006, and by 9.8 percentage points between 1996 and 2006. Some of the increase in the number of Métis households and the decrease in their incidence of core housing need may be attributable to ethnic mobility.

The incidence of core housing need for Métis households was highest in Yukon, at about 21.5%.

For Métis households, as for all Canadian households, unaffordable housing was the most common reason for falling into core housing need.

In general, Métis households had lower average household incomes and homeownership rates than non-Aboriginal households. About 62% of Métis households owned their homes in 2006.
