Under the authority of the *Pest Control Products Act*, Health Canada's Pest Management Regulatory Agency (PMRA) has concluded that the addition of new uses on field corn and popcorn grain to the product label of Fortenza and Fortenza Red, containing technical grade cyantraniliprole, is acceptable. The specific uses approved in Canada are detailed on the label of Fortenza and Fortenza Red *Pest Control Products Act* Registration Numbers 30899 and 30898 respectively.

The evaluation of this cyantraniliprole application indicated that the end-use product has merit and value and the human health and environmental risks associated with the new uses are acceptable.

Before registering a pesticide for food use in Canada, the PMRA must determine the quantity of residues that are likely to remain in or on the food when the pesticide is used according to label directions and that such residues will not be a concern to human health. This quantity is then legally established as a maximum residue limit (MRL). An MRL applies to the identified raw agricultural food commodity as well as to any processed food product that contains it, except where separate MRLs are specified for the raw agricultural commodity and a processed product made from it.

Consultation on the proposed MRLs for cyantraniliprole is being conducted via this document (see Next Steps, the last section of this document). A summary of the field trial data used to support the proposed MRLs can be found in Appendix I.

To comply with Canada's international trade obligations, consultation on the proposed MRLs is also being conducted internationally by notifying the World Trade Organization, as coordinated by the Standards Council of Canada.

The proposed MRLs, to be added to the MRLs already established for cyantraniliprole, are as follows.

MRLs established in Canada may be found using the Maximum Residue Limit Database on the Maximum Residue Limits for Pesticides webpage. The database allows users to search for established MRLs, regulated under the *Pest Control Products Act*, both for pesticides or for food commodities.

International Situation and Trade Implications

MRLs may vary from one country to another for a number of reasons, including differences in pesticide use patterns and the locations of the field crop trials used to generate residue chemistry data.

Table 2 compares the MRLs proposed for cyantraniliprole in Canada with corresponding American tolerances and Codex MRLs.¹ American tolerances are listed in the Electronic Code of Federal Regulations, 40 CFR Part 180, by pesticide. A listing of established Codex MRLs is available on the Codex Alimentarius Pesticide Residues in Food website, by pesticide or commodity.

Next Steps

The PMRA invites the public to submit written comments on the proposed MRLs for cyantraniliprole up to 75 days from the date of publication of this document. Please forward your comments to Publications (see the contact information on the cover page of this document). The PMRA will consider all comments received before making a final decision on the proposed MRLs. Comments received will be addressed in a separate document linked to this PMRL. The established MRLs will be legally in effect as of the date that they are entered into the Maximum Residue Limit Database.

Appendix I

Summary of Field Trial Data Used to Support the Proposed MRLs

Residue data from field trials conducted in Canada and the United States were submitted to support the domestic use of Fortenza and Fortenza Red on field corn and popcorn grain. Cyantraniliprole was applied to field corn and popcorn at exaggerated rates, and harvested according to label directions. In addition, a processing study in treated field corn was reviewed to determine the potential for concentration of residues of cyantraniliprole into processed commodities.

Maximum Residue Limit(s)

The recommendation for maximum residue limits (MRLs) for cyantraniliprole was based upon the submitted field trial data, and the guidance provided in the OECD MRL Calculator. Table A1 summarizes the residue data used to calculate the proposed MRL(s) for field corn and popcorn grain.

Following the review of all available data, MRLs as proposed in Table 1 are recommended to cover residues of cyantraniliprole. Residues of cyantraniliprole in these crops at the proposed MRLs will not pose an unacceptable risk to any segment of the population, including infants, children, adults and seniors.
