Canada's exports declined 2.8% due to lower price and volumes, while imports remained flat resulting in a widening of the trade deficit in January to \$2.5 billion. January exports remained 3.4% ahead of last year's pace for January.

Energy exports remained the main drag for the month due to the lower price profile. However, January exports expanded for 6 of the 11 broad product categories and, excluding energy, were up by 0.2%. Among the sectors that experienced export growth, agriculture and fishing product exports increased 4.5% due to large stocks from the recent bumper crop, automotive product exports were up 3.1% reflecting solid US demand, and forestry product exports grew 2.6% as the housing market south of the border gears up for a strong year.

Exports to the United States declined 3.1% while exports to the UK and Germany grew strongly reflecting their more robust economic recoveries compared to other European countries. Alberta exports remained the weakest due mainly to the continued challenging pricing conditions in the energy sector.


