



POPULATION ESTIMATES BY MARITAL STATUS, AGE AND SEX
FOR CANADA AND PROVINCES, 1959
ESTIMATIONS DE LA POPULATION SUIVANT L'ÉTAT MATRIMONIAL,
L'ÂGE ET LE SEXE, CANADA ET PROVINCES, 1959

This report provides estimates of the population by marital status, age and sex, for Canada and the provinces for 1957, 1958 and 1959, with comparative data for the 1956 Census.

The estimated total population of Canada, excluding Yukon and Northwest Territories, on June 1, 1959 was 17,408,000 of whom 11,600,000 or 66.6 p.c. were 15 years of age and over. The estimated total of males 15 years of age and over was 5,858,500 of whom 1,795,700 or 30.7 p.c. were single, 3,850,100 or 65.7 p.c. were married, and 212,700 or 3.6 p.c. were widowed or divorced. The estimated total of females, 15 years of age and over, was 5,741,500 of whom 1,331,900 or 23.2 p.c. were single, 3,816,100 or 66.5 p.c. were married and 593,500 or 10.3 p.c. were widowed or divorced.

Statement of Procedure

Using the 1956 Census figures on marital status by age and sex as a base, vital statistics on births by sex, marriages and deaths by marital status, age and sex, and dissolutions of marriages as well as immigration statistics by marital status, age and sex, for the period June 1, 1956 to June 1, 1959, were applied to the Census figures to obtain estimates of the population by marital status, age and sex, for 1959. Allowance has also been made for the marital status, age and sex composition of the estimated number of emigrants and inter-provincial migrants over this period. In estimating ages of husbands or wives whose spouses had died over the period the difference in ages of married couples as shown at the 1951 Census was used as the basis of assignment. Finally, the age totals in Table 1 were adjusted to correspond with the official population estimates by age and sex for 1959 published in the 1959 Supplement to D.B.S. Reference Paper No. 40.

Le présent rapport contient les estimations de la population du Canada et des provinces suivant l'état matrimonial, l'âge et le sexe pour 1957, 1958 et 1959. Il contient aussi des données comparatives tirées du recensement de 1956.

La population totale du Canada, sans le Yukon ni les Territoires du Nord-Ouest, le 1er juin 1959, était de 17,408,000 habitants dont 11,600,000 ou 66.6 p. 100 étaient âgés de 15 ans et plus. Le total des hommes âgés de 15 ans et plus était de 5,858,500 dont 1,795,700 ou 30.7 p. 100 étaient célibataires, 3,850,100 ou 65.7 p. 100 mariés, et 212,700 ou 3.6 p. 100 veufs ou divorcés. Le total des femmes âgées de 15 ans et plus était de 5,741,500 dont 1,331,900 ou 23.2 p. 100 étaient célibataires, 3,816,100 ou 66.5 p. 100 mariées, et 593,500 ou 10.3 p. 100 veuves ou divorcées.

Méthode d'estimation

En partant des chiffres du recensement de 1956 sur l'état matrimonial suivant l'âge et le sexe auxquels on a appliqué les données de l'état civil sur les naissances suivant le sexe, sur les mariages et les décès selon l'état matrimonial, l'âge et le sexe, et sur les dissolutions de mariage, de même que les statistiques de l'immigration selon l'état matrimonial, l'âge et le sexe pour la période du 1er juin 1956 au 1er juin 1959, on a obtenu une estimation de la population selon l'état matrimonial, l'âge et le sexe pour 1959. On a tenu compte de la répartition selon l'état matrimonial, l'âge et le sexe des émigrants et des migrants interprovinciaux au cours de la période. Pour évaluer l'âge des hommes ou des femmes dont le conjoint est mort au cours de la période, on a utilisé comme base la différence d'âge des couples mariés d'après le recensement de 1951. Finalement, les totaux quant à l'âge (tableau 1) ont été rectifiés pour qu'ils correspondent avec les évaluations officielles de la population selon l'âge et le sexe pour 1959 publiées dans le supplément de 1959 du Document de référence du B.F.S. n° 40.
