In 1996, the Canadian Institute for Health Information (CIHI) formed the Partnership for Health Information Standards initiative to respond to the need for standards in health information systems. The Partnership provides the forum for the standards community to learn about, influence and build consensus on pan-Canadian standards for health information. 




#### Who are our Members



#### Total Projected Revenues: \$139,890



#### Total Projected Expenses: \$428,545

The total projected cost of running the Partnership in 2002–2003 was estimated at \$428,545. Total revenues of \$139,890 offset some of this cost. Conference Registration accounted for the greatest proportion of the total revenues, with significant contributions from Membership and Sponsorship activities.

### Partnership Peer Recognition Award

This year the Partnership established the Peer Recognition Award to acknowledge outstanding achievement in the advancement of health information standards in Canada. An open nominations process was held within the membership in the Spring.

Please join the Partnership in congratulating the winner of the first annual Partnership Peer Recognition Award, *Ms. Jane Curry*. Ms. Curry is a senior consultant with over 15 years of experience in the health care industry. She is a member of the ISO/TC215 Canadian Advisory Group for the Information Modeling and Messaging Working Groups; chair of the HL7 Canada Design Technical Committee; member of the HL7 Canada Executive Committee; international member on the HL7 Architecture Review Board; modeling liaison for the HL7 International Affiliates Committee to the HL7 Modeling and Methodology Technical Committee; and co-chair for the HL7 Modeling and Methodology Technical Committee. Ms. Curry was also a past member of the Health Information Standards Committee of Alberta and Technical Advisory Group, and was the project lead for the CIHI Canadian Conceptual Health Data Model project.

Here are a few words from the award recipient:

"I am extremely honoured to have been chosen for the first ever Partnership Peer Recognition Award. I admit I passionately believe that a coherent health infostructure is entirely dependent on the evolution of converging health informatics standards affecting all components of the health system. While I have promoted these ideas at every opportunity over the years, I have sometimes felt that I was perceived as being too idealistic or strategic and not practical enough. It's nice to know my efforts have been noticed. This award suggests to me that the time has come to realize some of these ideas. I am grateful for the support I've gotten from my employers and the encouragement from my many standards community colleagues across the country, and around the world. In many ways, recognition from peers is the most rewarding acknowledgement possible because peers know what it takes to make things happen. We may not yet have a "feedback loop" for the Canadian health system - but the establishment of the Partnership Peer Recognition Award is a key indicator that the necessary awareness is building. I intend to continue to work with my peers on evolving collaborative health information standards. It will take the combined effort of a lot of people pulling in the same direction to get there."

### Projects of Interest to the Partnership

As many CIHI Health Information Roadmap projects were planned as a direct result of past Partnership Working Group initiatives, following is an update on some of these projects which may be of interest to our members:

#### **Unique Identifiers**

The CIHI Unique Identifiers Roadmap Project is approaching completion and will conclude with a final report in March 2003. Over the past three years, the project has examined the unique identification of providers, clients and facilities across functional, geographic and jurisdictional boundaries. Project milestones included:

Background Papers on National Unique Provider Identifiers, Facility Identifiers and Client Identifiers;

- A pilot project to test the Medical Identification Number for Canada (MINC) methodology of uniquely identifying providers with the Licensed Practical Nurses in three provinces;
- Involvement in the Western Health Information Collaborative (WHIC) Provider Registry Project;
- Delivery/Facility Unique Identification Discussion Paper;

- Pan-Canadian Meeting on Client Identifiers and Client Registries;
- Client Identifier and Jurisdiction Identifier Pan-Canadian Current State Assessment Questionnaire and Report;
- Presentations at e-Health and Partnership conferences and cross Canada education sessions; and
- Ongoing cross-jurisdictional collaboration and consensus building.

#### ICD-10-CA/CCI

As of April 1, 2002, ICD-10-CA and CCI had been implemented in all three territories and seven provinces. New Brunswick's health records administrators will be trained in the last quarter of 2003 for implementation April 1, 2003. Manitoba has agreed to adopt ICD-10-CA and CCI for April 1, 2004 and Quebec is considering this date for adopting these classifications.

The Classifications' team has been very busy researching the proposed enhancements and changes to the 2001 Versions of ICD-10-CA and CCI. The 2003 Versions will be implemented on April 1, 2003. There are approximately 60 additions to ICD-10-CA and over 800 additions to CCI. Both these products will contain appendices that identify all the new codes that have been added and all the existing codes that have been disabled. For the first time these products will be available in both French and English. CIHI will also be releasing the updated 2003 version of Canadian Coding Standards for ICD-10-CA and CCI. This product will be available in both French and English.

Educational workshops to provide ongoing support to coders and to introduce analysts and researches to the changes that implementation of ICD-10-CA and CCI will have on comparative data and trending of data have occurred across the country. In 2003–2004 a coding standards workshop and one targeting obstetrical coding will be introduced.

#### ISO/TC215 WG1

CIHI continues to host the ISO/TC215 website for Working Group 1 on Health Records and Modeling Coordination on behalf of the ISO/TC215 Convener, Mr. Don Newsham.

Some of the work items which this group is involved with include:

- Country Identifier Mechanism in Healthcare
- Requirements for the Electronic Health Record Reference Architecture
- Framework for Emergency Data Sets
- Health Indicators—Definitions, Attributes and Relationships
- Health Informatics Profiling Framework
- EHR Definition, Scope and Context

Members will be pleased to know that the National Member body voting on ISO/TC 215/WG 1/DTS 21667 *Health Indicators Conceptual Framework* has closed and the ballot was approved to be published as a Technical Specification. The Canadian lead on this work item was Ms. Indra Pulcins of CIHI.
