#### **Work and Family**

Since the 1980s, the topic of work-family integration has become increasingly prominent in both the public and private sectors, and its study encompasses a wide variety of disciplines, from sociology and social work to management and law. There is a growing understanding that the threads linking people to their work and home environments are fundamentally intertwined; a satisfying career and the opportunities it can present often depends upon responsibilities to the family, while a healthy and fulfilling family life is contingent upon the choices that the professional environment affords. Successful integration of the two spheres depends upon factors arising out of race, cultural background, economic group, and occupational class. This interplay is furthermore influenced by government and organisational policies, resulting in a wide-ranging discourse with implications for workers and family members everywhere.
