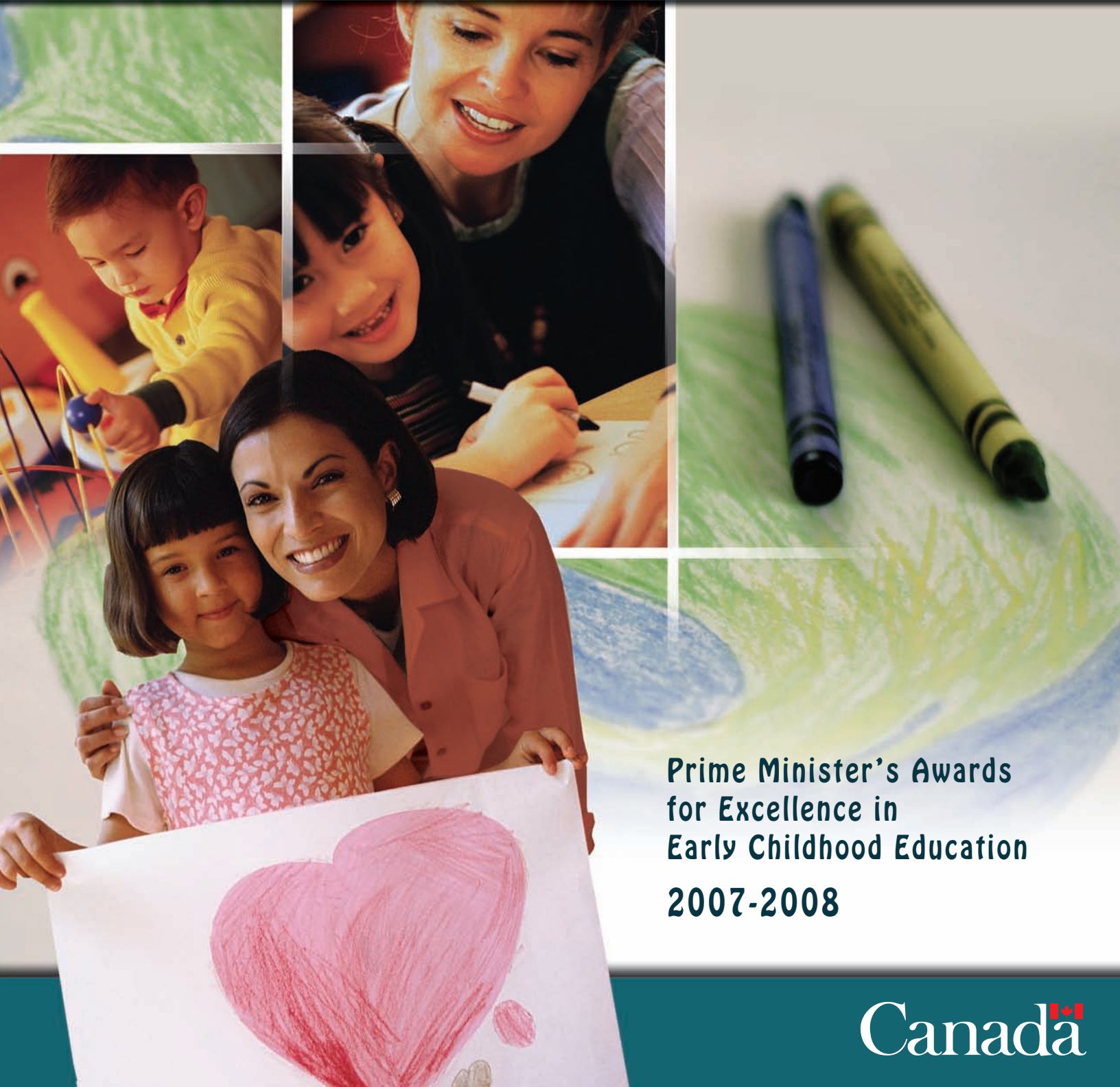

For most children, at least one educator will stand out as someone who encouraged, enabled and inspired them to be their very best when they were very young. The Prime Minister's Awards (PMAs) for Excellence in Early Childhood Education honour outstanding and innovative early childhood educators who excel at fostering the early development and socialization of the children in their care, and at helping build the foundation children need to meet life's challenges.

## Awards

- ◆ Up to 10 Certificates of Excellence (national level), each including a financial award of \$5,000.
- ◆ Up to 15 Certificates of Achievement (regional level), each including a financial award of \$1,000.

Certificates of Excellence are awarded to the 10 top-ranked nominees, with at least one award designated for each of the following regions: British Columbia; Prairies; the North (Yukon, Northwest Territories and Nunavut); Ontario; Quebec; and Atlantic Canada and at least one of the Certificates of Excellence is designated for the top-ranked Aboriginal early childhood educator.

The next top-ranked nominees (up to a maximum of 15) each receive a Certificate of Achievement. At least one of the Certificates of Achievement is awarded annually to an Aboriginal early childhood educator.

Financial awards are provided to recipients and may be used for professional development, equipment, resource materials or other tools to improve developmental programming and children's experiences related to the educator's work.

## Recognition

All recipients receive a certificate, PMA pin and letter of congratulations from the Prime Minister.

Certificate of Excellence recipients may also be invited to participate in best practice sessions and attend a special event where the Prime Minister will formally announce the PMA recipients and present them with their award certificates.

Certificate of Achievement winners are honoured at local events with children, supervisors, colleagues and local Members of Parliament or local leaders attending, as appropriate.

Each recipient's early childhood education setting, when applicable, also receives a certificate, signed by the Prime Minister, recognizing its support and contribution to the educator's achievement.

## Promotion

The achievements of all recipients are promoted both nationally and in the educators' home communities. Certificate of Excellence recipients are profiled (with their permission) in the Prime Minister's Awards *Exemplary Practices* publication, which can be viewed by everyone across Canada and around the world at [www.pma.gc.ca](http://www.pma.gc.ca). Certificate of Achievement recipients are also highlighted in this publication.

## Eligibility

Upon submission of the nomination by **December 17, 2007**, all nominees must meet the following criteria:

- ◆ Nominees must be Canadian citizens or permanent residents.
- ◆ Nominees must work a minimum of 2.5 days a week providing direct education and care to young children in a licensed early childhood education setting (as defined by provincial or territorial government regulations<sup>1</sup>). Full-time centre administrators are not eligible for this award.
- ◆ Nominees must have successfully completed training in early childhood education and care as follows: *(copy of training certification must be provided with nomination)*
  - ▲ degree, diploma or certificate in early childhood education and care;
  - ▲ official certification as an early childhood educator in the province or territory where the nominee is working; or
  - ▲ successfully completed a training program in family child care.
- ◆ Nominees must have worked in a licensed Canadian early childhood education setting for at least three years and still be gainfully employed in an ECE setting at the time of the nomination deadline (December 17, 2007).

Posthumous nominations are not accepted.

1. This requirement is waived for nominees who work in Aboriginal Head Start sites on and off reserve or in early childhood education settings on reserve where there is no applicable provincial or territorial government licensing.

The Prime Minister's Awards are designed to honour the overall accomplishments of a single educator or a team of up to three educators. The program is not intended to recognize the achievements of an entire early childhood education setting or staff. Each member of a team must meet the eligibility requirements described above. Any cash award is to be shared equally among the team members.

Educators who are not eligible for this award may be eligible for the Prime Minister's Awards for Teaching Excellence. Nomination guidelines are available at [www.pma.gc.ca](http://www.pma.gc.ca), by sending an email to [pmaece-ppmepe@gc.ca](mailto:pmaece-ppmepe@gc.ca) or by calling 613-946-0651.

## Nominators

Nominators may be any person or group with direct knowledge of the nominee's contribution (i.e. parent of child in care, co-worker, supervisor, fellow educator, etc...). However, self-nominations or nominations received from a nominee's direct family member will not be accepted.

## Renomination

Recipients of a Certificate of Achievement may be re-nominated for a Certificate of Excellence in a subsequent year, but are ineligible for a second Achievement award. Unsuccessful nominees may also be re-nominated in a subsequent year.

In all cases, a complete and current nomination package must be submitted, including letters of support written during the current nomination period.

Previous recipients of a Certificate of Excellence are not eligible.

## How Recipients Are Chosen

A committee of early childhood education and care practitioners and stakeholders from across Canada review all nominations received for the Prime Minister's Awards (see current list of organizations represented in the selection committee on the program website: [www.pma.gc.ca](http://www.pma.gc.ca)).

Based on the selection criteria outlined in this publication, the selection committee members evaluate the nominee's contribution based on the information contained in the nomination package. Nominees are then ranked based on the score received against the selection criteria and the top-ranked individuals are then recommended to the Prime Minister for recognition.



# Selection Criteria

Award recipients are selected based on their innovative approaches and outstanding ability to engage and support the development of the children in their care, and on their overall commitment to the development of children and the early childhood education and care profession. While an exemplary project or practice may form part of a nomination, nominees are judged on their overall merits as educators.

In selecting award recipients, the committee looks for **clear evidence** that nominees have excelled in **all four** areas described below.

## Support of child development

The nomination text should describe and provide evidence of how the educator provides daily experiences that support and promote each child's physical, emotional, social, cognitive, ethical and creative development, such as the following:

- ◆ optimizing each child's unique development;
- ◆ encouraging children's interest and participation;
- ◆ providing stimulating and engaging learning environments for all children;
- ◆ developing and maintaining warm, caring and responsive relationships with each child and with the group of children;
- ◆ using observation to assess children's skills, abilities, interests and needs; and
- ◆ using developmentally appropriate "best practices."

## Innovation

The nomination text should describe and provide concrete examples of the educator's use of innovative and creative approaches to encourage and support child development, such as the following:

- ◆ capturing and maintaining child interest;
- ◆ exploring new or different ideas with children;
- ◆ recognizing and adapting to children's special needs (including physical, emotional, social, cognitive and creative needs);
- ◆ recognizing and including diverse economic, cultural, linguistic and regional perspectives in the learning environment;

- ◆ respecting and promoting children's home language and cultural heritage;
- ◆ incorporating events and activities occurring in children's lives in the learning environment;
- ◆ incorporating international, national, local and community events and activities in the learning environment.

### Involvement with parents, families and the community

The nomination text should describe and provide concrete examples of the educator's efforts to involve and engage parents, families and the community in children's education and care, such as the following:

- ◆ developing and maintaining open, cooperative relationships with each child's family;
- ◆ encouraging active parent, family and community involvement in children's learning;
- ◆ developing and using innovative approaches to engaging and supporting parents and families;
- ◆ fostering community contacts or partnerships that encourage or complement children's learning and activities;
- ◆ developing and maintaining relationships with others in the early childhood education setting (such as colleagues) or with other community services involved with the children.

### Commitment and leadership in the field

The nomination text should show evidence of the educator's ongoing professional development and commitment to improving the early childhood education and care field and to enhancing the ability of others in the profession, such as the following:

- ◆ engaging in ongoing personal professional growth and learning
- ◆ organizing or delivering professional development courses, workshops or other development activities
- ◆ developing and disseminating learning materials, resources and best practices
- ◆ providing support or training to other professionals in the field (such as mentoring and training of students)



- ◆ fostering or contributing to the development of a team environment within their own early childhood education setting
- ◆ being actively involved in a professional organization, network or association related to early childhood education and care.

### Helpful Hints in Preparing A Nomination Text

**Follow the criteria set out in the nomination guidelines.** Provide adequate detail for each of the four categories of selection criteria. You may wish to organize your text using the same headings.

**Provide concrete examples and details to show how the nominee has met the selection criteria and explain the impact of the educator's efforts.**

Describe any special projects or activities, philosophies, unique learning environments, or child reactions, outcomes or achievements that make this educator stand out.

**Focus on the nominee's overall achievements.** Show that the nominee is well rounded in her or his overall work, not just in one particular project. Include activities the nominee participates in to support the development of the children in her or his care, the setting in which she or he works, colleagues and the early childhood education and care field (such as volunteer work, professional development, advocacy or social events).

## How to Apply

- ◆ Once you have identified one outstanding early childhood educator or a team of educators, develop a nomination package, following the guidelines and checklist provided.
- ◆ Each nomination package must include a completed copy of the attached PMA nomination form. This form is also available on the Internet ([www.pma.gc.ca](http://www.pma.gc.ca)).
- ◆ Forms must be signed by the nominee and the nominator, as well as by the nominee's supervisor, when applicable.
- ◆ When there is more than one nominee, please copy and complete a separate form for each.
- ◆ When more than one nomination package is received for an educator, nominators will be asked to combine their packages.

# Nomination Deadline

The deadline for nominations is **December 17, 2007**.

## Assembling a Nomination Package

An effective nomination package illustrates the outstanding achievements of the nominee and clearly explains why she or he should receive one of Canada's highest honours for early childhood educators. As a nominator, you are "painting a picture" of a nominee's achievements for a selection committee that reviews many applications, so the package should be compelling.

Your complete nomination package must not exceed **20 pages** excluding ECE certification, ECE setting's operating license and checklist.

## Format

**Typewritten and double-spaced.** All information should be typewritten in a font no smaller than 10 point and double-spaced on 8½" x 11" paper.

**One-sided.** To ensure ease of reproduction, please print on one side only.

**Packaging.** Creative packaging can certainly make a nomination package stand out. Unfortunately, the selection committee members do not get the opportunity to see it. Therefore, simple packaging is recommended.

**Binding.** For ease of reproduction, please do not bind your nomination package!

**Five copies.** In addition to the original, please include five copies of the complete package.

# Prime Minister's Awards for Excellence in Early Childhood Education

## CHECKLIST

To facilitate the preparation of the nomination package and its review by the PMA office, you may want to attach this checklist to your nomination package

- Copy of this checklist fully completed**
- Signed nomination form** (2 pages)
- Copy of ECE setting's operating licence** (as defined by provincial or territorial government regulations; if applicable) (1 page)
- Evidence of nominee's training in early childhood education and care** (such as a copy of a degree, diploma or certificate showing completion of training)
- Evidence of nominee's experience** (Employer confirmation letter indicating a minimum of three years in a licensed early childhood setting) (1 page)
- Nomination text** (maximum 5 pages)
- Letters of support** (Three letters required) (maximum 6 pages) Letters of support should provide evidence of the nominee's excellence and achievements under any or all of the four selection criteria. The selection committee looks at the picture painted in both the nomination text and the letters of support. Letters should not exceed two pages and must be signed by the author. To reduce repetition, ask writers to focus on one or two specific things about the educator that make her or him exceptional. Letters may come from anyone with direct knowledge of the nominee's accomplishments; however, letters from parents, children, peers and professional associations are often particularly effective in demonstrating a nominee's impact. Letter of support must be **issued no earlier than six months prior** to the nomination deadline, and must include contact information (mailing address and telephone number) for the author.
