
The Workplace Bulletin, issued by the Labour Program, is published twice a month. It provides wage and other information relating to collective bargaining in Canada and offers updates on industrial relations issues.

Wage Settlements Covering 500 or More Employees

August 2008

Major collective bargaining settlements reached in August 2008 provided base-rate wage adjustments averaging 4.6% annually over the contract term, up from the 3.3% average in July. The results are based on a review of 20 settlements covering 51,440 employees.



When the parties to these


settlements previously negotiated, the resulting wage adjustments averaged 2.7% and the contract durations averaged 44.6 months, compared to the 4.6% in their current round of settlements and average contract durations of 44.5 months.

The relatively large average adjustment for the month of August was due to 2 Health Boards of Alberta agreements. The first provided 13,000 nursing assistants, technical employees, and licensed practical nurses with an average annual wage adjustment of 7.3% over the life of a 48-month contract; it included a 10% market adjustment, in addition to a 5.0% wage increase in the first year. The second agreement provided 14,000 health professional employees with a wage adjustment averaging 4.8% over the life of a 36-month contract. Excluding the 2 Health Boards of Alberta agreements, wage adjustments for the remaining 18 agreements averaged 3.0%.



Wage adjustments in the public sector averaged 5.2% for 38,210 employees in 15 agreements. The 2 Health Boards of Alberta agreements (mentioned above) exerted upward pressure on the public-sector figure. Excluding the 2 Health Boards of Alberta settlements, wage adjustments in the public sector averaged 3.3%, down from 5.2%.

Private-sector wage adjustments averaged 2.7% for 13,230 employees in 5 agreements. Canada Safeway Ltd. in British Columbia provided 9,800 retail employees (74% of private-sector employees), with wage gains averaging 2.6%.



On a jurisdiction basis, wage adjustments ranged from a low of 2.4% in Quebec, to a high of 5.9% in Alberta (due to the Health Boards of Alberta settlements). Ontario averaged a wage increase of 2.5%; Manitoba, 2.7%; and British Columbia, 2.6%. There were no major settlements in the federal jurisdiction.

On an industry basis, wage adjustments ranged from a low of 1.4% in the manufacturing sector to a high of 5.4% in the education, health, and social services sector; the largest concentration of employees (70.5%) and agreements (60%) was also in the education, health, and social services sector.

Wage adjustments in the first 8 months of 2008 (January through August) averaged 3.2% for 414,520 employees

in 167 agreements: the public-sector average was 3.6% for 259,680 employees in 103 agreements and the private-sector average was 2.6% for 154,840 employees in 64 agreements.

In the following tables, COLA is the abbreviation for Cost-of-Living Allowance.
