Highlights

December 2007

- Refined petroleum product sales were led by a strong demand for motor gasoline.
- Regular unleaded motor gasoline accounted for about 90% total motor gasoline sales.
- Crude oil and equivalent receipts by refineries totalled 8.9 million cubic metres.
- Petroleum product inventories totalled 11.2 million cubic metres.

Analysis – December 2007

Domestic sales of refined petroleum products in December 2007 totalled 8,631.1 thousand cubic metres, up 4.2% from the same month a year earlier. On an annual basis sales of refined petroleum products in 2007 were 3.7% higher than 2006.

The 2007 increase in sales was led by strong domestic demand for transportation fuels. Demand for motor gasoline increased by 3.9% over 2006. Diesel fuel oil was up by 4.8%. All other products posted increases with the exception of naphtha and asphalt.

On a national basis Canadians consumed almost 43 billion litres of motor gasoline in 2007. Regular unleaded gasoline accounted for about 90% of this volume. Premium gasoline accounted for about 8%. On a provincial basis Ontario consumed about 38% of motor gasoline sales followed by Quebec (22%) and Alberta (14%).

In December 2007, domestic refineries produced 10.6 million cubic metres of refined petroleum product, 3.4% above a year earlier. On an annual basis refinery production totalled 121.7 million cubic metres 1.6 % above 2006. Motor gasoline and diesel fuel oils represented about 58% of total refinery output unchanged from the year before.

Domestic refiners took 8.9 million cubic metres of crude oil and equivalent in December 2007 slightly below the same month a year earlier. However on an annual basis refineries received 107.6 million cubic metres, 4.0% above the 2006 level. This increase was led by a 6.7% rise in the receipts of domestic crude oils to 57.7 million cubic metres.

Refineries received 3.8 million cubic metres of imported crude oil in December 2007. In 2007 crude oil imports totalled 49.8 million cubic metres representing about 46% of total refinery receipts compared to a 48% share in 2006. OPEC countries comprised 50% of all imports led by Algeria, Saudi Arabia and Iraq. North Sea sources supplied 38% of total crude oil imports.

Total crude oil and refined petroleum products held by refineries and major distributors closed 2007 at 14.3 million cubic metres, 4.3% higher than the close of 2006. Of this volume, crude oil inventories accounted for 3.1 million cubic metres, 9.7% lower than a year earlier. Refined petroleum product inventories closed the year at 11.2 million cubic metres 9.1% higher than a year earlier.

millions of cubic metres

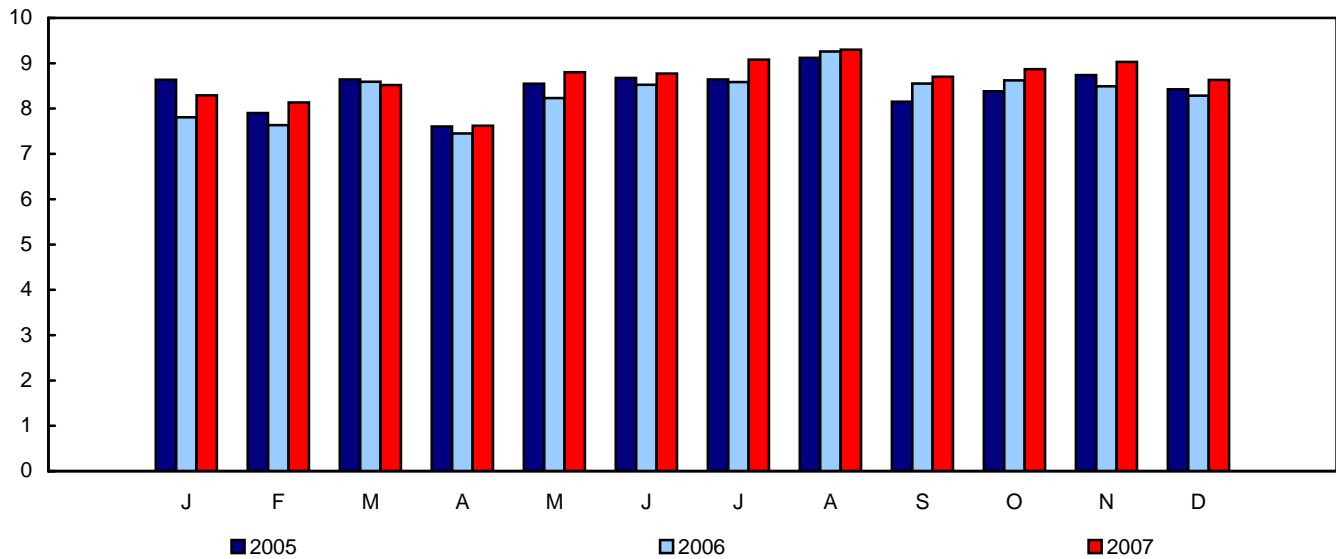

Domestic sales of refined petroleum products – by product – December 2007

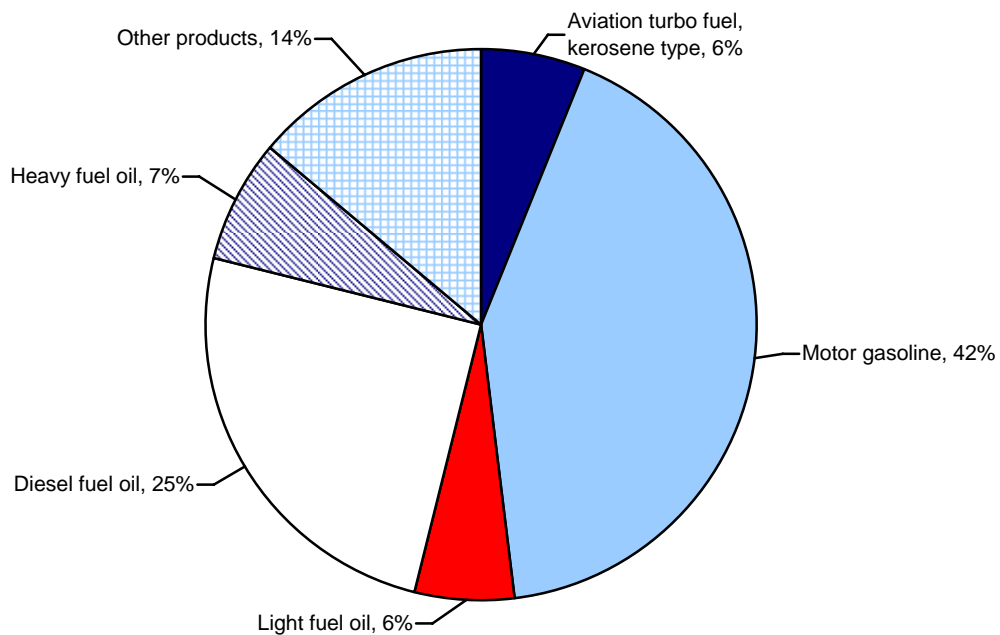

Domestic sales of refined petroleum products – by region – December 2007

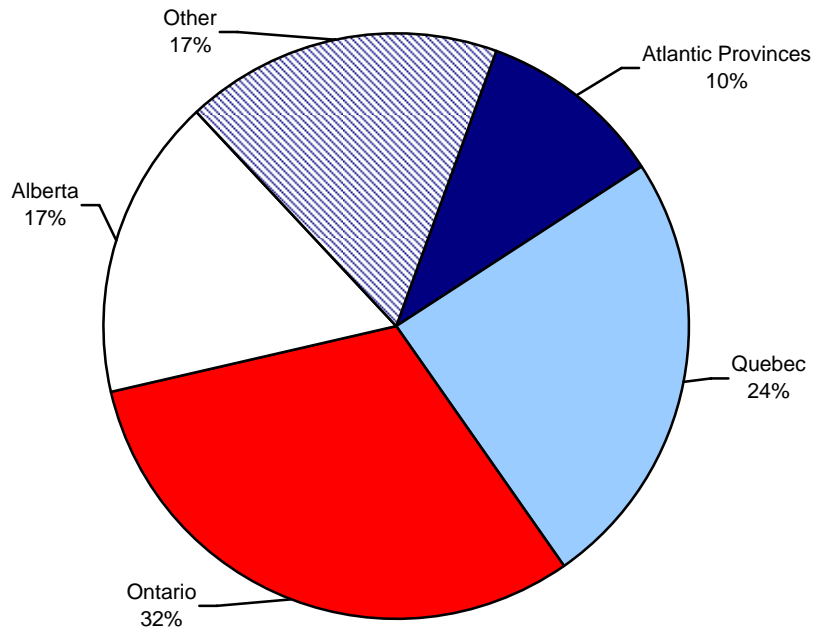

Refinery supply of crude oils – domestic and import receipts – December 2007

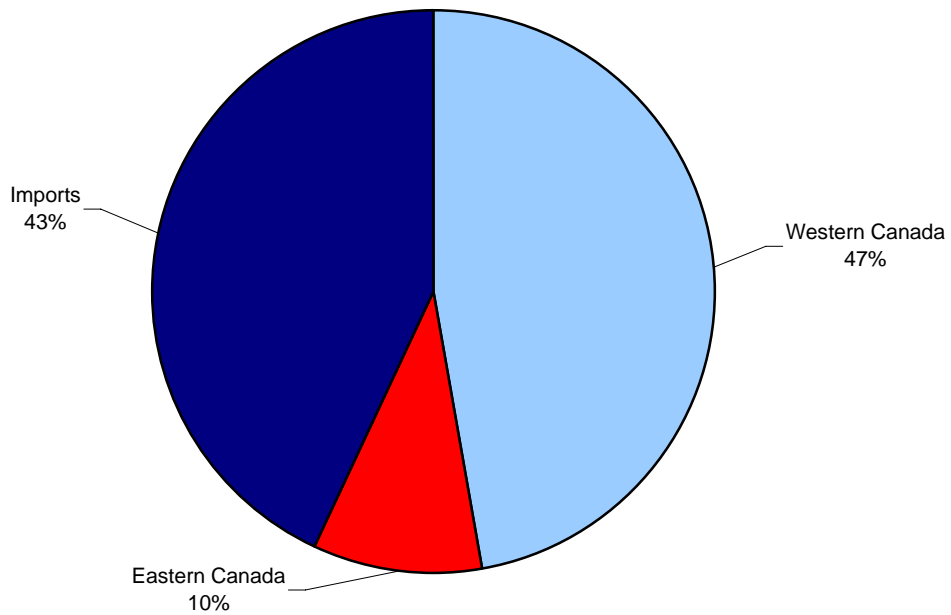
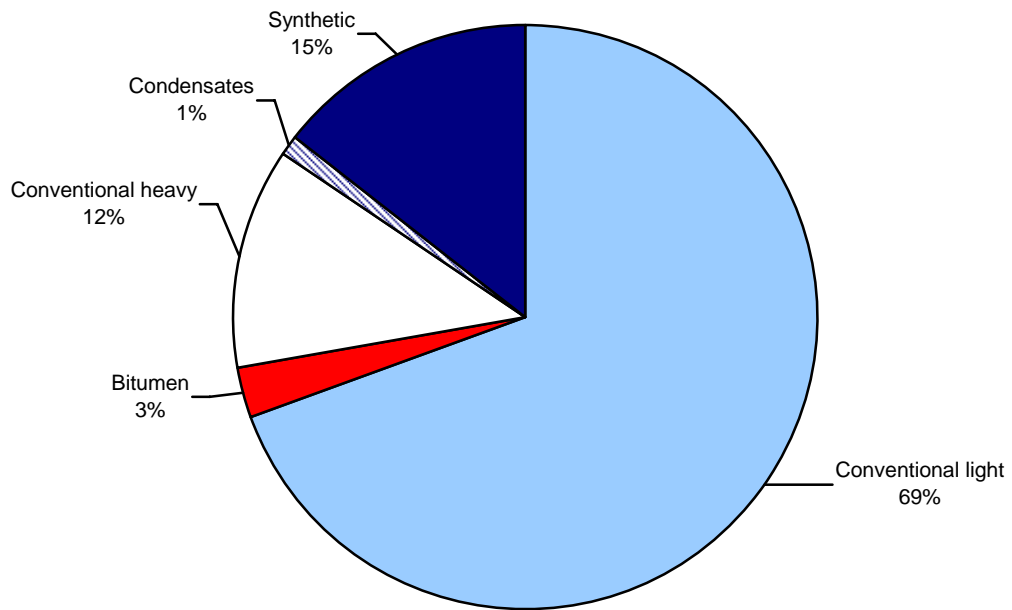


Chart 5

Explanatory notes

Data quality and methodology

This publication results from the compilation of data reported monthly in the “Refined Petroleum Products” Survey, covering all refining companies in Canada and major wholesalers/distributors. We would like to thank these respondents for their co-operation in the survey.

In order to ensure the accuracy and consistency of these data, the results of this survey are reconciled with other Energy section surveys such as the monthly Crude Oil and Natural Gas Production (survey ID # 2198), the monthly Oil Pipeline Statement (survey ID # 2191) and the monthly Oil Pipeline Transport (survey ID # 2148) surveys in terms of inter-provincial movements, imports, exports and deliveries to refineries by type of crude and means of delivery.

For survey data, non-sampling errors can be attributed to one or more of the following sources :

Data response error. This error may be due to questionnaire design and the characteristics of the questions, inability or unwillingness of the respondent to provide correct information or misinterpretation of the questions because of definitional difficulties.

Non-response error. Some respondents are unable to respond, while others may be too late in responding. Data for the non-responding units can be imputed using the data from responding units. The extent of error due to imputation is usually unknown and is very much dependent on any characteristics differences between the respondent group and the non-respondent group in the survey.

Processing error. These are the errors that may occur at various stages of processing the data such as coding, data entry, verification, editing, weighting, tabulation, etc.

These reported data allow for a measurement of refining activity in Canada. The supply of crude oil is indicated by source and the volume oil other materials charged is also shown. Production of 17 refined products or groups of products is detailed and is measured at a “net yield” level, that is, after exchanges between various processes in refinery operations. As a result, inter-products transfers are primarily those transfers needed for marketing purposes. Propane and butanes, shown at the gross level, are the exceptions to the net yield measurement and therefore interproduct transfers for these products are not restricted to marketing transfers, but include movement to gasoline blending, to petrochemicals, etc. Similarly, interproduct transfers for “other products”, a classification covering unfinished products whose final product form can vary, is not restricted to marketing transfers.

Data on the exports and imports of refined products are those reported by respondents to the survey, adjusted for exports and imports made by non-responding companies. When such adjustments are made, corresponding changes are made to “domestic sales”. As a consequence, figures shown for “domestic sales” should accurately reflect total Canadian demand for refined products.

A quarterly questionnaire, requesting a detailed breakout by consumer categories of the domestic sales figures shown in this publication, is completed by the same companies that report to the monthly “Refined Petroleum Products” survey. The results of this quarterly survey, together with data for all other energy forms, are published in Catalogue no. 57-003-X “Report on Energy Supply – Demand in Canada”.

The questionnaire used in the monthly refined petroleum products survey is subject to regular revision to reflect changing technologies, etc. Similarly, the list of respondents is constantly updated to ensure a total coverage of refining operations and a sufficiently wide coverage of the wholesalers/distributors of refined products.

The Canadian Socio-economic Information Management System (CANSIM), which is Statistics Canada’s computerized data bank, contains most of the data presented in this publication from 1973, less detailed information is available for the years 1956 to 1972. Please refer to tables 134-0001, 134-0002 and 134-0004.

Data Confidentiality

Statistics Canada is prohibited by law from publishing any statistics which would divulge information relating to any identifiable business without the previous consent in writing of that business. The disclosure of data likely to reveal specific information on the activity of a particular company is therefore systematically and rigorously controlled and regulated to prevent the publication or disclosure of any information deemed confidential. The rules regarding the confidentiality of parts of the results of merchandising surveys are therefore applied in such a way that no data are shown for cells (or statistical units) composed of fewer than three companies or of three or more if these are dominated by one or two companies. Then, in the publication itself, the information is withheld on this designated cell by entering an “X” in the appropriate cell.

Another way of preserving data confidentiality without having to enter an “X” is to combine (consolidate) the information from selected regions or selected cells) for the same item. The data in question can then simply be aggregated and published in a less detailed, but still confidential form.

Definitions

Refined petroleum products

Propane, and propane mixes. A normally gaseous paraffinic compound extracted from refinery gases.

Butane, and butane mixes. A normally gaseous paraffinic hydrocarbon extracted from refinery gasses.

Petrochemical feedstocks. Refinery gases or other petroleum derivatives if sold to a chemical company to be used as a raw material for further processing, such as chemicals, synthetic rubber and a variety of plastics.

Naphtha specialties. Includes materials such as industrial and commercial solvents, lighting naphtha, mineral spirits and paint thinners.

Aviation gasoline. All gasoline type fuels for piston type aircraft engines.

Motor gasoline. All gasoline type fuels for internal combustion engines other than aircraft.

Retail sales of motor gasoline. All sales of motor gasoline (including additives) to retail outlets, including marinas, irrespective of type of ownership or operations including own brands, subsidiary, brands, the known or authoritative estimate of retail sales of jobbers, resellers, agents etc.

Aviation turbo fuel (kerosene type). All kerosene type fuels for turbo-jet or straight type jet aircraft engines.

Aviation turbo fuel (naphtha type). All naphtha type fuels for turbo-jet or straight type jet aircraft engines..

Kerosene, stove oil. Includes mineral lamp oil, no.1 fuel oil, and stove oil (including all vaporising burning oil). Is used in space heaters, cook stoves and is suitable for use as an illuminate when burned in wick lamps.

Diesel fuel oil. All grades of distillate fuel sold for diesel engine use including low sulphur content (with sulphur content lower than 0.05%).

Light fuel oil (nos.2 and 3). Includes all distillate type fuels for power burners, fuel oil no.2 (heating oil no.2), fuel oil no.3 (heating oil no.3), furnace fuel oil, gas oils and light industrial fuel.

Heavy fuel oil (nos.4, 5 and 6). All grades of residual type fuels including low sulphur (with sulphur content lower than 1%) for both steam and diesel engines. Bunker B and Bunker C, fuel oils no. 4, 5 and 6, and residual fuel oil

Asphalt. Produced by petroleum processing and includes asphalt flux, asphalt primers, asphaltic saturants, bitumals, cutback asphalts, liquid or solid asphalts, oxidized asphalt, paving compound and fluxes or primers.

Petroleum coke (including coke from catalytic cracker). All petroleum coke included. Petroleum coke is obtained mainly by cracking and carbonising of residue feedstocks, tar and pitches in processes such as delayed coking or fluid coking. The two most important qualities are green coke and caluminiated coke. This category also includes catalyst coke deposited on the catalyst during refining processes: this coke is not recoverable and is usually burned as refinery fuel.

Lubricating oil and grease. Includes all oils and greases of petroleum origin manufactured or sold for lubricating purposes. Also contains automotive or industrial oils which may be described as having special properties other than lubricating alone such as brake fluids, automatic transmission oils, industrial cutting oils or coolants and rust preventatives.

Still gas. The remaining unseparated gaseous fractions produced in refinery distillation or cracking produced in refinery distillation or cracking processes, after marketable products have been extracted. This is usually consumed as refinery fuel although sales have been made to public gas utilities under certain circumstances.

Other petroleum products. All other petroleum products such as wax and candles, unfinished products, etc..

Supply and disposition of petroleum products

Refinery supply of crude oil. Total domestic crude receipts - Receipts of domestic crude oils and equivalent at refineries for processing into petroleum products or held in inventories.

Supply regions:

Western Canada - Manitoba, Saskatchewan, Alberta, British Columbia, Northwest and Yukon Territories

Eastern Canada - Newfoundland, Nova Scotia, Prince Edward Island, New Brunswick, Quebec and Ontario

Atlantic Canada - Newfoundland and Labrador, Nova Scotia, Prince Edward Island and New Brunswick

Other provinces and territories - Manitoba, Saskatchewan, British Columbia, Yukon, Northwest Territories and Nunavut

Total crude imports. Receipts of imported crude oils at refineries for processing into petroleum products or held in inventories, by foreign country.

Note: OPEC (Organization of Petroleum Exporting Countries) includes Iran, Iraq, Saudi Arabia, Algeria, Venezuela, Kuwait, Libya, Nigeria, Qatar, United Arab Emirates, Angola, and Indonesia.

Grand total receipts of crude oils and equivalent. Total receipts of domestic crude oils and equivalent plus total crude oil imports at refineries for processing into petroleum products or held in inventories.

By pipeline. All domestic and imported crude oils received into refinery tankage from pipelines.

By other means. All domestic and imported crude oils received into refinery tankage from means other than pipelines for example tank car, tank truck, tankers etc.

Inventories (opening and closing). Refinery tankage of domestic and imported crude oils, excludes pipeline fill. The opening inventory of the reporting month equals the closing inventory of the previous month.

Losses and adjustments. Crude oil losses due to spillage, metering difference etc, after receipt into refinery tankage.

Total crude oils and equivalent charged. The total volume of domestic and imported crude oils put into refinery processing units for processing into petroleum products. The sum of crude oil receipts by pipeline, by other means, transfers from other reporting companies and opening inventories minus transfers to other reporting companies, closing inventories and losses and adjustments. Note: transfers to and from other reporting companies are not displayed.

Feedstock charged

Total crude oils and equivalent charged. The sum of crude oils and equivalent feedstock noted below put into refinery processing units for processing into petroleum products.

- i. **Conventional light crude oil charged.** All medium and light crude oils of 26 degrees API and over excluding synthetic crude oil production, condensate and pentanes plus.
- ii. **Conventional heavy crude oil charged.** All crude oils under 26 degrees API which in its natural state can be recovered with primary pumping techniques.
- iii. **Synthetic crude oil charged.** High quality light crude oil derived from upgrading bitumen from oil sands (see Conventional light crude oil charged).

- iv. **Crude bitumen charged.** Heavy crude oil, below 20 degrees API, not recoverable commercially without application of in-situ recovery techniques for example steam injection.
- v. **Condensate and pentanes plus charged.** Low density crude oils with a rating of over 40 degrees API.

Note: API (American Petroleum Institute). Internationally accepted measure of crude oil specific gravity, for example water has a specific gravity of 10 degrees API.

Other materials charged

Total other materials charged. The sum of other refinery feedstock noted below excluding crude oils and equivalent put into refinery processing units for processing into petroleum products.

- i. **Crude tops.** That portion of crude oil charged that remains after a refinery has extracted the desired heavy products which is subject to further processing.
- ii. **Crude bottoms.** That portion of crude oil charged that remains after a refinery has extracted the desired light products which subject to further processing.
- iii. **Liquefied petroleum gases (LPGs).** Includes propane and butane or propane and butane mixes.
- iv. **Natural gas.** Excludes natural gas used for non-refining purposes such as for heating.
- v. **Lubricating oils and base stock in operations.** Excludes substances used to reduce friction.
- vi. **Other feedstock used in operations.** Additives to improve refinery yields.

Total feedstock charged. The sum of 'Crude oil and equivalent charged' and 'Other materials charged.'

Refinery losses. Refineries produce a greater volume of finished products whose specific gravity on average is greater than feedstock charged as inputs to processing units. The resulting 'volumetric gain' is shown as a deduction (negative entry) from refinery production to ensure balancing of refinery production with refinery inputs.

Refinery production

Refinery production. The volume of petroleum products produced from crude oil and equivalent and other materials input into refinery processing units. Production is measured on 'net yield' basis, that is, the stage after exchanges between the various processes of the refinery.

Transfers to refinery feedstocks. Previously refined or partially refined petroleum products and other materials input into refinery processing units for further processing into other petroleum products.

Inter-provincial transfers (in / out). The movement of petroleum products entering or leaving one province from another.

Receipts and deliveries to and from other reporting companies. Receipts from and deliveries to other reporting companies of petroleum products where a change in title to product being transferred has occurred (see Appendix I).

Imports. Receipts of finished and unfinished petroleum products received from foreign sources.

Inventories (opening and closing). Petroleum product refinery and marketing inventories. The opening inventory of the reporting month equals the closing inventory of the previous month.

Exports. Sales of finished or unfinished petroleum products for export outside of Canada.

Losses and adjustments. Petroleum product refinery or marketing losses due to metering difference, shrinkage, spillage etc.

Own consumption. Amount of petroleum product produced or purchased and used in refinery operations.

Domestic sales. The sales of finished and unfinished refined petroleum products. This line is the sum of production plus inter-provincial transfers-in, receipts from reporting companies, receipts from non-reporting companies, imports and opening inventory minus inter-provincial transfers-out, closing inventory, deliveries to reporting companies, exports, losses and adjustments and own consumption.
