



# Canada-Nevada Trade



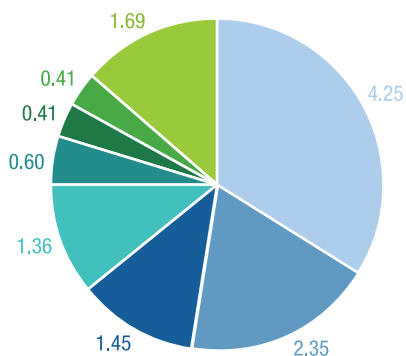
- Total bilateral trade between the state of Nevada and Canada amounted to \$1.4 billion in 2006. Coin and token operated games top Nevada's number one export to Canada, while Canada's top exports to Nevada are wood and paper products. Two-way trade in agriculture and agri-food products totaled \$39.7 million in 2006.
- Canada was the destination for almost 43 percent of Nevada's 2006 agriculture and agri-food exports. Miscellaneous processed food products topped the list of Nevada's agriculture and agri-food exports to Canada in 2006. Nevada also exported \$3.6 million in an array of prepared foods, and \$1.7 million in live animals to Canada.
- From Canada, Nevada purchased a variety of goods in 2006, including over \$3 million in crabs, lobsters and prawns, \$2.7 million in whiskies, \$1.2 million in pet food, \$1.2 million in beef, and \$1.3 million in beer.

## TRADE SUPPORTS NEVADA'S FAMILIES

Canada's population is slightly less than the population of the state of California, but the face of agriculture remains the same for both Canada and the United States. Both in Canada and the United States, 98 percent of farms are family operations. Nevada produces and exports agricultural products. In 2006, the state's farm cash receipts totaled \$479 million. In 2006, this state exported an estimated \$44 million worth of goods worldwide. Agriculture is important to Nevada's economy. It creates jobs on farms and also supports jobs in related sectors, such as food processing, transportation, and manufacturing.

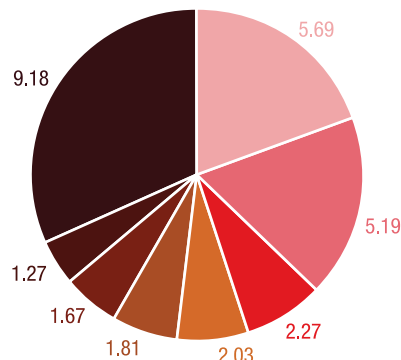
## HOW IMPORTANT IS AGRICULTURE?

In the U.S., the agriculture and agri-food industry represents roughly 5% of GDP, and is responsible for roughly 24 million jobs when you consider everything from growing the food to selling it at the local supermarket. In Canada, the agriculture and agri-food industry generates 8% of the GDP. It also employs nearly 2.1 million people, or approximately one out of every eight Canadians. Agriculture remains a central component of Canada's economy.
