The Ontario Court of Appeal has ruled that Ontario's municipal government institutions can't use technological barriers as an excuse to deny access to information requests made by the public.

The ruling is in response to a request for information from the Toronto Police Services Board's electronic databases. The board had refused arguing it would have to create new software to extract the information which would "unreasonably interfere with the operations of the police."

According to the National Library of Australia parts of Australia's valuable cultural history could be lost forever if Web archiving is not seriously undertaken in Australia.

The library's senior librarian in Web archiving, Edgar Crook, says that as new websites are created, literally on a daily basis, recording every single one is impossible.

Crook adds "We've been going for quite a while and we have at the moment about 2.9 terabytes of information, but that is a drop in the ocean to what has been produced since 1996. So we're trying, we're capturing a small amount and we're hoping that is going to be relevant."

Headline: NARA wants to replace Archival Research Catalog (ARC)

The ARC provides a description of what the National Archives and Records Administration (NARA) has in its repositories and permits users to retrieve information by searching for keywords and through other means.

However, the catalog can no longer keep up with the rapid progress being made by companies working with NARA to digitize its holdings. This has prompted NARA to look for new ways to share and manage its growing amount of data.

A new system would require the capacity to support at least 250 million archival descriptions and links to upwards of 500 million digital copies over the next four to seven years.

Other bills include (1) Making information documenting changes to electronic documents a public record (2) Allowing government officials to remove personal information about senders from emails they have received (3) Classifying as a public record metadata, or data about other data that's contained within a file, which identifies who accessed it and when.

Survey Subject: Infrastructure priorities within the Indian CIO community

Organization: EMC Corporation has announced the results of the IDG Mindtrack survey.

**Survey Participants:** The survey draws upon the experience and feedback of 148 CIOs polled from leading organizations across different industry verticals.

Summary: According to the survey:

- (1) Nearly 80% of the data within organizations is either partially or completely unstructured with only a fraction of the employees having complete access to structured data.
- (2) A majority of CIOs are firmly convinced that an enterprise-wide information management strategy is important, if not critical, for the success of their businesses.

CIOs however are divided on the issue of whether or not there are benefits to heterogeneous storage architecture.

**(3)** More than half of CIOs surveyed will increase their security budgets in the range of 10-30% to combat rising theft and leaks of intellectual property and financial information.

**Conclusion:** There is a need for information management solutions that will mitigate the challenges associated with the increase in digital data and organizations must adopt an information centric approach to securing their vital digital assets.

In addition, the increase in unstructured data versus the availability of storage is driving corporate investments in storage virtualization, information lifecycle management and back-up / archival technologies, with the latter receiving the most attention.

**Overview:** After leaving the legal team at Bell Canada, Montréal lawyer Dominic Jaar created his own consulting company which assists law firms and businesses inside and outside Quebec downsize by combining law with technology in an innovative and practical way.

**Summary:** Instead of competing with the larger companies in the information systems integration consulting field Jaar targeted a narrower market of "better managing the information in order to reduce your costs and be more effective in cases of litigation."

Jaar says "where there is a gap right now is mainly with information management. Indeed, it is often management of information technology processes and electronic documents that ends up bogging down and creating extra costs for lawyers and law firms, and other businesses."

Another challenge, according to Jaar, is being able to retrieve information. "Company employees spend as much as 30 percent of their time looking for information. Multiply that by the salary, and the cost to the clients, and in this downturn economy, it is a huge amount of money you could be saving."

As for lawyers, Jaar says, "due to the explosion of the volume of information you have with electronic documents, you are creating piles and piles of paper, actually boxes of paper in every case you have now. The lawyers end up managing paper, as opposed to managing the case."

As companies and law firms continue to deal with compliance and governance regulations, business consulting companies such as Jaar's will continue to advise them.

Overview: The digital universe is expanding.

The amount of digital information produced by the world in the year 2011 will reach 1,800 exabytes, or 10 times higher than that produced in 2006, with 95 percent of it being unstructured.

#### **Main Points:**

- (1) The digital universe is expanding exponentially and haphazardly and has also been accompanied by a parallel increase in the personal digital information footprint or 'digital echo'.
- **(2)** The proliferation of groups of data by individuals, specific work groups, etc., also creates redundant and duplicate information repositories, adding to the confusion with huge cost implications as well.
- (3) Corporations will ultimately be responsible for the security, privacy, reliability, and compliance of over 85 per cent of all this information, despite the fact that over 75 percent of it will be created by individuals.
- (4) The strategy of organizations will increasingly have to centre around comprehensive information management, built around an integrated information infrastructure and strong information governance protocols.
- **(5)** Given the size and complexity of information at enterprise levels, organizations will require new information management tools, standards and an information infrastructure that is flexible, adaptable, and scalable to manage exponential growth.

**Overview:** Billy Segal, Director, Israel Broadcasting Authority (IBA) archive talks about the archive's initiatives and challenges.

**Summary:** After 22 years of working at the archive, 12 of them as its director, Segal is focused on the future.

One example is the agreement between Harvard University and the IBA that will see materials stored at the IBA transferred to digital files.

"We'd already had a connection with Harvard for several years," relates Segal, "but with reference to digitization, the connection was made by Moti Amir from Israel Radio. They want to purchase all of the State of Israel's Judaica documentation, to have a copy of every Jewish-Israeli work there."

This agreement is welcome news to Segal as she sees firsthand the disintegration of the collections in the archive she directs.

In regards to addressing the problem Segal says "every time I brought the idea to the management, to the various managements, they all tied my hands. My job, my mandate, is to save the archive. If we don't do something, there are materials that are going to be ruined. They will disappear."

**Topic/Title:** We're in danger of losing our memories

Type of Document: Opinion Piece

Author: Lynne Brindley, Chief Executive of the British Library featured in The Observer

**Summary:** In the age of the Internet there is an infinite amount of information that is accessible online. For example there are approximately 8 million .uk domain websites which are growing at a rate of 15-20% each year.

These websites contain valuable information which is not always being preserved because the websites disappear along with the information contained in them.

Brindley cites examples such as the White House website removing information pertaining to President Bush's administration when Obama became President and websites that contained information about the 2000 Sydney Olympic Games which no longer exist.

Brindley says that organizations, such as Google, are not archiving this type of material and therefore it is essential that archives and libraries take the lead.

She emphasizes that if websites continue to disappear the memory of the nation disappears too and historians and citizens of the future will find a black hole in the knowledge base of the 21st century.

She adds that it is her job to ensure that this does not extend to Britain's national memory.

Topic/Title: HOLD UP!

**Summary:** A litigation hold is not a reason for ignoring your records retention schedule for the remainder of your records. This article describes the five steps to keep moving forward.

#### **Five Steps:**

- 1) Determine what records and information should be preserved. Being under a legal hold does not mean the records have to be in your office or on your computer.
- 2) Apply retention requirements to the records and information not covered by a legal hold.
- 3) Work with IT to ensure preservation of data subject to the legal hold from systems that are at the end of their lifecycle.
- **4)** Review abandoned or orphaned data sets for relevance. Data that needs to be held can be archived offline and data that does not need to be held may be deleted, but either way abandoned data does not have to remain on the system.

**5)** Meet with litigators and the discovery teams to review legal holds that have been in place for an extended period of time.

**Conclusion:** There is no need to put a "hold" to the elements of an organization's Records Information Management (RIM) Program.

During litigation, more than ever, management should comply with the requirements to continue demonstrating that RIM controls and processes are carried out in the normal course of business.

Compliance with a RIM Program should not stop just because of litigation. Applying RIM processes and controls during discovery and litigation can be done.
