Introduction

stablished by the federal Government in 1967, the Security and Defence Forum (SDF) continues to promote and strengthen Canadian academic expertise and interest in a wide range of security and defence issues. This academic grant programme, valued at \$2.5 million/year, is mandated to:

- Develop and support a strong Canadian academic competence in security and defence issues;
- Foster informed public discussion and commentary; and,
- Enhance communication between the Department, the Canadian Forces (CF) and the academic community.

The SDF carries out this mandate through three main activities:

- Annual grants to promote teaching, conduct research, and encourage publication in security and defence issues at twelve Centres of Expertise and a Chair of Defence Management Studies, located at universities across Canada;
- Awards such as scholarships and internships to scholars pursuing Master's, Doctoral and Postdoctoral studies on security and defence topics; and,
- Special Project funding to support conferences or other unique activities, by individuals or organizations that are directly relevant to the mandate of the SDF.

This report, for fiscal year 2008/2009 covers the third fiscal year of a five-year funding cycle that will end in 2010/2011.









Governance

he Security and Defence Forum follows a Treasury Board approved programme accountability framework that includes indicators and reporting mechanisms to ensure that the Forum's activities have their intended effects. An independent, ministerially-appointed Selection Committee meets to review Annual Reports from the twelve Centres of Expertise and the Chair of Defence Management Studies to assess their performance against Grant Agreements that were concluded at the beginning of the current five-year cycle. The independent Selection Committee consists of representatives of academic, public and private institutions in the defence and security community. It ensures academic freedom, preserves neutrality in the review process, and contributes to the sound management of public funds.

The Committee also selects the recipients of various research and academic awards and internships.

SDF Selection & Business Committee Meetings

On 12 and 13 May 2009, the SDF Selection Committee met at the Army Officers' Mess in Ottawa. The Committee – chaired by Dr. Kim Nossal – reviewed the performance of all the Centres of Expertise and the Chair in Defence Management Studies, decided on the SDF Award recipients for 2009/10, and assessed the overall direction of the SDF.



Representatives from the twelve SDF Centres and the Chair of Defence Management Studies gathered for their annual Business Committee meeting on 4 June 2009.

The meeting included an overview of the 2008/09 fiscal year and two briefing sessions: one by Policy Group representatives Dr. Michael Margolian (Director General Policy Planning) and Mr. Claude Leblanc (Director Arms and Proliferation Control Policy); and a second on opportunities featuring Dr. Brooke Smith-Windsor (NATO Defence College), Ken MacKillop (Director External Communication and Public Relations) and Dr. David Emelifeonwu (Canadian Defence Academy).










In FY 08/09, more than 700 staff and graduate students were involved in research, including 156 faculty members. SDF scholars produced nearly 900 publications, and faculty taught some 230 graduate and undergraduate courses. More than 9,700 students were enrolled in courses related to security and defence.

SDF Annual Fall Conference – "Canada and the Changing Strategic Environment: The Canada First Defence Strategy and Beyond."

The SDF Annual Fall Conference was held at the Centre of International Relations at the University of British Columbia and at CFB Esquimalt from 23 to 25 October 2008. It brought together experts from all SDF Centres, DND and the CF. Five panels – with some 21 papers – were presented. While at CFB Esquimalt, the participants heard from the Chief of the Defence Staff, General Walter Natynczyk, and had the opportunity to tour HMCS *Ottawa*.

SDF Operational Visit

In June 2008, scholars from each SDF Centre and the Chair in Defence Management Studies participated in a four-day briefing tour to Belgium and France. The visit was sponsored by the SDF, and organized by Dr. James Fergusson, of the Centre for Defence and Security Studies at the University of Manitoba, with the assistance of the NATO Information Office.

The visit began with two days of briefings at NATO Headquarters in Brussels. A third day in Brussels included a round table with the German Marshall Fund, and discussions with staff and guest speakers at the Mission of Canada to the European Union.

The fourth day was spent in Northern France touring the Beaumont Hamel Newfoundland National Historic Site, the Ulster Memorial, Pozières Ridge, and the Vimy Ridge National Historic Site. Historians Brent Wilson of the University of New Brunswick and Dr. Patrick Brennan of the University of Calgary both offered their insights into the battlefields the group visited.



Academic Awards

ach year, the Security and Defence Forum supports the work of Canadian students in the field of security and defence by offering a number of scholarships and fellowships at the Master's, Doctoral and Postdoctoral level.

The SDF internship programme promotes the professional development of graduates, by encouraging post-graduate employment opportunities for defence research and analysis. Interns can work for a range of organizations in the security and defence field including think tanks, non-governmental organizations, and international organizations. In 2008-09, the SDF provided funding to four Intern candidates, who were placed at the North-South Institute, the Conference of Defence Associations Institute, the Canadian International Council, and the Atlantic Council of Canada.

The Aboriginal Student Award is a funding pool of \$10,000 to support First Nations, Inuit and Métis Canadians in studying defence and security issues. In 2008-09, an Aboriginal Award of \$10,000 was given to one individual.

In 2008-09, the Selection Committee awarded a total of \$372,500 in academic awards:

- one R.B. Byers Post-Doctoral Fellowship (\$35,000);
- one Post-Doctoral Fellowship (\$35,000);
- one Dr. Ronald Baker Doctoral Scholarship (\$22,500);
- two Doctoral Scholarships (\$20,000 each);
- nine Master's Scholarships (\$10,000 each);
- one Aboriginal Scholarship (\$10,000); and;
- four internships (\$35,000 each).

SDF Internship: Krista Nerland (North-South Institute)

Krista Nerland received an SDF Internship in 2008-09 and has been working with the Conflict Prevention and Peacebuilding Team and the North South Institute (NSI). Krista has also been involved in projects on gender and security sector reform, and on regional approaches to security in Afghanistan/Pakistan. He is an MA candidate at Carleton's Norman Paterson School of International Affairs (NPSIA), with a background in Political Science and Arab Studies from the University of Ottawa. His research to date has centered upon intelligence sharing within multinational operations and the experience of the Canadian Forces in Afghanistan. He aspires to complete his research by December 2009 and will consider his options to pursue Doctoral studies in the future.

Special Projects 2008-09

vailable to the academic community, the voluntary and NGO sector, and private individuals, the Special Project Fund provides support for a wide range of activities, including conferences, simulations, workshops and academic visits.

In addition to promoting a broad Canadian dialogue on security and defence issues, the Special Project Fund helps to foster links between the public and the Department of National Defence and the Canadian Forces.

In 2008-09, 60 requests for support were received, amounting to \$451,095. Of these, 43 activities were funded, totalling \$279,506.

50% of Special Projects funding went to SDF Centres and their affiliated researchers; the balance was from non-SDF universities, research centres, the voluntary sector and NGOs.

Northern Model United Nations Conference

On 30 and 31 March 2009, the United Nations Association in Canada (UNAC) held its second *NorthernMUN* (model United Nations) for high school students residing in northern Canada. The students, who represented some 20 UN member states, debated and voted on draft resolutions such as the right to food, measures to prevent terrorists from acquiring weapons of mass destruction, and climate change.

Combined Task Force 150 Observation

Pat Lennox, J.L. Granatstein Postdoctoral Fellow at the Centre for Military and Strategic Studies, received Special Project funding to support a research project on Combined Task Force 150. For 105 days throughout the summer of 2008, Dr. Lennox observed the deployment of the Canadian Task Group — comprising Her Majesty's Canadian Ships *Iroquois*, *Protecteur* and *Calgary* — as part of a multilateral coalition. Deployed to the Arabian Sea, Task Force 150 was charged with securing the area from destabilizing forces such as piracy, terrorism and the flow of illicit narcotics and arms. From his experience with the Task Force, Dr. Lennox produced a series of articles on the role of the Canadian Navy in achieving Canada's security policy objectives.

Student Visits to National Defence Headquarters

In the winter of 2009, students from the Centre d'études des politiques étrangères et de sécurité (CEPES) at Université du Québec à Montréal and Concordia University, from the Research Group in International Security (REGIS) at Université

de Montréal and McGill University and from the Centre for Defence and Security Studies (CDSS) at University of Manitoba participated in a series of briefings by officials at NDHQ on a number of security and defence issues.

In January, students from CEPES and REGIS attended presentations by representatives from the Policy Group on issues such as the Canada First Defence Strategy, Operations in Afghanistan, Diplomacy and Defence, the Security and Defence Forum and the Policy Officer Recruitment Programme. A few weeks later, students from CDSS participated in briefings from representatives of the Policy Group, the Strategic Joint Staff and Canada Command.

n order to promote a Canadian voice and perspective at international conferences, each SDF Centre of Expertise may access the International Conference Fund to facilitate travel by junior faculty and graduate students.

In FY 08-09, the Fund was used 78 times, for a total of \$103,716, and resulted in Canadian scholars being heard in 13 different countries. Details are listed in Appendix D.



ach SDF Centre of Expertise is annually allocated \$5,000 to support travel for senior graduate students and junior faculty to allow them to participate in security and defence-related conferences across Canada.

In all, the NCF was used 64 times, for a total disbursement of \$47,030.




Public Awareness and Communication
