

Wage Settlements Covering 500 or More Employees

February 2010

Major collective bargaining settlements reached in **February 2010** provided base-rate wage adjustments averaging **4.3%** annually over the contract-term, up from 2.6% in January and the 2.4% average for the year 2009.



The relatively high

February wage figure was due in large part to settlements in the Alberta public sector, more specifically within the Alberta education sector; the Alberta education agreements provided 31,680 employees (65% of the monthly employee coverage) with wage adjustments of 6.0% (more precisely 5.99%). This wage increase was calculated based on the year-over-year increase in the Alberta Average Weekly Earnings Index. Excluding the Alberta public sector, the remaining major agreements across Canada recorded an average annual adjustment of 1.8%.

The February results (all sectors) are based on a review of 34 agreements and 56,270 employees. In the previous round of negotiations, the resulting wage adjustments for these February contracts averaged 4.0%, compared to the 4.3% in the current settlements. Contract durations in February averaged 21.9 months compared to 27.3 in their predecessor contracts.



Wage increases for 45,540 public sector employees in 25 agreements in February averaged 4.8%, up from the 2.8% increase in January, and the 2.5% average for the year 2009. The February public-sector results are based on a coverage of 48,540 employees in 25 agreements (86.3% of all employees covered in February's major settlements). Wage adjustments in this sector ranged from 1.9% for 800 employees with the Nova Scotia Association of Health Organizations, to a high of 6.0% for 31,680 teachers, office workers and maintenance employees in 18 agreements in the Alberta education sector.

Private-sector wage adjustments yielded an average increase of 1.1% in February, down from the 2.1% average in January and the average of 1.8% for the year 2009. The February private-sector results are based on a relatively smaller coverage of 11,360 employees in 12 agreements. Private-sector wage adjustments ranged from a 10% cut for 570 mill employees with Corner Brook Pulp and Paper Ltd. in Newfoundland and Labrador (resulting in an average annual adjustment of -6.4% over a 19 month duration), to a high of 3.2% for 500 carpenters with the St. John Construction Association in New Brunswick. Employees (700) with the Alberta Roadbuilders and Heavy Construction Association were subject to a wage freeze in a 2-year contract.

On a regional/jurisdictional basis, wage adjustments ranged from 1.1% in Newfoundland and Labrador to a high of 5.8% in Alberta. The largest concentration of employees covered in February settlements was also in Alberta (42.2% of all employees); many of these employees were in large part within the provincial health and education sectors.

On an industry basis, the largest concentration of employees in February's settlements was in the education, health and social services sector (44,910 employees in 23 agreements); wage adjustments in this industry division averaged 4.8%, the highest figure for all industry sectors this month. The lowest adjustment was recorded in manufacturing at 0.5% (due to the wage cut at Corner Brook Pulp and Paper mentioned above).

Wage adjustments for January and February combined (i.e., first two months in the first quarter of 2010) averaged 3.9% in 47 agreements covering 72,650 employees.

In the following tables, COLA is the abbreviation for Cost-of-Living Allowance.
