

Wage Settlements Covering 500 or More Employees

May 2010

Major collective bargaining settlements reached in May 2010 provided base rate wage increases averaging 2.3% annually over the term of the contracts. These results are based on a review of 21 agreements and cover 47,510 employees.



When the parties to these settlements previously negotiated, the resulting wage adjustments averaged 3.2%, a higher average than in their current settlements. Contract duration in May 2010 averaged 35.3 months, compared to 37.0 months in the previous round of settlements.

There was an increase in settlement activity in the construction sector; 12 agreements (57.1% of all major settlements in May) provided 34,500 employees (72.6%) with a wage adjustment of 2.5%. All the construction agreements were in Ontario.

The majority of agreements and the largest concentration of employees were in the private sector. Private sector wage adjustments averaged 2.4% for 37,750 employees in 15 agreements. Public sector wage adjustments averaged 1.6% for 9,760 employees in 6 agreements.



On an industry basis, the lowest average wage figure was recorded in public administration at 1.2% (3 agreements covering 6,000 employees) and the highest in the finance and professional services sector at 2.7% (2 agreements covering 1,420 employees).

On a jurisdictional basis, the largest average annual wage increase was in Saskatchewan at 3.0% (a single agreement at the University of Regina). The smallest average adjustment recorded was in British Columbia at 0.0% (a single agreement with a wage freeze, the Government of British Columbia (scientific and other professionals)).

In May, 85% of employees received wage increases in the 2.0 to 2.9% range. This was due to the large number of Ontario construction settlements that ranged between 2.2 to 2.9%; 7.2% of employees were subject to a wage freeze (3 agreements including the Municipal Property Assessment Corporation in Ontario, the Government of British Columbia (scientific and other professionals), and in the federal jurisdiction, Servisair Inc. (aircraft maintenance) at the Lester B. Pearson International Airport in Toronto; 2.4% of employees received wage adjustments in the 1.0 to 1.9% range and 5.1% of employees received wage gains of 3.0% and over.

Wage increases in the first 5 months of 2010 (January through May) averaged 2.1% for 317,620 employees in 121 major settlements.

In the following tables, COLA is the abbreviation for Cost-of-Living Allowance.
