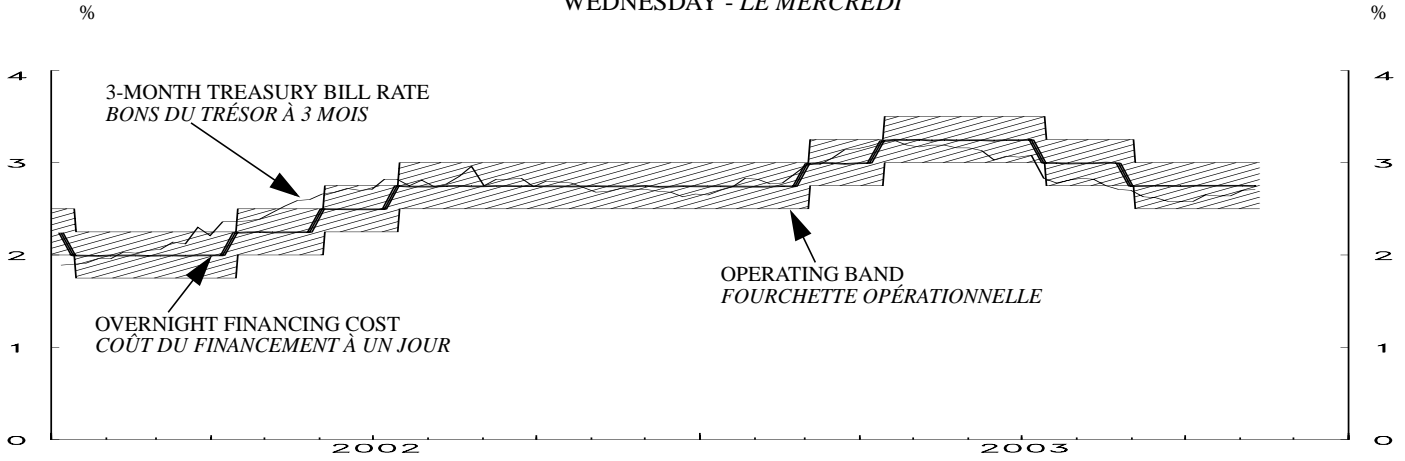

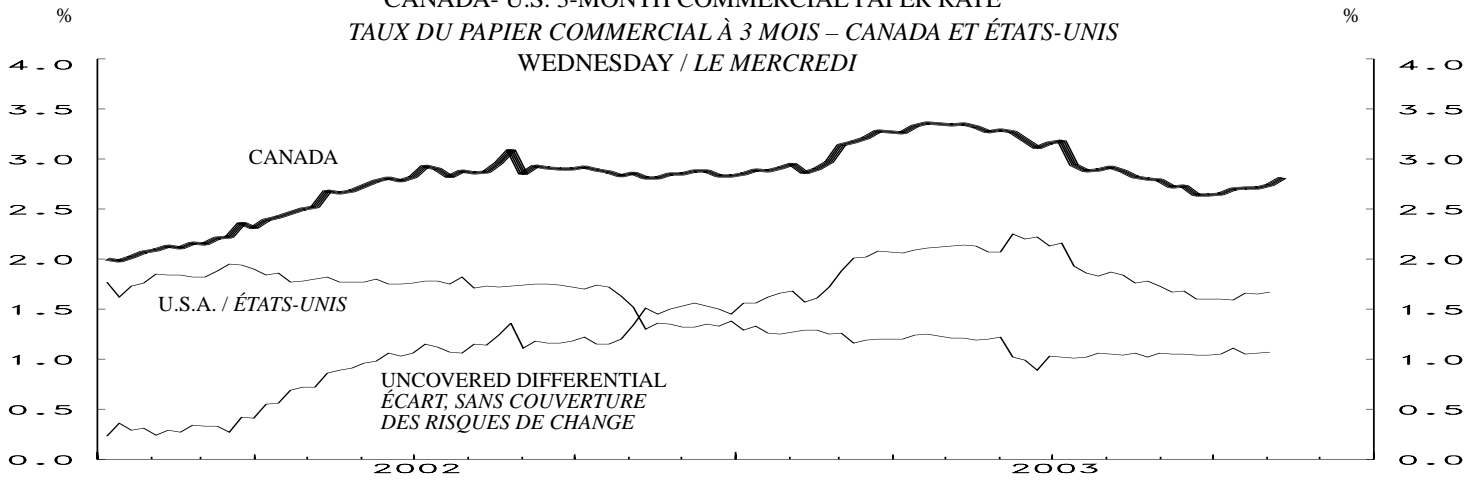

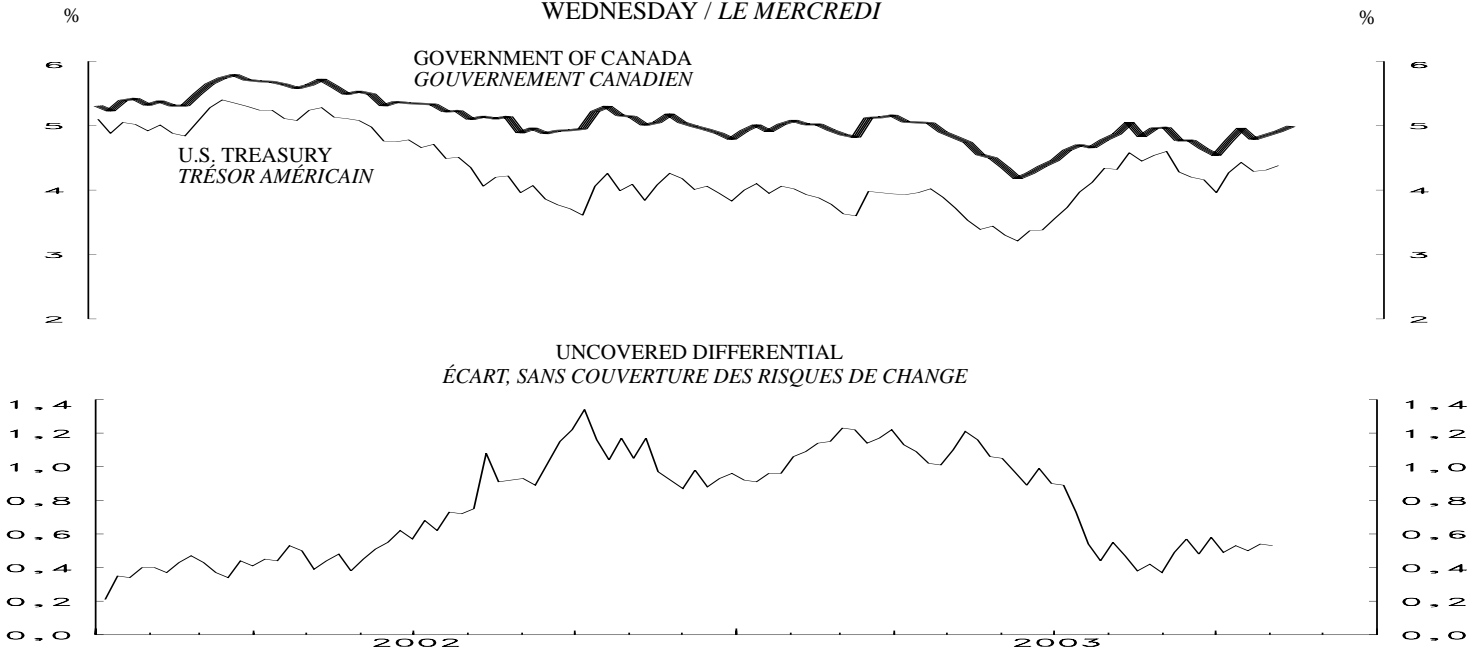
3-MONTH TREASURY BILL RATE AND OVERNIGHT FINANCING COST

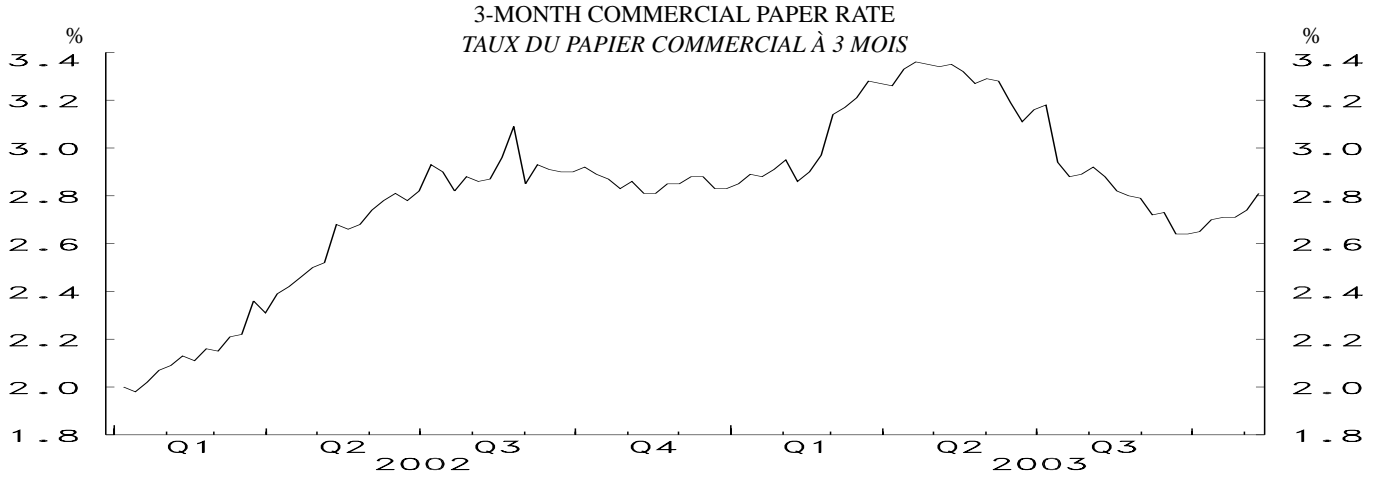
CANADA- U.S. 3-MONTH COMMERCIAL PAPER RATE

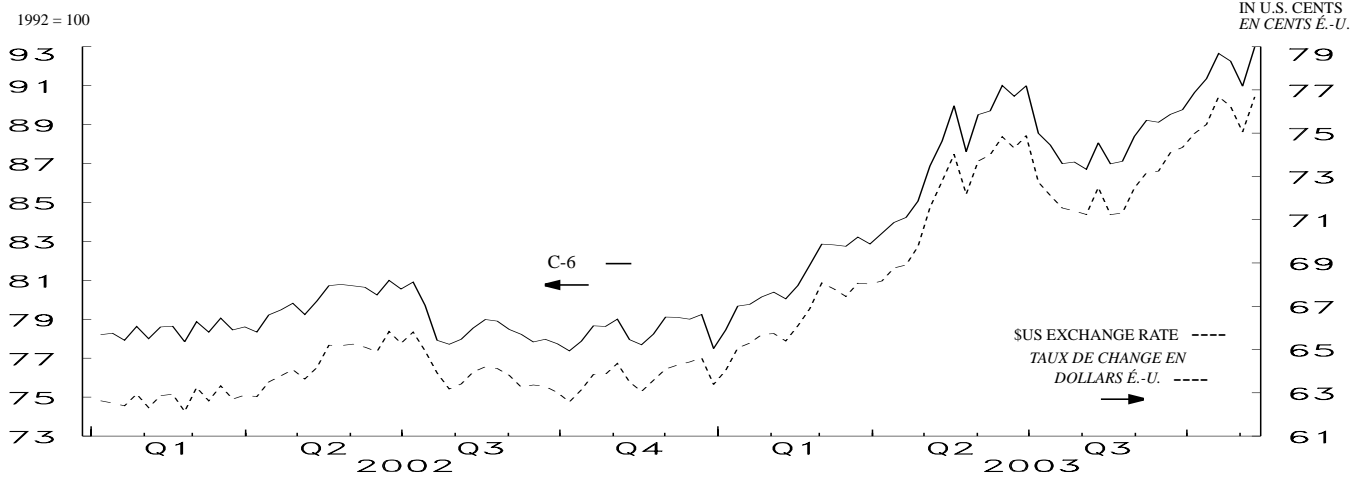

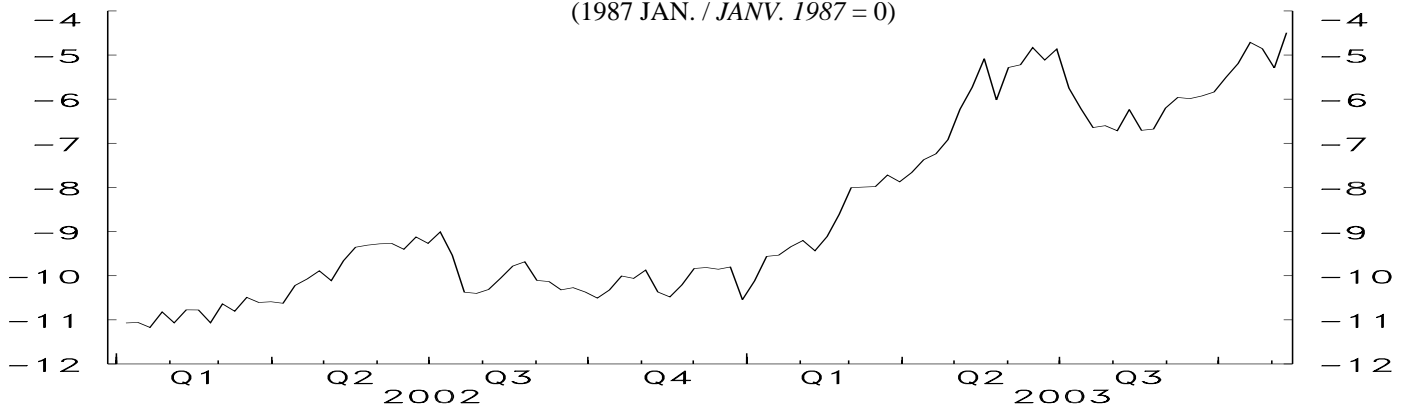
C-6 EXCHANGE RATE INDEX AND \$U.S. EXCHANGE RATE

(1987 JAN. / JANV. 1987 = 0)

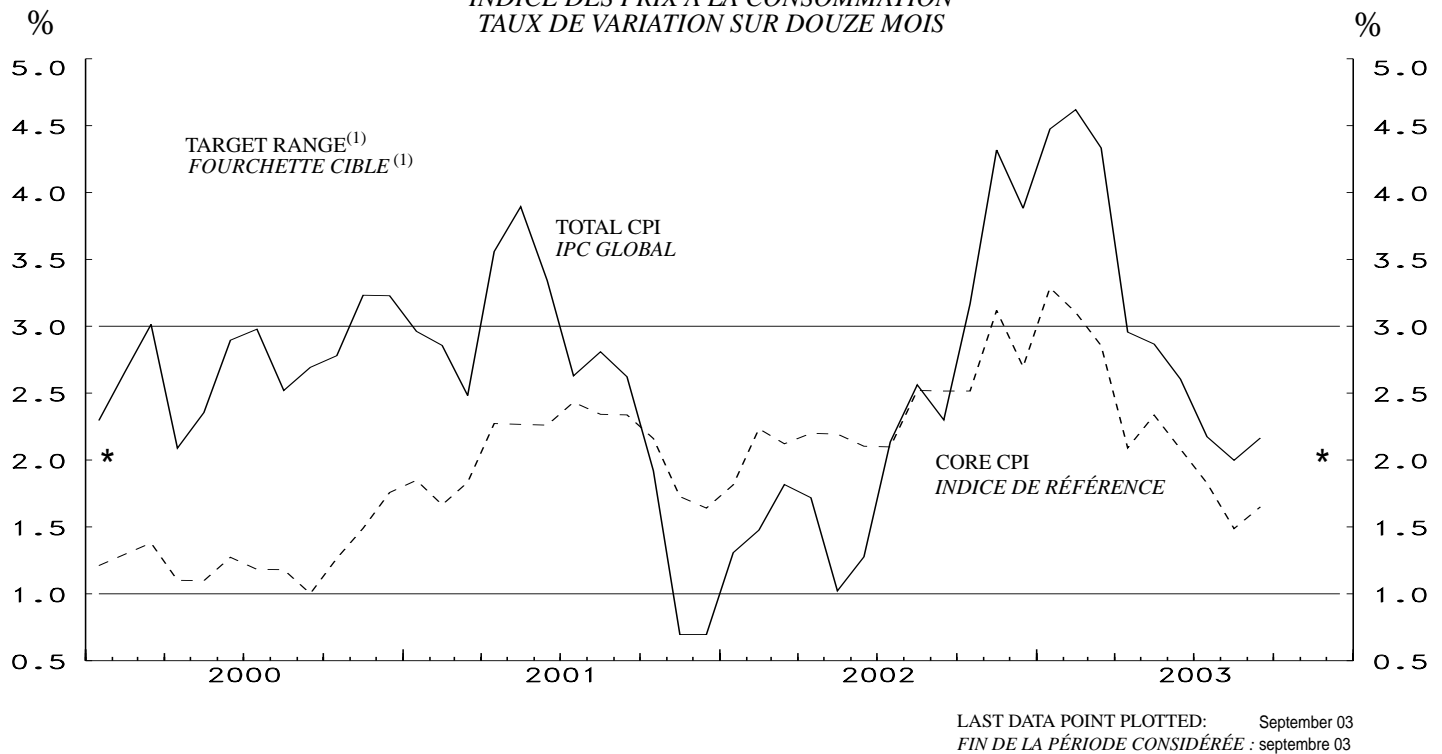
