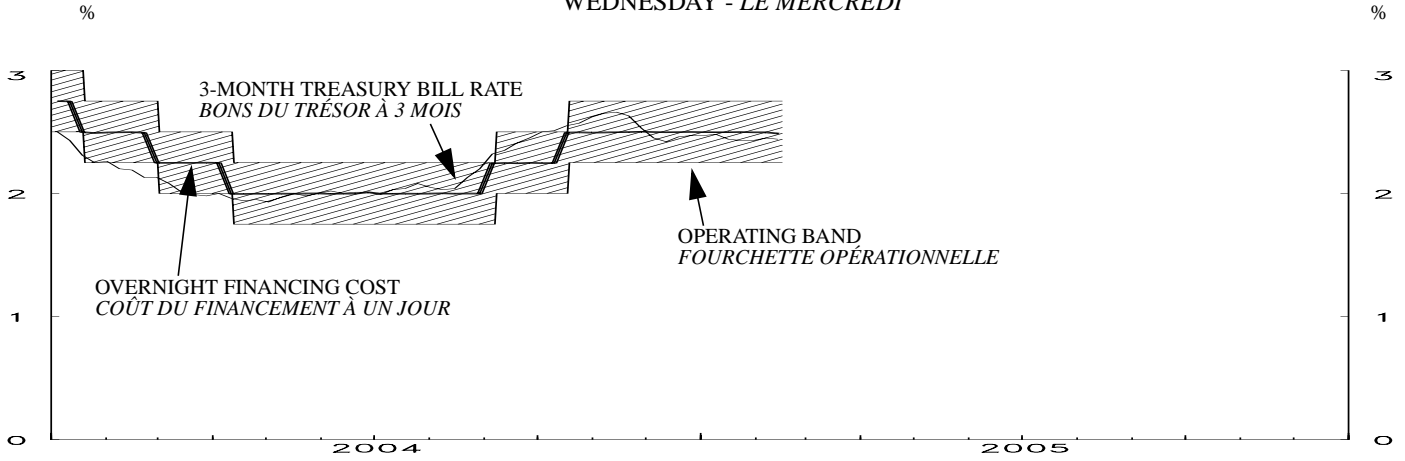

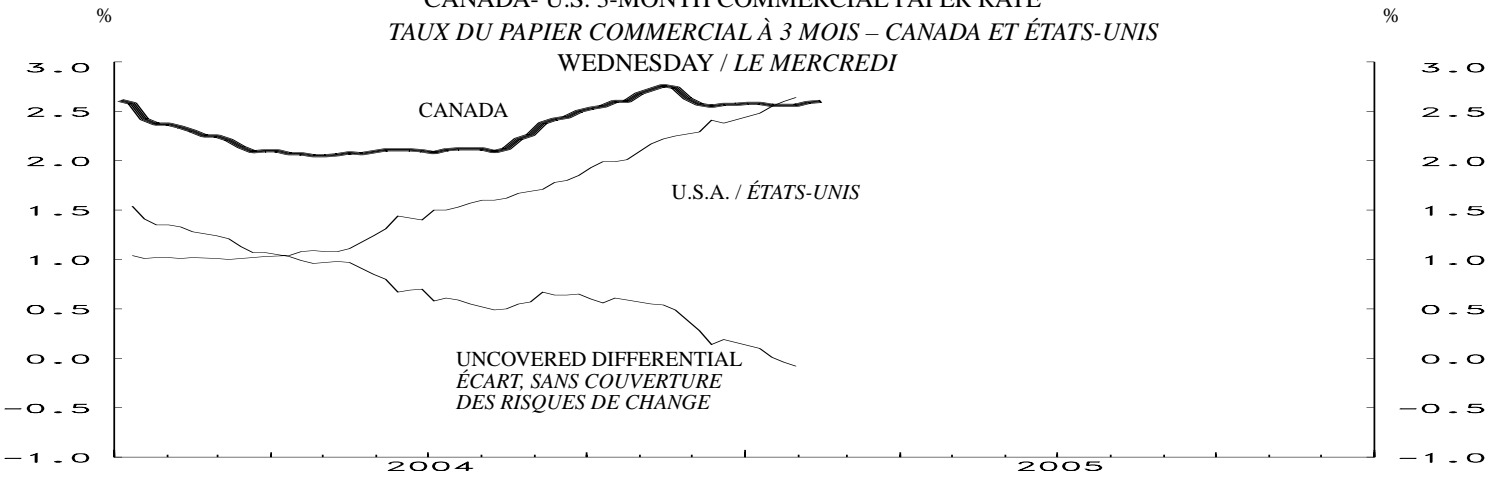

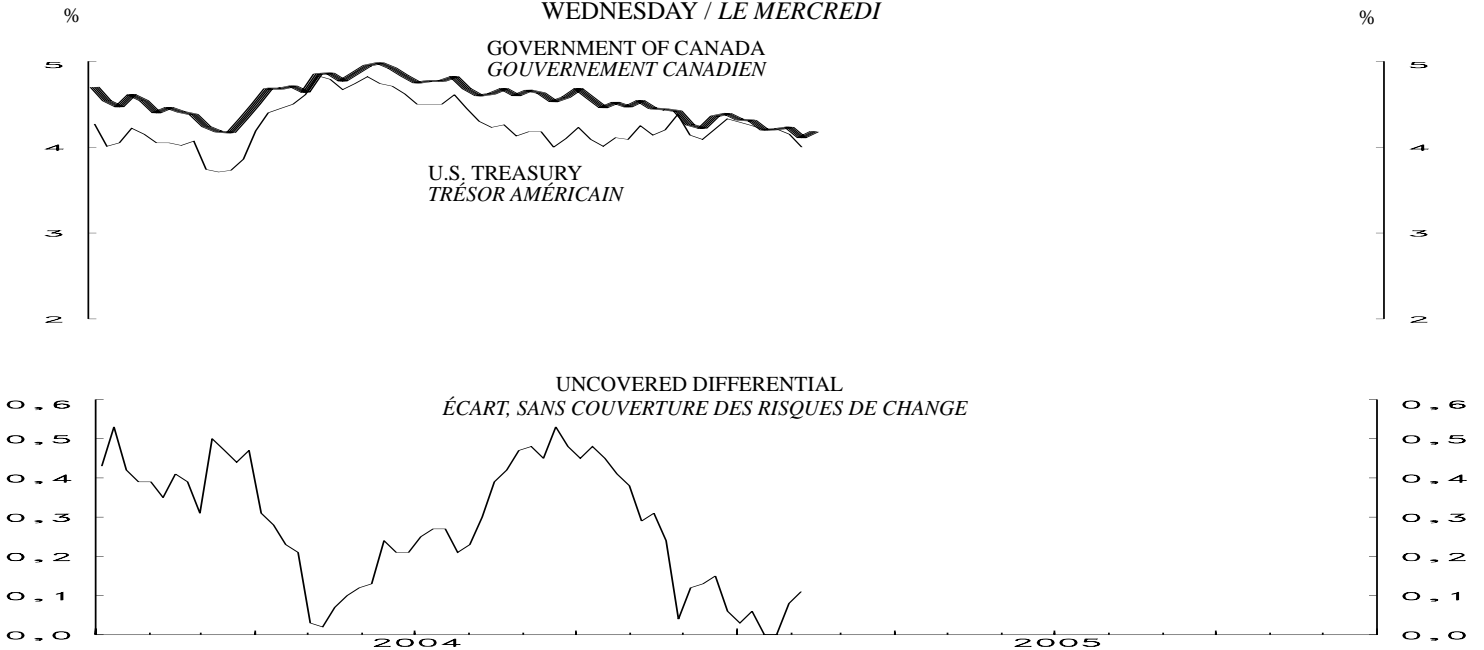
3-MONTH TREASURY BILL RATE AND OVERNIGHT FINANCING COST

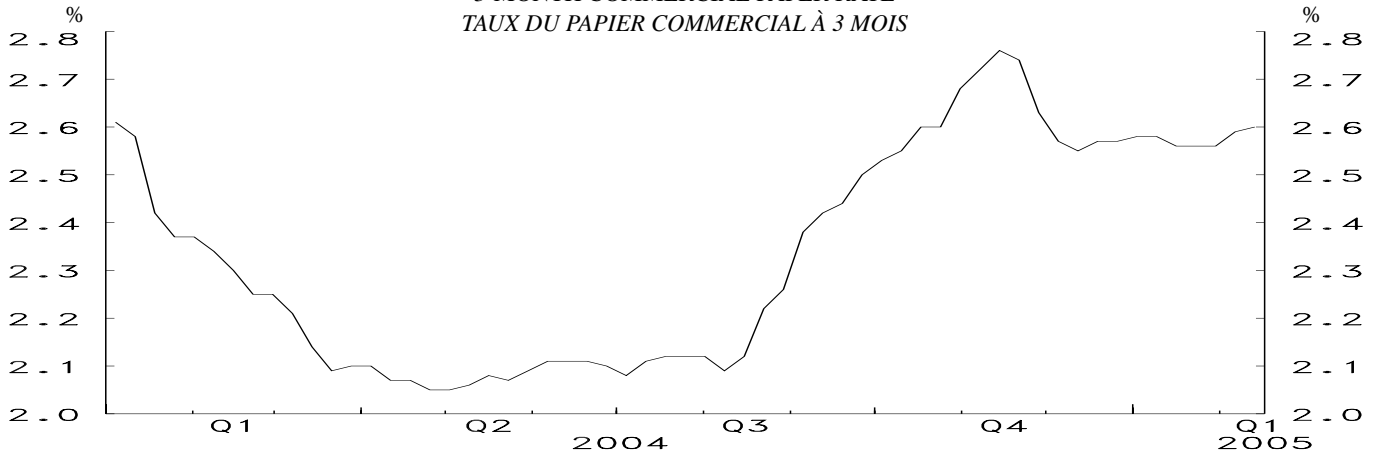


CANADA- U.S. GOVERNMENT 10 YEAR BOND YIELDS

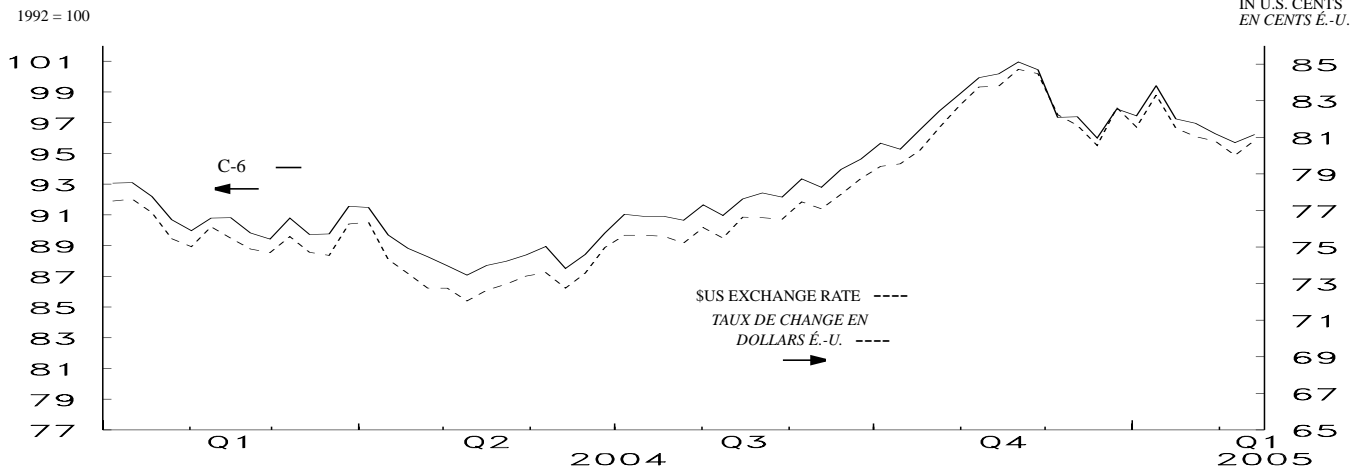

TAUX DU PAPIER COMMERCIAL À 3 MOIS



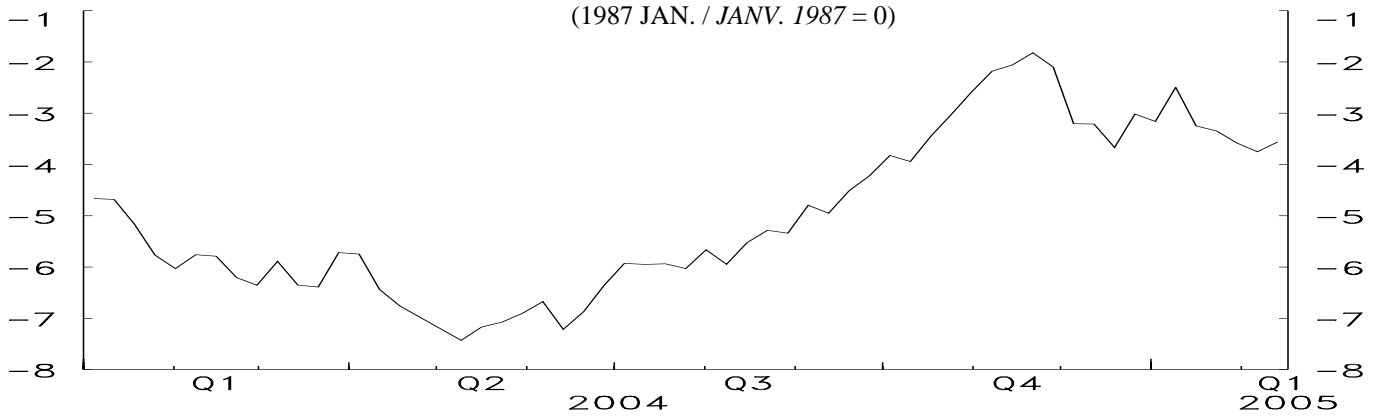
C-6 EXCHANGE RATE INDEX AND \$U.S. EXCHANGE RATE

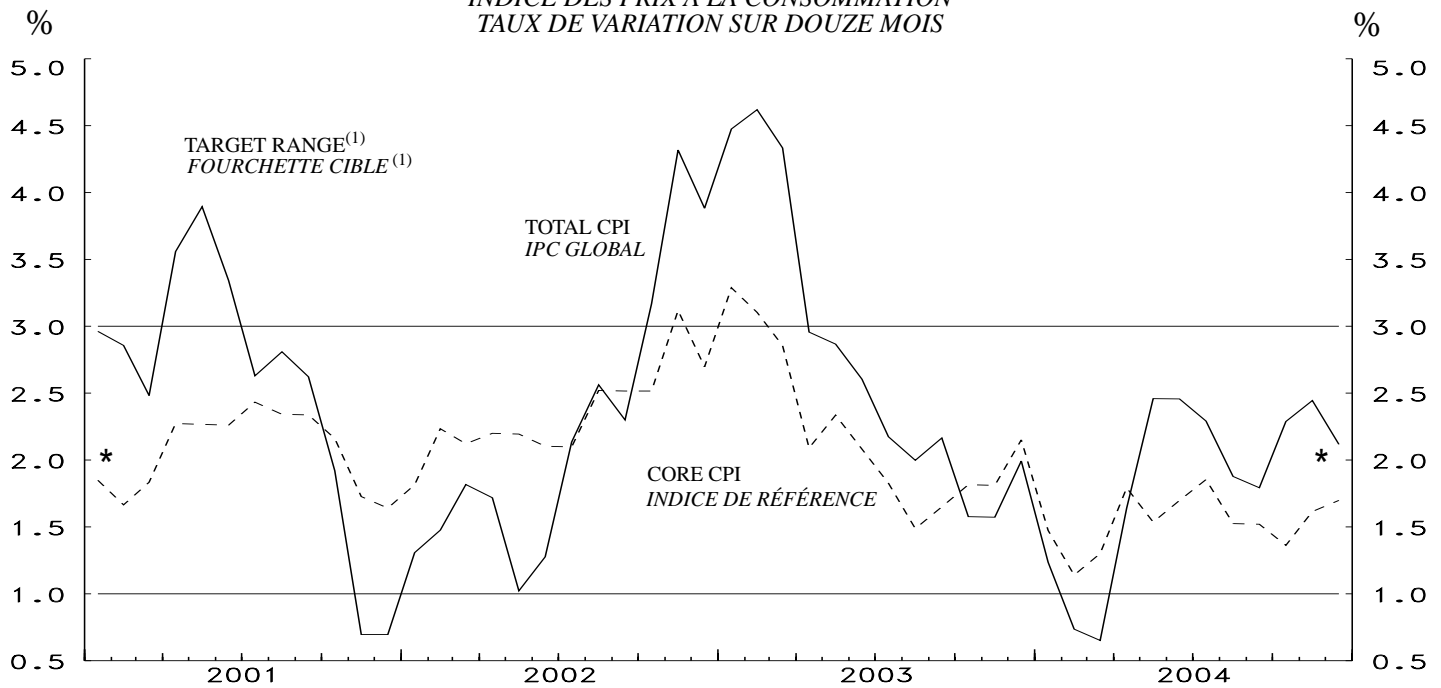
