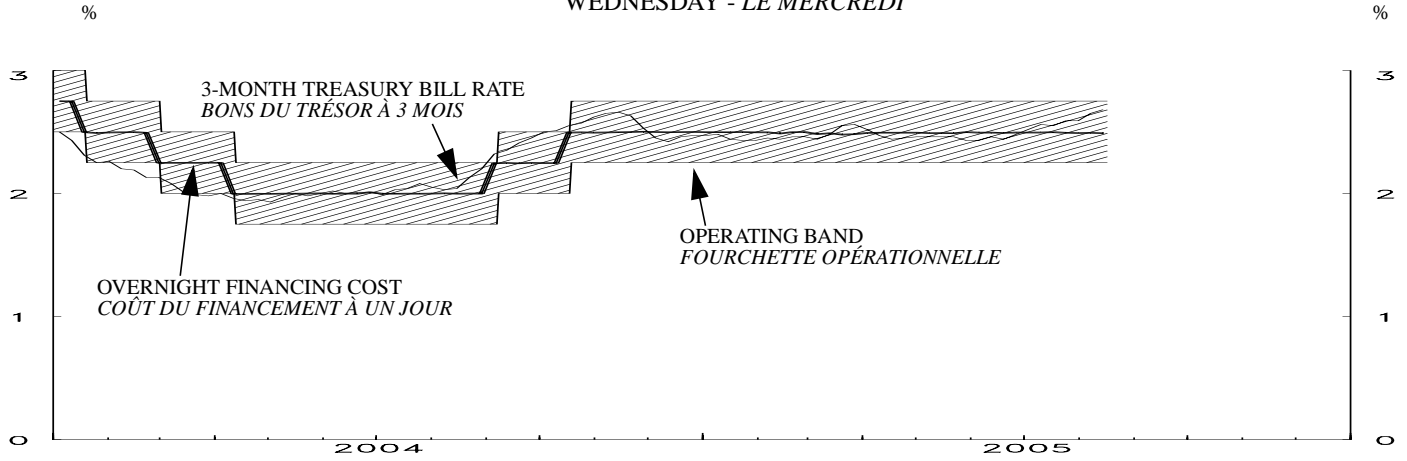

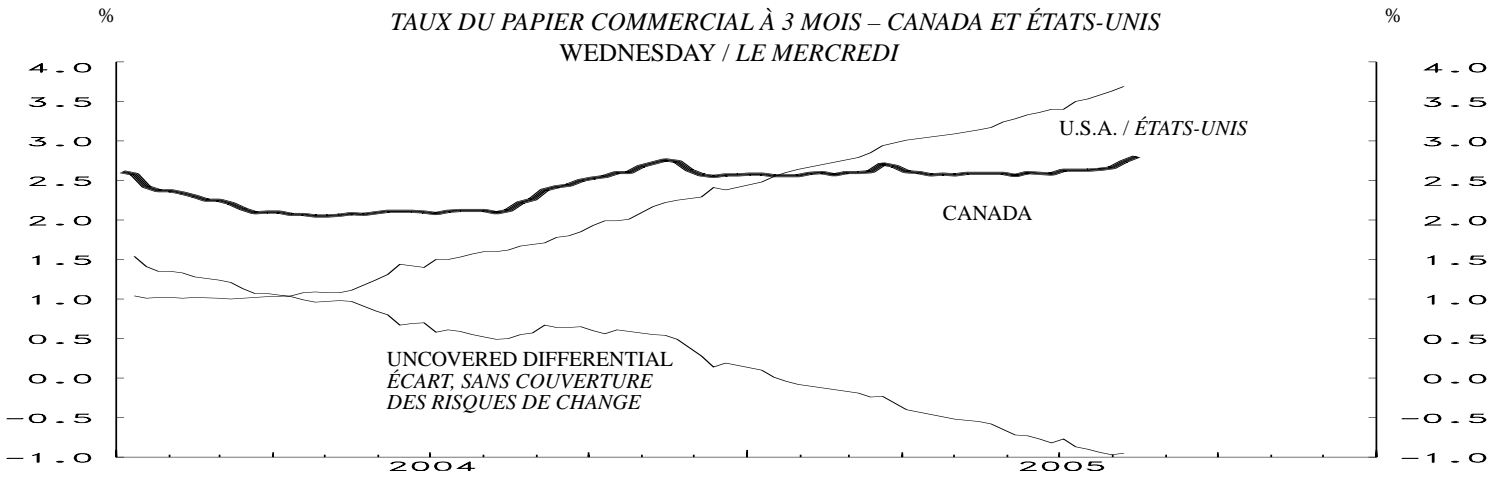

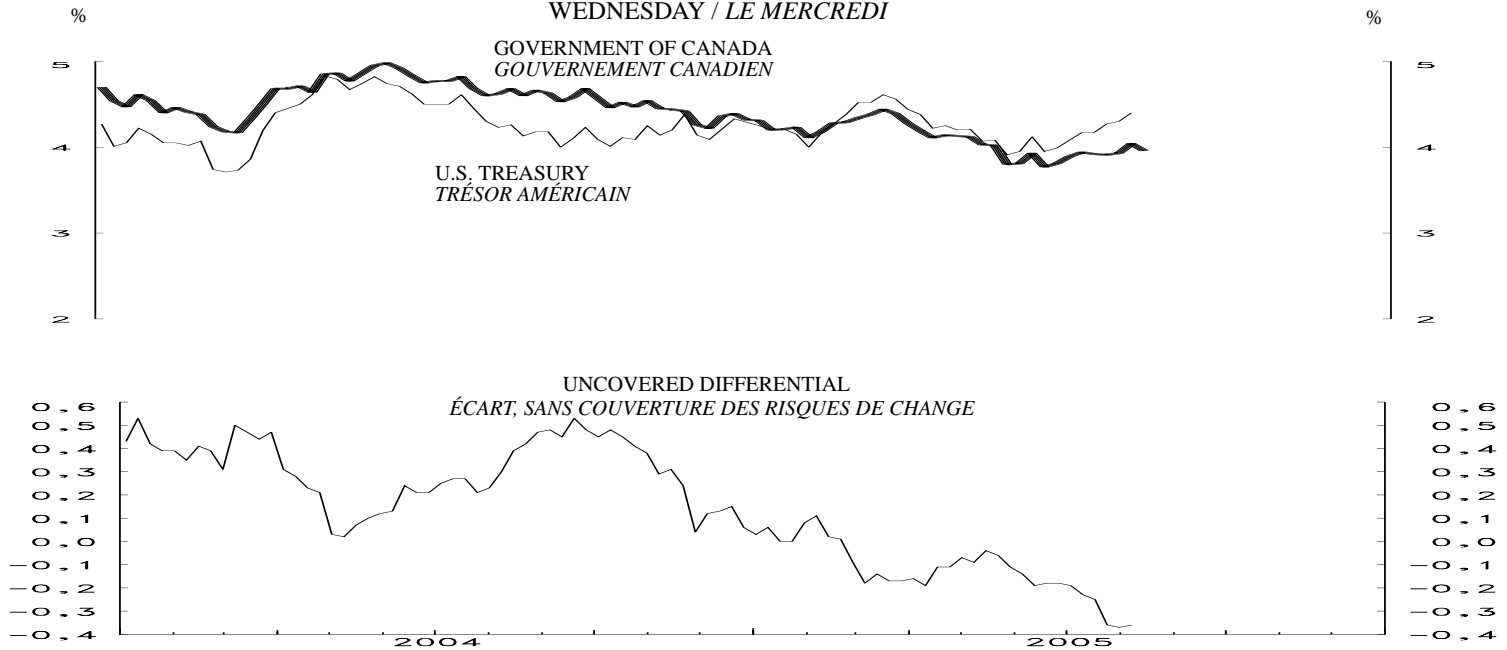
3-MONTH TREASURY BILL RATE AND OVERNIGHT FINANCING COST

 WEDNESDAY / LE MERCREDI

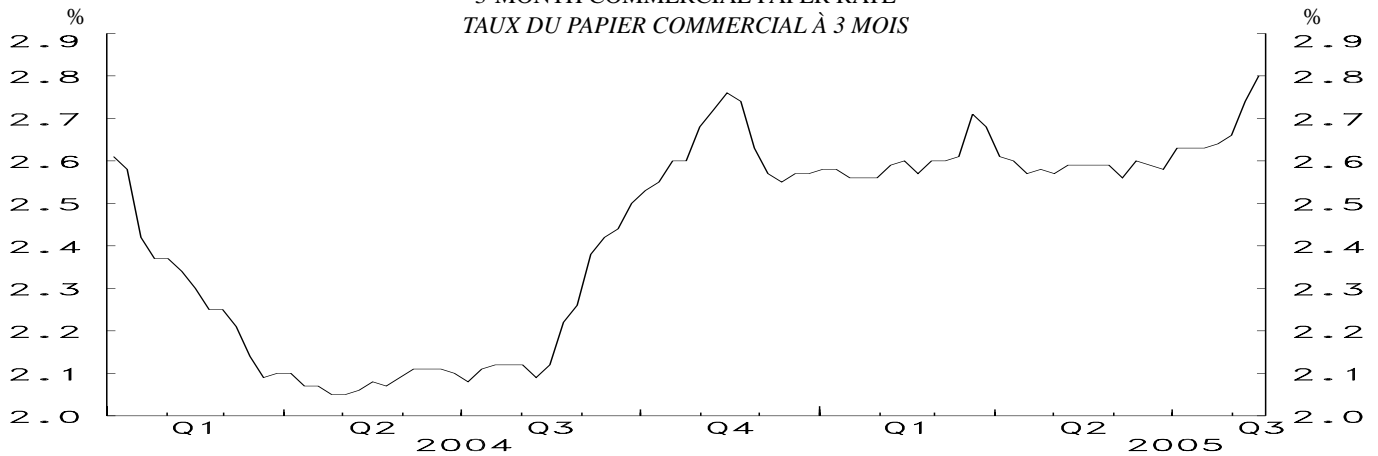


CANADA- U.S. GOVERNMENT 10 YEAR BOND YIELDS

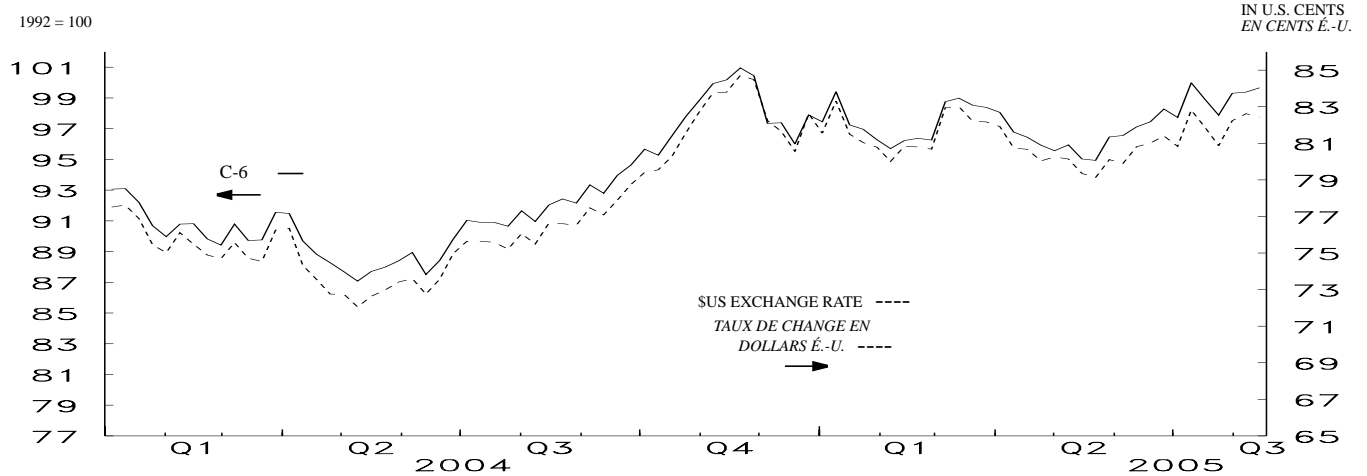

*TAUX DU PAPIER COMMERCIAL À 3 MOIS*



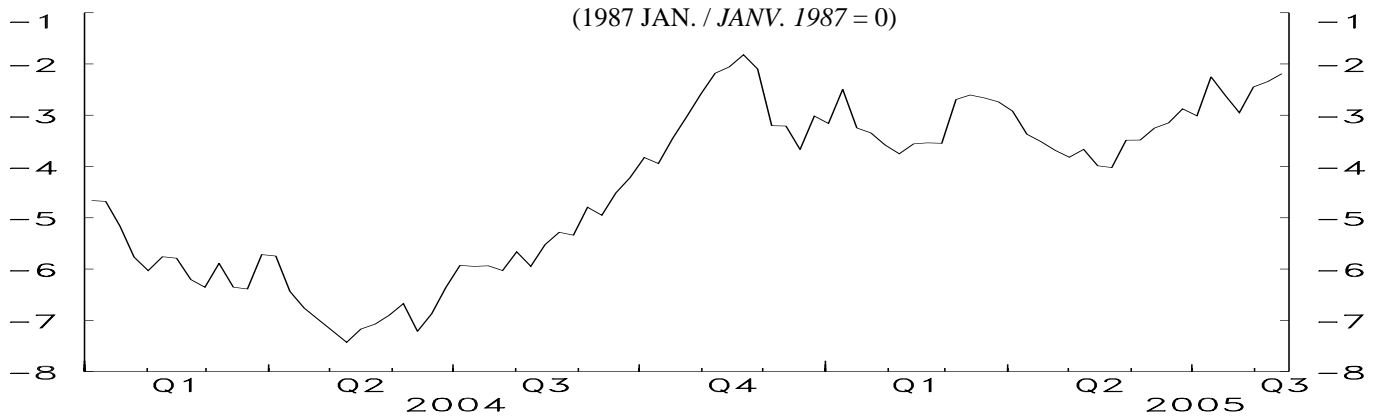
C-6 EXCHANGE RATE INDEX AND \$U.S. EXCHANGE RATE

(1987 JAN. / JANV. 1987 = 0)

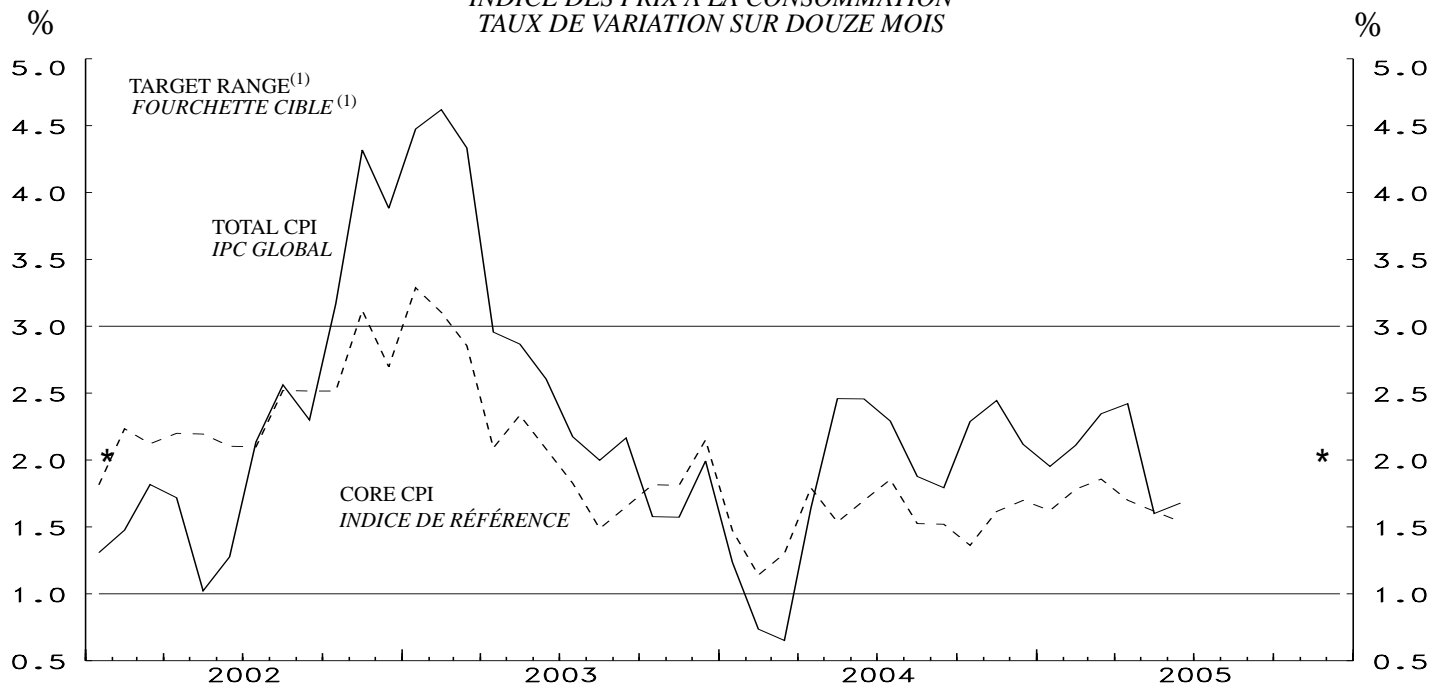
