URMULE UPDATE

User Requested Minor Use Label Expansion (URMULE) - registrations March 1, 1998 - April 30, 1998

The **URMULE Update** provides timely information on the latest proposals for minor use label expansion of pesticides that have been evaluated and accepted for registration.

For the following pesticides, a Certificate of Registration has been issued based on a Supplemental Label, making the use legal. Registrants are required to add the new use to the full product label at the next printing. Provincial authorities, in publishing recommendations on the use of agricultural chemicals, may incorporate such acceptable uses in the knowledge that they meet the requirements of the *Pest Control Products Act*.

Mineral Oil (Superior 70 Oil - United Agri Products), registration number 14981 for the control of lecanium scale on highbush blueberry

Mineral Oil (Dormant Spray Oil - United Agri Products), registration number 16211 for the control of lecanium scale on highbush blueberry.

Hexazinone (Velpar L Herbicide - DuPont), registration number 18197 for weed control on lowbush blueberry in the Maritime Provinces - New Brunswick, Prince Edward Island, Nova Scotia.

Clopyralid (**Lontrel 360 - Dow Agrosciences**), registration number 23545 for the control of perennial vetch in cranberry applied as a wipe-on treatment.

Vegetables

Bromoxynil (Pardner - Rhone-Poulenc), registration number 18001 for weed control on garlic.

Cyhalothrin-lambda (**Matador - Zeneca**), registration number 24984 for the control of insect pests on head lettuce.

Tralkoxydim (Achieve 80Dg - Zeneca), registation number 24117 for weed control on seedling timothy grown for seed production.

CEREAL CROPS AND PRODUCTS

Clopyralid/MCPA (**Curtail M - Dow Agrosciences**), registration number 22764 for weed control in wheat, oats and barley in the Okanagan and Creston Flats regions of British Columbia.

FIELD CROPS

Nicosulfuron (**Accent Herbicide - DuPont**), registration number 25116 for weed control on field corn in Western Canada - Manitoba, Saskatchewan, Alberta and British Columbia.

SPECIALTY CROPS

Glyphosate (**Touchdown - Zeneca**), registration number 23971 for annual and perennial weed control in North American ginseng

Diazinon (Diazinon - United Agri Products) , registration number 19576 for the control of pavement antion flue-cured tobacco seed/seedling in greenhouses.
OTHER CROPS
Fluazifop-p-butyl (Fusilade II - Zeneca), registration number 21209 for the control of labelled grass weeds in poplars.
