

I. Introduction to the Relationship to Person 1 Coding Manual

This Coding Manual has been written to assist you in understanding the Relationship to Person 1 variable.

Throughout this Coding Manual you will find procedures which will permit you to understand coding Relationship to Person 1 responses.

Once you have read all the procedures, you will participate in a group discussion with your trainer.

II. The Relationship to Person 1 Question

The Relationship to Person 1 (R2P1) question on the 1996 census questionnaire gathers information to be processed and used in the production of a wide variety of statistics, profiling both Canada as a country and Canadians as people.

The Relationship to Person 1 question is Question 2 on the 2A (short questionnaire), 2B (long questionnaire), 2C, 2D and 3 forms. Only the responses from the 2B, 2C, 2D and forms 3 questionnaires will be coded. This question was created so that we can learn more about family size, the number of children living with one parent and the number of people living alone, etc.. This information is used for planning programs, such as the Old Age Security and the Child Tax Benefit. It is also used by towns and cities to plan for day care centres, schools and senior citizens homes.

Information from the Relationship to Person 1 question, in conjunction with the responses to the questions on date of birth, sex, marital status and common-law status, will be used to determine whether a person is a member of a family group.

When answering the following question, respondents were asked to mark the circle corresponding to the response which best characterizes the relationship of each household member to the first enumerated person (Person 1).

For each person usually living here, describe his/her relationship to Person 1. Mark or specify one response only. Stepchildren, adopted children and children of a common-law partner should be considered sons and daughters. If none of the choices apply, use the "Other" box to indicate this person's relationship

If a person in the household has a relationship to Person 1 other than one of the check box responses, the respondent must write the relationship in the space provided on the questionnaire (write-in box 14). Throughout this manual we will refer to the write-in response simply as the response.


Your responsibility is to code these responses using the R2P1 Interactive Coding System. This Coding Manual will show you how to code the various categories of responses.


III. Two types of Households

As a coder for the Relationship to Person 1 variable, you will be asked to code responses from two types of households: private and collective households.

When using the R2P1 Interactive Coding System, the top portion of the screen will identify which type of household you are coding. For private households the screen will appear as follows:



For collective households the screen will identify the type of collective household you are coding:



A. Private Household

A private household refers to a household occupied by a person or a group of persons. It may consist of:

- a family group with or without other non-family persons;
- two or more families sharing a dwelling;
- a group of unrelated persons; or
- one person living alone.

B. Collective Household

The term collective household refers to a household of a commercial, communal, institutional, or military nature identified by a sign on the premises or by a census representative speaking with the person in charge, with a resident or a neighbour, etc, and where residents do not have a usual place of residence elsewhere in Canada.

The following is a list of all collective household types you will find listed on the R2P1 Interactive Coding System.



IV. Standard Coding Procedures

When coding, no matter what type of household or response the system generates, you will be asked to use the following Standard Coding Procedures.


The following screen will be used to explain the Standard Coding Procedures.



- 1. Identify the type of household by looking in the Household type box.
- 2. Identify which person(s) in the household has a "Must code" in the status box.
- 3. Examine the reported Relationship to Person 1, for each person where a status of "Must code" is identified.

If the household has more than 6 people, click on the **Bosument** button to move to the subsequent document(s).

4. For each response with a status of "Must code", click on the arrow beside the text box and select the appropriate description for the response, from the displayed code set. Refer to Appendix 1 for the complete code set in numeric order or to Appendix 2 for the complete code set in alphabetic order for private and collective households.



5. When all responses in the household have a status of "Coded" or "Referred", save your household by clicking on the button, and clicking on OK in the "SAVE HOUSEHOLD" confirmation box. The default for this window is set to "Save, apply edits and display errors".


6. If the chosen codes are accepted, the R2P1 Interactive Coding System will automatically give you a new household to code. If one or more chosen codes are incorrect, the system will identify this by showing you the following screen:

The "LIST OF ERRORS FROM EDITS" screen produces a message describing what was not accepted. This message can guide you in choosing a new description from the code set.

The function opens a window which can also help you find the closest match from the reference file. Refer to Appendix 3 for the private households reference file and to Appendix 4 for the collective households reference file.


7. Once you have selected a new code from the code set or determined that the initial code you had selected was correct, save the household. In the "SAVE HOUSEHOLD" confirmation box, click on the second option, "Save, apply edits and find another household" and press OK. The system will automatically give you a new household to code.



8. If you think that no description from the displayed code set can be used to code the response, refer the household by using the coded by using the button from the status box.

Throughout the manual, each time the procedures ask to refer a response you must select "Requires SM attention" from the confirm referral window. If you refer a response for any other reason (not a reason marked in this manual) then you must select "Interactive choice" from the confirm referral window.



You can refer to the R2P1 User Guide for more detailed instructions on the different functions of the R2P1 Interactive System.

V. Coding Private Household Responses

This chapter will show you how to code the different categories of responses the R2P1 Interactive Coding System will generate for private households.

a. Coding Common-law Relationships

The term Common-law Relationship is viewed as describing a consensual union or a living arrangement in which two persons who are not legally married to each other, live together in the same household as husband and wife. Persons reported as common-law partners cannot be of the same sex. The edit rule also requires that these persons be at least 15 years of age.

Do not assume that a common-law relationship exists in every situation where a man and a women who are not married share the same living quarters.

However, if the respondent indicates one of the following responses:

▲ living together / vivre ensemble;

living with (name of other person in household of the opposite sex) / vivre avec (le nom d'une autre personne de sexe opposé dans le ménage);

consensual union / union consensuelle;

boyfriend/girlfriend / ami(e) de coeur, chum/blonde;

lover / amant, amoureux;

significant other / douce moitié;

you must apply the following conditions and actions:

<u>Conditions</u>	<u>Actions</u>
If the response to common-law for both persons (respondent and Person 1) is "Yes", and the responses to sex are opposite, that is to say, male and female,	then select "Common-law partner" from the code set.
If the response to common-law for both persons is "Yes", and the responses to sex are the same,	then REFER THE HOUSEHOLD TO EXPERT CODER.
If either person has responded "Yes" to common- law, and the responses to sex are the same,	then select "Room-mate" from the code set.
If both persons have responded "No" to common- law, and are of opposite sex,	then REFER THE HOUSEHOLD TO EXPERT CODER.
If both persons have responded "No" to common- law, and are of the same sex,	then REFER THE HOUSEHOLD TO EXPERT CODER.

In any of the above situations, if the action to take is unclear, REFER THE HOUSEHOLD TO THE EXPERT CODER.

If the respondent indicates one of the following responses you must REFER THE HOUSEHOLD TO THE EXPERT CODER.

partner / partenaire

Note: A response of "Partner" in a Hutterite household (collective household) will be coded to "Hutterite". For all other responses, REFER THE HOUSEHOLD TO THE EXPERT CODER.

b. Coding Step Relationships

Several types of Step Relationships can exist: step-children, step-parent and step-relative.

For Step Relationships you must apply certain conditions and actions, which are:

Conditions	Actions
If the response is Stepson / Stepdaughter of person 1,	then select "Stepson" / "Stepdaughter" from the code set.
If the response is any other step relationship,	then REFER THE HOUSEHOLD TO EXPERT CODER.

Coding Responses of "Father-in-law"/"Mother-in-law" c.

You must refer all responses of "Father-in-law"/"Mother-in-law" TO THE EXPERT CODER.

Coding responses of "Beau-père"/"belle-mère" or "beau-fils"/"belle-fille" d.

You must refer all responses of "Beau-père"/"belle-mère" or "beau-fils"/"belle-fille" TO THE EXPERT CODER.

e. Coding responses of "Son-in-law" or "daughter-in-law"

To code responses of "Son-in-law" or "daughter-in-law" you must apply certain conditions and actions, which are:

Conditions	Actions
If the response is Son-in-law / Daughter-in-law of person 1,	then select "Son-in-law" / "Daughter-in-law" from the code set.
If the response is Gendre / Bru of person 1,	then select "Son-in-law" / "Daughter-in-law" from the code set.
For all other situations,	REFER THE HOUSEHOLD TO THE EXPERT CODER.

f. Coding Responses of "Husband/Wife of Brother/Sister-in-law"

When coding responses of "Husband/Wife of Brother/Sister-in-law", select "Husband/Wife of Brother/Sister-in-law" from the code set.

g. Coding Responses of Room-mate and Lodger/Boarder

When a respondent reports a relationship which indicates the sharing of living quarters (sharing expenses), or a business partnership, (such as co-owner, housemate) the response should be considered to be "Room-mate" unless a common-law partnership is indicated. Tenants, boarders, godchildren and wards are regarded as Lodgers.

When coding "Room-mate" and "Lodger/Boarder" responses apply the conditions and actions below:

Conditions	Actions
If the response is Co-owner, Housemate or Roommate of Person 1,	then select "Room-mate" from the code set.
If the response is Tenant , Boarder , Godchild , Ward of Person 1,	then select "Lodger/Boarder" from the code set.
If the response is Foster child of Person 1,	then select "Foster child" from the code set.

h. Coding Responses of Landlord and Owner

When coding any responses of Landlord, Owner, Home owner or Owner of the household, select "Owner" from the code set.

i. Coding Responses of Employee

When coding responses of "Employee" apply the conditions and actions below:

Conditions	Actions
Conditions	Actions
If the response is Housekeeper, Baby sitter, Live- in nurse, of Person 1,	then select "Employee" from the code set.
If the response is Husband, Wife, Common-law partner, Son or Daughter, Step-son or Daughter of an employee of Person 1,	then select "Employee's husband/wife", "Employee's common-law partner", "Employee's son/daughter" or "Employee's step son/daughter" accordingly from the code set.
If the response is any other relationship to an employee, such as employee's father, employee's cousin etc.,	then select "Lodger/Boarder" from the code set.

j. Coding Relationships Reported to Someone Other than Person 1

If a household member reported a relationship to someone other than Person 1 (ie. child of Person 2), you should first determine the relationship of the individual to person 1 and then code the reported relationship appropriately.

Appendix 5 - R2P1 Deterministic Response Table, gives you a relationship reported to someone other than Person 1 resolution chart. This chart will help you find the code for response(s) reported to someone other than Person 1. Use the example below and Appendix 5:

Pers	on# Response	Age	Sex	Status
1	Person 1	68	M	coded
2	Wife	66	F	coded
3	Grandchild	15	M	coded
4	Sister of Person 3	13	F	must be coded

In Appendix 5, look for the must be coded responses of Person 4 (Sister) under the Reported Relationships column. Then, under the Target Member column look for the response provided by Person 3 (Grandchild). The Assign Value column in the table indicates that Person 4 should be coded to "Grandchild".

Here is an other example of a relationship reported to someone other than Person 1.

Pers	on# Response	Age	Sex	<u>Status</u>
1	Person 1	78	M	coded
2	Daughter	38	F	coded
3	Daughter of Person 2	15	F	must be coded

In Appendix 5, look for the must be coded responses of Person 3 (Daughter) under the Reported Relationships column. Then, under the Target Member column look for the response provided by Person 2 (Daughter). The Assign Value column in the table indicates that Person 3 should be coded to "Grandchild".

k. Coding Inverted Relationships

Inverted relationships are cases where the reported Relationship to Person 1 is the Relationship of Person 1 towards another member of the household, rather than the individual's relationship to Person 1. An example of an inverted relationship, for one or several members of the household, is when the relationship is reported as father/mother, when son/daughter should have been reported. The more logical relationship would be father/mother since there are usually more sons/daughters in a household than there are fathers/mothers. When coding inverted relationship you must code the reported relationship. This situation will be corrected later in the processing of the data. The following is an example of an inverted relationship.

Pers	on# Response	Age	Sex	Expected Relationship
1	Person 1	38	M	Person 1
2	Wife	36	F	Wife
3	Father	15	M	Son

For Person 3, in this example, the relationship of Person 1 toward Person 3 was reported; Person 1 is the Father of Person 3 and Person 3 is the Son of Person 1. However, when coding this response you select "Father" from the code set, since the procedures for Inverted Relationships is to code the response reported by the respondent.

I. Coding Misspelled Responses

If you can make sense of a Misspelled Response, follow the appropriate coding instructions.

m. Coding Abbreviated Responses

If you know the long form of an Abbreviated Response, follow the appropriate coding instructions.

n. Coding Multiple Responses

A Multiple Response is when more than one response is found in a "Must be coded" response space. Multiple check boxes are not considered as Multiple Responses and must be ignored by the coder.

For all Multiple Responses to be coded, REFER THE HOUSEHOLD TO THE EXPERT CODER.

o. Coding Responses of Same/Same as

Same/Same as responses, such as in the following example are to be REFERRED TO THE EXPERT CODING.

Pers	son# Response	Age	<u>Sex</u>
1	Person 1	38	F
2	Friend	36	F
3	same	35	F
4	same	33	F

p. Coding Other Categories of Responses

- For any Other Relative Responses (ie: great-grand parents) to be coded, REFER THE HOUSEHOLD TO THE EXPERT CODER.
- For any Gay Living Arrangement Responses to be coded, REFER THE HOUSEHOLD TO THE EXPERT CODER.

If the exact relationship cannot be determined; or if the response is either not legible or is in a language other than French or English, REFER THE HOUSEHOLD TO THE EXPERT CODER.

VI. Coding Collective Household Responses

The overall approach when coding relationships in collective households is similar to that of private households. Most collective households do not have a Person 1. The responses in a collective household refer to the status of the person in the household. Therefore, you will encounter certain responses and situations which are unique to collective households. Collective households may present certain relationships which are not encountered in private households (ie: resident, inmate, patient, nun, etc).

When coding relationships in collective households you must first identify, on the screen, which type of collective household you are dealing with. The instructions found within this section will help you to code responses in these household types.

a. To code responses within:

- hotels, motels and tourist homes;
- lodging and rooming houses;
- school residences and residences for training centres;
- YMCA/YWCAs, missions and hostels;
- campground and parks;

you must apply the following conditions and actions:

Conditions

If the response is Employee,

If the response is Husband, Wife, Common-law partner, Son or Daughter, Step-son or Daughter of an employee,

If the response is Owner or Manager,

If the response is Husband, Wife, Common-law partner, Son or Daughter, Step-son or Daughter of the owner,

Actions

then select "Employee" from the code set.

then select "Employee's husband/wife", "Employee's common-law partner", "Employee's son/daughter" or "Employee's step son/daughter" accordingly from the code set.

then select "Owner/Manager" from the code set.

then select "Owner/Manager's husband/wife", "Owner/Manager's common-law partner", "Owner/Manager's son/daughter" or "Owner/Manager's step son/daughter" accordingly from the code set.

b. To code responses within:

- work camps;
- religious institutions;
- military camps;

you must apply the following conditions and actions:

Conditions

If the response is Employee,

If the response is Employee's husband, Employee's wife, Employee's common-law partner, Employee's son or daughter, or Employee's stepson or daughter,

Actions

then select "Employee" from the code set.

then select "Employee's husband/wife", "Employee's common-law partner", "Employee's son/daughter" or "Employee's step son/daughter" accordingly from the code set.

c. To code responses within:

- chronic care hospitals;
- hospitals;
- psychiatric institutions;
- treatment centres and institutions;
- nursing homes;
- correctional and penal institutions;
- young offenders' facilities;
- iails:
- residences for senior citizens;
- orphanages

you must apply the following conditions and actions:

Conditions

If the response is Employee,

If the response is Employee's husband, Employee's wife, Employee's common-law partner, Employee's son or daughter, or Employee's stepson or daughter,

For all other responses,

Actions

then select "Employee" from the code set.

then select "Employee's husband /wife", "Employee's common-law partner", "Employee's son/daughter" or "Employee's step son/daughter" accordingly from the code set.

select "Institutional Resident" from the code set.

d. To code responses within:

- merchant and coastguard vessels;
- naval vessels;

you must apply the following conditions and actions:

Conditions

If the response is Employee,

If the response is Employee's husband, Employee's wife, Employee's common-law partner, Employee's son or daughter, or Employee's stepson or daughter,

Actions

then select "Employee" from the code set.

then select "Employee's husband/wife", "Employee's common-law partner", "Employee's son/daughter" or "Employee's step son/daughter" accordingly from the code set.

e. To code responses within:

• Hutterite colonies;

you must apply the following conditions and actions:

Conditions

If the response is Hutterite,

If the response is Hutterite's husband, Hutterite's wife, Hutterite's son or Hutterite's daughter,

Actions

then select "Hutterite" from the code set.

then select "Hutterite's husband/wife", or "Hutterite's son/daughter" accordingly from the code set.

If the exact relationship cannot be determined; or if the response is either not legible or is in a language other than French or English, REFER THE HOUSEHOLD TO THE EXPERT CODER.

VII. Conclusion

Now that you have read the Coding Manual, you are ready to use the Relationship to Person 1 Interactive Coding System.

If you have any questions, be sure to ask your supervisor for clarification.
