Small, Medium-sized and Large **Businesses in the Canadian Economy: Measuring Their Contributions to Gross Domestic** Product from 2001 to 2008

This paper estimates the contributions to gross domestic product (GDP) made by small, medium-sized, and large businesses in the Canadian business sector from 2001 to 2008. The contribution of large businesses, that is, businesses with 500 or more employees, to business-sector GDP steadily increased from 45.0% in 2001 to 47.9% in 2008. Small and medium-sized businesses, including unincorporated businesses, accounted for the remaining 52.1% in 2008.

Small Business Profiles, 2010

Small business profiles for 2010 are now available. The profiles present financial data for small businesses in Canada, defined as having annual total revenue between \$30,000 and \$5 million in 2010. They are classified by industry, by province or territory, and by legal status (incorporated or unincorporated).

The SME Benchmarking Tool from Industry Canada provides these data at no cost.
