The Chair (Mr. Dean Allison (Niagara West—Glanbrook, CPC)): I want to mention that the bells are ringing right now for votes. I need unanimous consent to move forward here. If we want to do the main estimates fairly quickly, my suggestion is that if we had a couple of minutes to do this, we could do it, and then we would not need to come back.

Do we have unanimous consent?

Some hon. members: Agreed.

The Chair: Okay, if we could do the main estimates, then I would have one budget—I won't keep you more than 15 minutes, if that's the case, and then we won't come back after votes. Is that all right?

I want to look at the main estimates. I am going to start with Foreign Affairs, Trade and Development, votes 1, 5, 10, 15, L20, and L25, and on the International Development Research Centre.

Mr. Dewar, go ahead.

Mr. Paul Dewar (Ottawa Centre, NDP): Mr. Chair, I want to make three comments, and then I'll let you go right through it.

With respect to the estimates, I note that there is a 17% cut to IDRC, that there's a 28% cut to pensions and social security benefits for diplomats included in this, that there's an \$8-million debt relief to Burma, which I found interesting. Some of us have concerns about the continuing repression going on in parts of Burma.

I also note, Mr. Chair, that the plans and priorities metrics for trade success still emphasize quantity over quality. I noted that in the estimates.

One final thing I noted, Mr. Chair, is that many of the objectives assessed are seemingly arbitrary on this one to five scale, when we looked at how things are assessed in the votes we're passing right now. I note that, because it's a concern when you're grading yourself on a subjective one to five scale, that it's based on your own intuition of how you have done.

One last thing I hadn't written down here, Mr. Chair, but while I have the microphone....then I'll just carry on with the votes. At some point—and I guess I'm looking to government, parliamentary secretaries—we would love to see an organizational chart of the new department. It's been a while. We've had them in front of the committee, but it would be nice to see an organizational chart of what DFATD looks like. I just want to mention that.

That's all, Mr. Chair. Thanks very much.

The Chair: I'm going to ask a question on how we proceed. Would it be okay if we grouped all of the votes together? We have the comments on the record. Is it all right with the opposition to move forward?

My question is with respect to votes 1, 5, 10, 15, L20, and L25.
