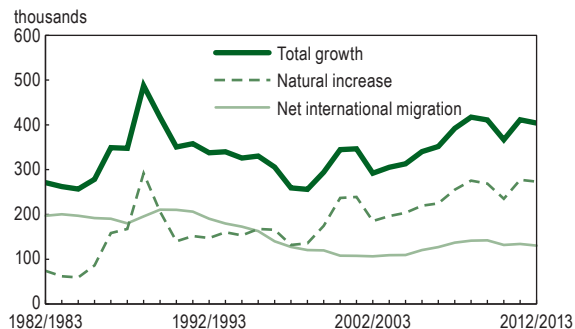

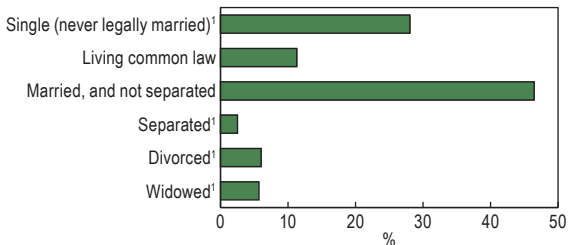

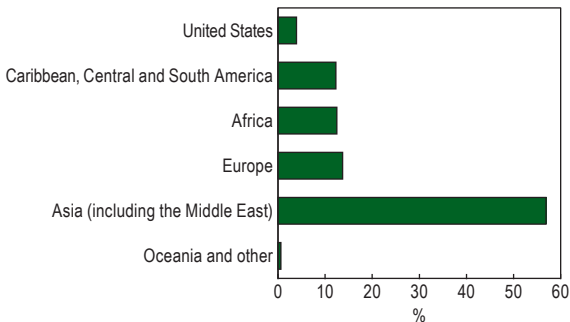

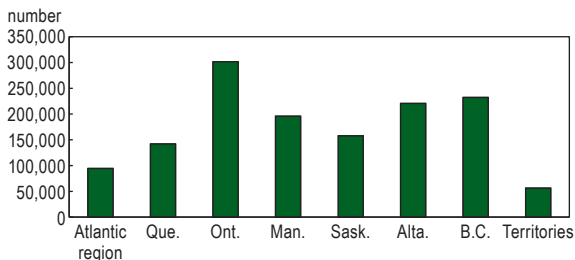

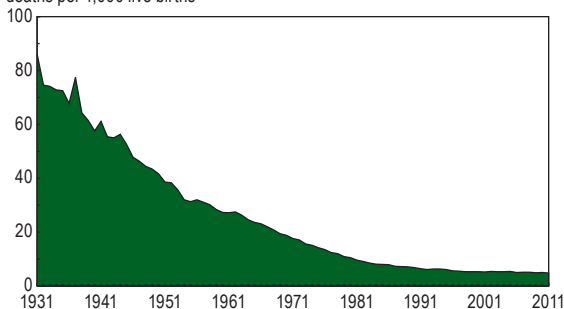

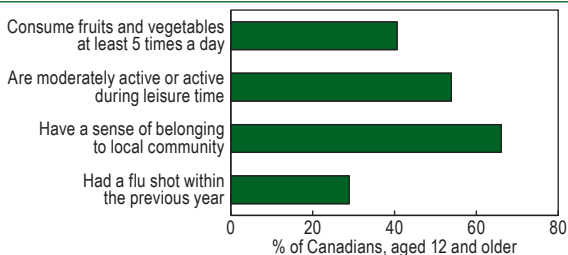

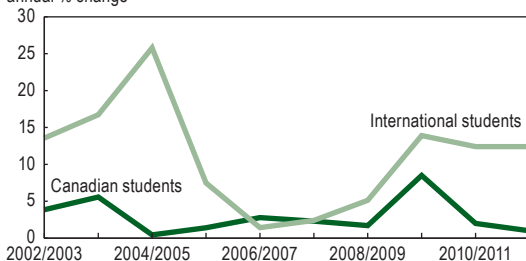

Public postsecondary enrolment

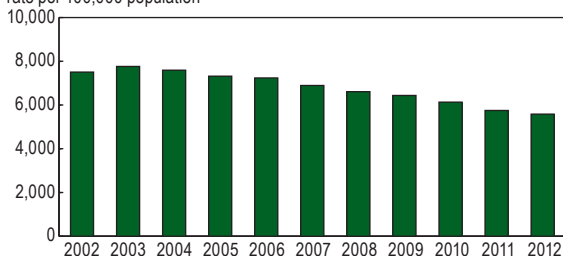
annual % change

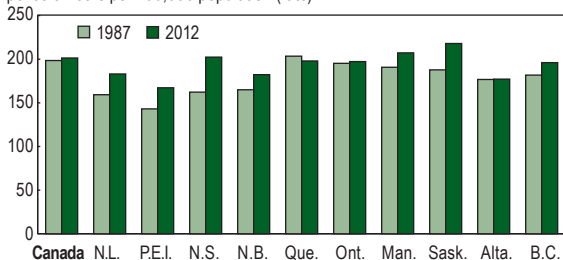

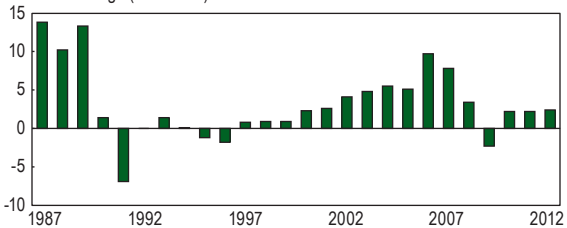

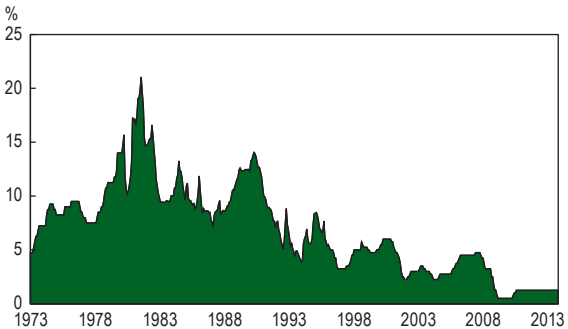

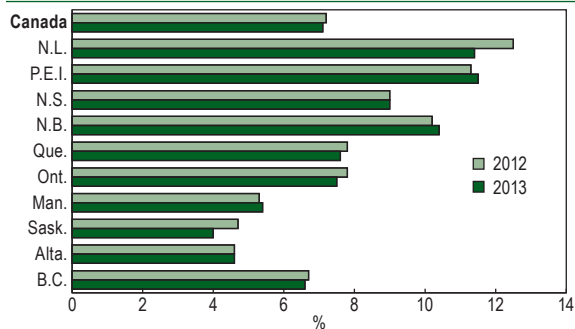

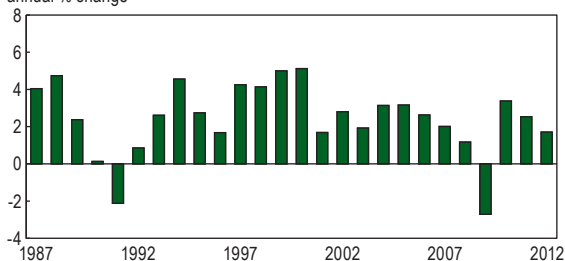

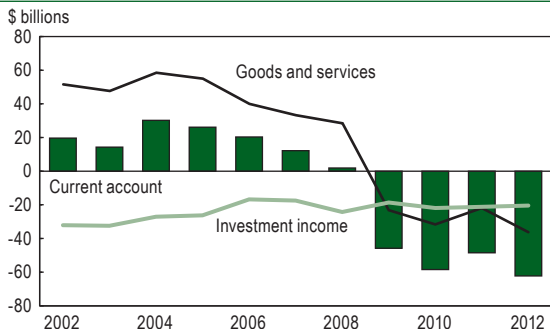

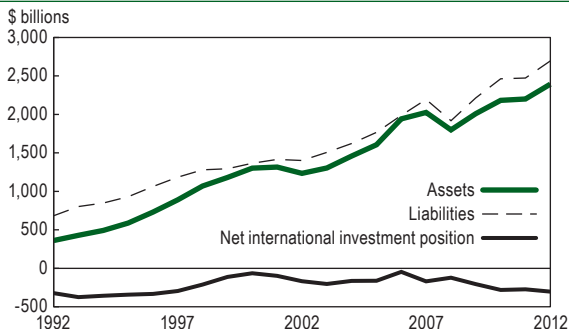

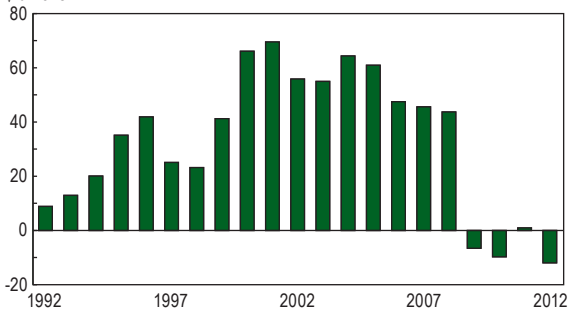

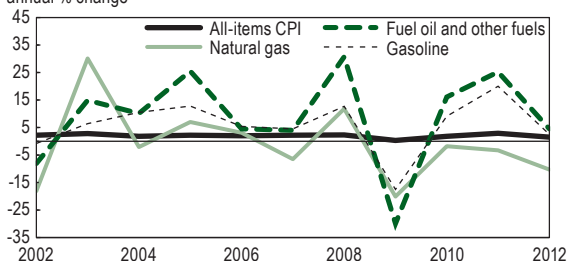

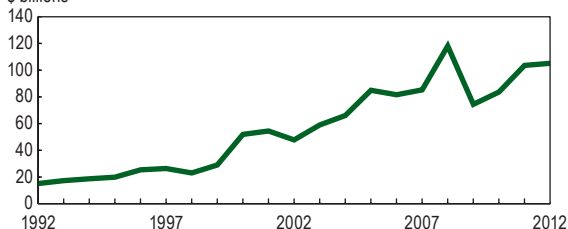

Industrial capacity utilization rates

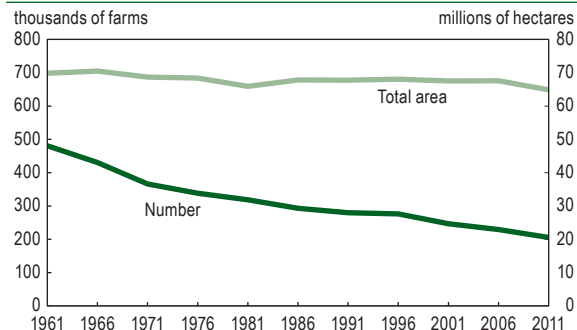

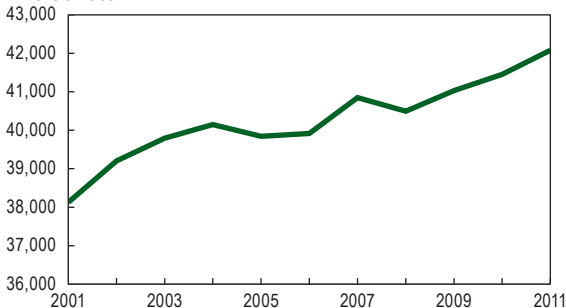

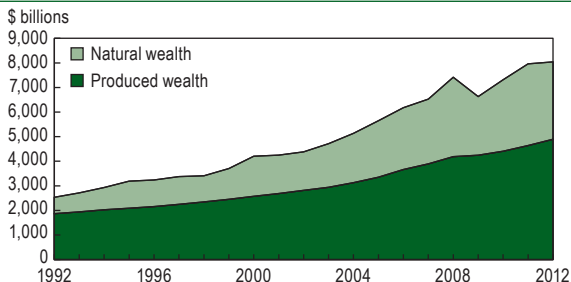
Gross sales of gasoline for motor vehicles

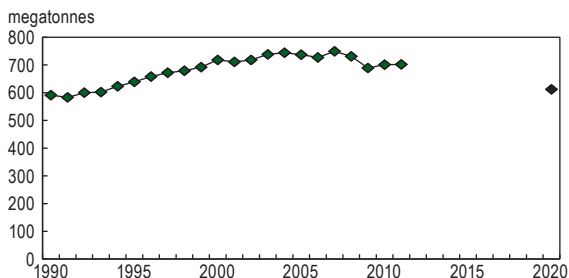
Canada's natural resource assets and produced assets

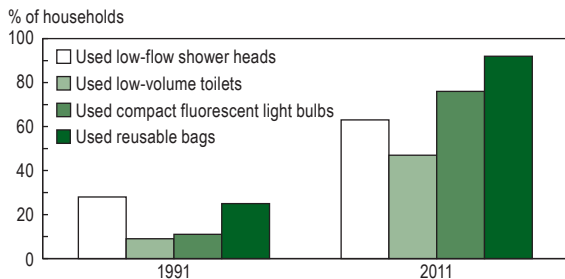
Emissions of carbon dioxide equivalents in Canada
