Council Welcomes New Director of Domestic Policy and Programs



Clouncil's Executive Director, Terry Hayward is pleased to announce the appointment of Christine Kwasse as Director, Domestic Policy and Programs, effective October 12, 2004.

Ms. Kwasse studied in Belgium, where she acquired a Masters Degree in Economics and Social Sciences focusing on agricultural development and at the University of Ottawa where she received an International Masters in Business Administration.

As a result of the broad scope, as well as the practical aspects, of her academic background, Ms. Kwasse has worked at the International Development Research Center (IDRC) and the Bank of Canada. At the Bank of Canada, she was involved in projects such as the launch of new banknotes series and other research initiatives in the Department of Banking Operations. She subsequently moved to the position of economist in the Developing Countries and International Financial Institutions Division, where she conducted research and briefings on international relations and trade issues in emerging economies.

Ms. Kwasse replaces **Keith Wilkinson**, a 25-year Council veteran, who is on a pre-retirement assignment at the Council, working with the Agencies and signatories on the renewal of their federal-provincial-territorial agreements.

Chairperson **Cynthia Currie** noted, "I am happy that the Council has been able to attract Christine to work with us. She shows a keen interest in our agricultural marketing system and I am sure she will be a definite asset as part of the staff team."

Council Business

October 13 and 14, 2004 Council Meeting

Council met in Ottawa on October 13 and 14, 2004. A full agenda included a briefing on the Canadian Agricultural Income Stabilization Program (CAIS), prior approval of an amendment to the Canadian Chicken Marketing Quota Regulations (Period A-62), prior approval of amendments to the Canadian Broiler Hatching Egg Marketing Agency Quota Regulations (Final 2004 and Preliminary 2005), a meeting with representatives of the Canadian Beef Cattle Promotion and Research Agency and discussions regarding ongoing complaints before Council.

In light of a complaint by Giannone Poultry Inc. against the Chicken Farmers of Canada, Council deferred consideration of an amendment to the Canadian Chicken Marketing Levies Order.

Complaint by Giannone Poultry Inc. Against Chicken Farmers of Canada

A s mentioned above, Council has received a complaint from Giannone Poultry Inc. of St. Cuthbert, Quebec against a decision of the Chicken Farmers of Canada relating to the assessment of a market development levy.

A complaint hearing took place at Council's office (10th Floor, 344 Slater Street, Ottawa) on November 1, 2004. The Complaint Committee members are Council Chair **Cynthia Currie** and Council Member **Michel Veillette**.

BC Turkey Signatories' Complaint Against the CTMA

In December 2003, Council received a complaint from the BC signatories against the Canadian Turkey Marketing Agency for failure to provide a market responsive allocation process that complies with the provisions of the Proclamation establishing the Agency. Council has worked with the parties to the complaint throughout the last ten months to encourage a resolution to the issue.

The BC signatories have now requested that Council move forward with a hearing. The hearing has been scheduled for 9:00 a.m. on December 1, 2004, and will take place at the office of the Canadian International Trade Tribunal, 18th Floor, 333 Laurier Avenue, Ottawa, Ontario.

Any person or party wishing to intervene at the hearing will have until November 12, 2004 to provide the Council with a written intervention. Complaint Committee members will be **Ron O'Connor**, Council Vice Chair and **Michel Veillette**, Council Member.

Meeting with Agencies on Modern Comptrollership

on September 10, 2004, Council staff met with the General Managers and Chief Financial Officers of the four national marketing agencies. The purpose of the meeting was to update them on the implementation of modern comptrollership practices by both the federal government at large and the Council. Gilles Vezina, a senior director at the Treasury Board Secretariat, gave a presentation on modern comptrollership.

Agency representatives were informed of initiatives being undertaken to implement modern comptrollership practices at the Council and how this may impact Council's day to day business. Further discussions with the Executives of the agencies will take place in the near future.

Chicken Farmers of Canada

The CFC Board of Directors has set the allocation for Period A-63 (January 9 to March 5, 2005) at 209,367,778 kilograms live weight (154,146,848 kg. eviscerated). This consists of a domestic allocation of 197,283,639 kilograms live weight (145,251,958 kg. eviscerated) and a market development allocation of 12,084,139 kilograms (8,894,890 kg. eviscerated).

The national domestic allocation represents a 7.9% increase over the base allocation, and a 2.3% increase over domestic production for the same period last year.
