December Council Meeting

Council had a busy schedule during its meeting of December 16 to 18, 2008. Council met with the Executives of the four national marketing agencies to discuss Agency issues and strategic directions as well as review their budgets for the coming year. Council members also met with the Canadian Poultry and Egg Processors Council and the Further Poultry Processors Association of Canada as well as with representatives of the 5 primary chicken processing enterprises in Canada.

Canadian Turkey Marketing Agency



Council approved the Canada Turkey Marketing Producers Levy Order extending the expiry date of the Order to December 31, 2009. The CTMA levy will remain unchanged for 2009. The Agency levy

rates are a combination of the CTMA's levy of 1.6 cents/kg (live weight) and provincial levies as listed on the tables.

Council also approved CTMA's By-Law No. 8 which deals with expenses to be paid to their members for attending CTMA meetings. The changes are to the annual stipend (from \$6k to \$7.5k), per diem (from \$275 to \$350) and teleconference fee (from \$137.50 to \$175/call) for the Chairman.

Members were also presented with the 2009 budget and briefed on the Agency's 2009 business plan, priorities and challenges which include governance, policy, marketing, operations, communications and relationship development.

Complaint and Amendment to Chicken Quota Regulation for A-89



CPEPC, FPPAC and CRFA filed a complaint against Chicken Farmers of Canada's quota allocation decision for A-89. This complaint is similar to the

complaint on A-87 and the NFPC will use the same process and approach as with the complaint for A-87.

Therefore, having reviewed the A-89 complaint Members proceeded to consider for prior-approval the quota regulation for A-89.

Council approved the Canadian Chicken Marketing Quota Regulations establishing a domestic quota allocation of 198,190,170 kilograms chicken live weight (145,929,898 eviscerated) and the market development quota of 14,186,959 kilograms of chicken live weight (10,443,110 eviscerated) for the period beginning January 4, 2009 and ending February 28, 2009.

Council approved the Canadian Chicken Marketing Levies Order extending the expiry date of the Order to December 31, 2009 with no change to the CFC levy. The Agency levy is a combination of the CFC's levy of 0.44 cents/kg (live weight) and provincial levies. The tables illustrate the 2009 CFC levies and the allocations by category and by province.

Council also approved the CFC's by-laws amending their annual stipend, per diem and incidental allowance. With this amendment the Chairman will receive a stipend of \$27,000, executive members will each receive \$7,300 and each director will collect \$3,600. As well changes to the meeting per diem are for the Chairman from \$330 to \$375 and the incidental allowances from \$60 to \$100 (see table).

Canadian Hatching Egg Producers



Council approved the Agency's 2008 Final Quota Regulations at 539,069,195 broiler hatching eggs and its Initial 2009 Quota Regulations at 544,738,536 broiler hatching eggs for 2009.

Members were presented with CHEP's 2009 Budget as well as an update on key activities and priorities for 2009 which include Agency membership, proclamation amendments,



AI surveillance, *Health of Animals Act,* business risk management programs, standardized operating protocols and WTO.

Egg Farmers of Canada



Council approved the Canadian Egg Marketing Levies Order for 2009 which reduced the total Agency levy by \$0.0400 per dozen to

\$0.2025 per dozen (see chart). The levy is effective on December 28, 2008 and expires on March 26, 2010.

During the October meeting Council approved the expiry date of the existing Canadian Egg Marketing Levies Order to March 26, 2009. This will allow the Agency to continue to collect levies for a ninety

day period in the event that Council does not prior-approve the 2009 levy rates prior to the existing expiry date of December 27, 2008. Council postponed consideration for the 2009 EFC Quota Regulation as well as consideration of the complaint filed by the three Saskatchewan signatories against the 2009 quota regulation.

At the request of the Saskatchewan Egg Producers, Council further examined the concept of comparative advantage as proposed by Mr. Michael **Katz.** Professor **Joel Bruneau** and Professor Andrew Schmitz in their paper entitled "Identifying and Applying a Comparative Advantage Framework in Canadian Supply-Managed Agriculture". In order to give the paper the consideration it deserves, Council commissioned two independent reviews as well as Council staff's paper titled Balassa Index for Egg *Production – a disaggregated approach – 1947 to* 2007. Council also intends to obtain an independent assessment of Professor Doyon's paper Discussion of Over-base Factors Using Various Indicators, 2008.

Members were presented with the 2009 budget and updated on the Agency's activities, priorities and challenges which include name change, traceability program, successful office relocation, on-going IPP

efficiencies, current three year business plan and COP survey.

Complaint on A-87 Oversight Committee Meeting

Last fall the NFPC held a special joint meeting regarding the Canadian Poultry and Egg Processors Council's June 2008 complaint. During this session NFPC staff presented preliminary investigation findings and gave the participants the opportunity to partake in a discussion about the report and talk about next steps and deadlines.

In our November edition of Focus, it was announced that an industry oversight committee was established to ensure that coordinated actions are developed and implemented to improve CFC's allocation setting system. The first meeting of the newly established oversight committee was held on December 10, 2008. Terms of Reference were discussed as well as the working approach.

Complaint on CFC A-90

The Canadian Poultry and Egg Processors
Council and the Further Poultry Processors
Association of Canada tabled a complaint on

December 3, 2008 against Chicken Farmers of Canada's quota allocation decision for A-90. The NFPC is currently reviewing the complaint.

Update on NFPC Strategic Plan

Council staff presented Members with a first draft of the NFPC's 2009-2012 strategic plan which resulted from the discussion held during the Council's October strategic planning session. Members will provide their comments and a



revised version will be presented to agencies, industry stakeholders and provincial supervisory boards for their input and comments in mid January 2009.

Amendment to NFPC By-Law #1

In accordance with the Farm Products Agencies Act under section 25 (c), Agencies may make by-laws that are subject to the approval of the Council, fixing the fees to be paid to members of the agency, for attendances at meetings of the agency and the travel and living expenses to be paid to the members of the agency.

The Council has delegated its duty to review and approve proposed amendments to fees paid to members of an agency and proposed amendments to the travel and living expenses to be paid to members of an agency. To this end, a new By-Law Committee was established consisting of the Chairperson, (and in the absence of the



Chairperson, the Vice-Chairperson) and any two of the following staff, the Executive Director, the Secretary and the Senior Advisor responsible for the agency in question.



Brazil forecasts its domination in chicken exports by 2018

Over the next 10 years, Brazil will dominate a large share of foreign trade of agricultural products, including chicken, according to a latest Brazilian Agribusiness Forecast study.



The Brazilian forecasts published by Brazil's Ministry of Agriculture, indicate that Brazilian

exports of chicken should reach 89.7% of the world's total volume in 2018 compared with 44.6% today.



Global broiler output forecast 4% higher next year

World production of broiler meat is forecasted to rise next year by 4% to 74 million tonnes, according to the latest forecast by the USDA's Foreign Agricultural Service (FAS).

Highlights:

- * US: lower production for the first time since 1973.
- * **EU-27**: Expanding imports will make them the second largest importer in the world.
- * Saudi Arabia: Expanding imports, mainly from Brazil.
- * Venezuela: imports to grow, but at a slower rate to 2008.

In its World Markets and Trade report, FAS reports the fastest growth will occur in China (+8%) and Brazil (+5%) and that the US production is expected to decrease for the first time since 1973 due to relatively high levels of feed and energy costs.

Exports from Brazil and the US account for nearly 80% of the world total exports. Brazil is forecasted to hit another record as shipments to Hong Kong, Japan, the United Arab Emirates, the EU-27, Saudi Arabia and Venezuela, continue to accelerate.

The International Poultry Expo (IPE)

The 2009 International Poultry Expo (IPE) will be held in Atlanta Georgia from January 28 through to 30, 2009. It will once again be held in conjunction with the International Feed Expo.

This trade show is the networking centre of the world for the poultry industry. Every part of the poultry and egg industry is represented: feed milling, live production, hatchery, processing, further processing, packaging, commercial egg, marketing, and all other industry stakeholders.

This year the fair will offer free workshops and seminars and the program will address the hottest issues and challenges facing the poultry industry.

Topics will include: Current Trends in Employment Law and Labor Relations, Social Responsibility in the Poultry Industry, Industry Outlook: An Executive Management Perspective and more.



This is a great place to share ideas with more than 20,000 poultry and feed industry leaders from more than 100 countries, attend educational programs and gain valuable insights from key business leaders.

What do you know about Frost Bite?

Frost bite is a potentially dangerous condition where both the skin and underlying tissue are frozen. Skin appears white and waxy and is hard to the touch. Extreme cases can result in amputation.



In the event of frostbite one should:



Begin the warming process only if you can ensure the area will stay warm.



Warm the affected area very gradually using body heat or moderately warm water.



Do not rub or massage the area and avoid direct heat which can burn the skin.
