### Seasons Greetings from the INMD Institute Advisory Board (IAB)



With great pleasure, I bring greetings from the INMD Institute Advisory Board (IAB). Reflecting on the past year, we celebrate achievements of INMD through funding opportunities, national and international partnerships, and outreach to the community. As a co-lead on the Environments and Health Signature Initiative, INMD launched Programmatic Grants in Environments,

Genes and Chronic Disease in collaboration with the Institutes of Aging, Human Development, Child & Youth Health, and Infection & Immunity. The results of the Team Grants in Bariatric Care for Management of Severe Obesity, launched in April, will be announced soon. Grants from a collaborative transnational research initiative with European nations on Biomarkers in Nutrition and Health were also recently announced.

The diabetes research community gathered at a <u>National</u> <u>Strengthening Workshop</u> in Ottawa on Diabetes and Related Complications as a means of focusing interest in a national Strategy for Patient-Oriented Research (SPOR) Network in the area. To enhance

research skills for young scientists, a two-day meeting for 35 New Investigators (<5 years on faculty) from across the country was held in Banff. Evaluated as a great success, this meeting cultivated interactions between the new investigators with seasoned scientists and INMD partners from health charities and professional societies. In partnership with the Institute of Infection & Immunity, INMD hosted a national **Microbiome Workshop**. INMD also sponsored scientific symposia at the 17<sup>th</sup> World Congress of Food Science and Technology, the Canadian Nutrition Society, and the annual meeting of the Canadian Public Health Association. With excellent input from IAB members, partners, and the research community at large, the refreshed strategic plan for INMD for 2015-2018 was finalized, and will be circulated shortly.

On behalf of all members of the IAB, sincere thanks to INMD staff for making 2014 a great year for the Institute.

# LAUNCHED: Programmatic Grants in Environments, Genes and Chronic Disease

CIHR and partners are pleased to announce the *Programmatic Grants in Environments, Genes and Chronic Disease (EGCD)* funding opportunity. The Programmatic Grants in EGCD are part of the **Environments and Health Signature Initiative**. The total amount available for this funding opportunity is \$14M (grant max \$400K/yr for up to 5 yrs). The Programmatic Grants in EGCD will provide funding for research addressing four funding pools: (1) environment-microbiome-gene interactions in chronic non-communicable

diseases, (2) chronic non-communicable immunologically-mediated diseases (e.g. IBD, type 1 diabetes, celiac disease), (3) chronic non-communicable metabolic diseases (e.g. type 2 diabetes, NAFLD, obesity), (4) chronic non-communicable diseases related to reproduction, fetal and/or early childhood development. ## **Brent Richards, MD, MSc,** McGill University 2014 Dr. Jody Ginsberg Young Investigator Award



Dr. Brent Richards is an endocrinologist and a FRQS-supported Clinician-Scientist on faculty at McGill Univ. in Montreal, Quebec. In support of his training, he was selected for a CIHR Fellowship and a Commonwealth Scholarship. Brent's current research program is focused on the identification of genetic determinants of common, aging-related diseases and the translation of these findings

to improved clinical care. His research focuses primarily on diabetes and osteoporosis. His research findings, which have been supported by CIHR, the Public Health Agency of Canada and partners in industry, are published in journals including Nature Genetics, Lancet, and PLoS Medicine. Dr. Richards has been recognized for his accomplishments with receipt of the 2014 Canadian Society for Endocrinology (CSEM) Dr. Jody Ginsberg Young Investigator Award, co-sponsored by INMD, for his research on vitamin D.

# Dr. Daniel Drucker, Recipient of the 2014 Manpei Suzuki International Prize for Diabetes Research



INMD congratulates Dr. Daniel Drucker,
Professor of Medicine (Univ. Toronto) and
Senior Scientist at the Lunenfeld-Tanenbaum
Research Institute of Mt. Sinai Hospital, for his
receipt of the prestigious **2014 Manpei Suzuki International Prize for Diabetes Research**.
The Selection Committee recognized his years
of ground-breaking contributions to landmark
discoveries in the biology and physiology of
incretin hormones. These serve as the basis for
clinical development of GLP-1 receptor agonists

and DPP-4 inhibitors. Dr. Drucker will be awarded a certificate of honour, at an award ceremony in Tokyo in February 2015.
