Under the authority of the *Pest Control Products Act*, Health Canada's Pest Management Regulatory Agency (PMRA) has concluded that the addition of a new use on crop subgroup 13-07B (Bushberries) to the product label of Confirm 240F Agricultural Insecticide, containing technical grade tebufenozide, is acceptable. The specific uses approved in Canada are detailed on the label of Confirm 240F Agricultural Insecticide, *Pest Control Products Act* Registration Number 24503.

The evaluation of this tebufenozide application indicated that the end-use product has value, and the human health and environmental risks associated with the new uses are acceptable.

Before registering a pesticide for food use in Canada, the PMRA must determine the quantity of residues that are likely to remain in or on the food when the pesticide is used according to label directions and that such residues will not be a concern to human health. This quantity is then legally specified as a maximum residue limit (MRL). An MRL applies to the identified raw agricultural food commodity as well as to any processed food product that contains it, except where separate MRLs are specified for the raw agricultural commodity and a processed product made from it.

Consultation on the proposed MRL for tebufenozide is being conducted via this document (see Next Steps, the last section of this document). A summary of the field trial data used to support the proposed MRL can be found in Appendix I.

To comply with Canada's international trade obligations, consultation on the proposed MRL is also being conducted internationally by notifying the World Trade Organization, as coordinated by the Canada's Notification Authority and Enquiry Point.

The proposed MRL, to be added to the MRLs already established for tebufenozide, is as follows.

MRLs are proposed for each commodity included in the listed crop groupings in accordance with the Residue Chemistry Crop Groups webpage in the Pesticides and Pest Management section of Health Canada's website.

MRLs established in Canada may be found using the Maximum Residue Limit Database on the Maximum Residue Limits for Pesticides webpage. The database allows users to search for established MRLs, regulated under the *Pest Control Products Act*, both for pesticides or for food commodities.

International Situation and Trade Implications

The MRL proposed for tebufenozide in Canada is the same as corresponding American tolerances and Codex MRLs.¹ American tolerances are listed in the Electronic Code of Federal Regulations, 40 CFR Part 180, by pesticide. A listing of established Codex MRLs is available on the Codex Alimentarius Pesticide Residues in Food website, by pesticide or commodity.

Next Steps

The PMRA invites the public to submit written comments on the proposed MRL for tebufenozide up to 75 days from the date of publication of this document. Please forward your comments to Publications (see the contact information on the cover page of this document). The PMRA will consider all comments received before making a final decision on the proposed MRL. Comments received will be addressed in a separate document linked to this PMRL. The established MRL will be legally in effect as of the date that it is entered into the Maximum Residue Limit Database.

Appendix I

Summary of Field Trial Data Used to Support the Proposed Maximum Residue Limit

Previously reviewed residue data from field trials conducted in/on blueberries (highbush and lowbush) were reassessed in the framework of this petition.

Maximum Residue Limits

The recommendation for a maximum residue limit (MRL) for tebufenozide was based upon the previously reviewed field trial data, and the guidance provided in the OECD MRL Calculator. Table A1 summarizes the residue data used to calculate the proposed MRL for bushberries (Crop Subgroup 13-07B).

Following the review of all available data, the MRL as proposed in Table 1 is recommended to cover residues of tebufenozide. Residues of tebufenozide in these crop commodities at the proposed MRL will not pose an unacceptable risk to any segment of the population, including infants, children, adults and seniors.
