## Advance Statement of Employment and Payrolls, Feb. 1, 1952.

Employment at Feb. 1 in the major non-agricultural industries declined from the Jan. 1 level, reflecting a typical seasonal movement. Based on the 1939 average as 100, the advance index number of employment, at 177.9, was 1.7 p.c. lower than it had been a month earlier. While employment was lower than in the preceding 8 months, it was the highest recorded at this time of year. The index number of payrolls showed a seasonal advance over the Jan. 1 figure, amounting to 3.2 p.c. The average wages and salaries, at \$52.94 for the week, were the highest to date, being \$2.52 above the average of \$50.42 at Jan. 1, and \$3.30 above that of \$47.87 reported at Feb. 1, 1951.

Employment was lower than at Jan. 1 in all provinces except Prince Edward Island and Nova Scotia. Average weekly wages and salaries were higher in every area with the exception of Prince Edward Island. The increases in most cases were sufficient to result in larger payroll disbursements than at Jan. 1, when the situation had been affected by the year-end holidays.

The advance tabulations indicated reduced activity in all major industries except mining and manufacturing. The changes over the month were seasonal in character and were most substantial in trade, construction and transportation.

In manufacturing, the index of employment showed a gain of 0.8 p.c. in the month and was 0.3 p.c. above the level reported at Feb. 1, 1951. Payroll disbursements were 7.4 p.c. higher than at Jan. 1, and 11.5 p.c. above those reported 12 months earlier. The average weekly earnings, amounting to \$55.25, as compared with \$51.82 at Jan. 1 and \$49.64 at Feb. 1, 1951, were the highest on record.
