ADVANCE STATEMENT OF EMPLOYMENT AND WEEKLY EARNINGS,

NOVEMBER, 1959

The industrial composite index number of employment for November was 121.8 (1949 = 100), down 2.1 p.c. from the index for October. Seasonal factors accounted for about half the decline. Steel shortages were the main factor in the reductions in durable goods manufacturing, leading to major layoffs in the automobile industry and to smaller reductions in iron and steel products. Employment movements in most other industries followed normal seasonal patterns, although declines in construction were somewhat greater than is usual at the time of year.

The industrial composite figure of average weekly wages and salaries declined from \$74.64 in October to \$74.28 in November. Reductions in activity in durable goods manufacturing industries contributed to the decrease. The composite payroll index declined from 217.3 in October to 211.6 in November, a decrease of 2.6 p.c.
