# Competitive Trade Analysis

### REPORT CONTENT SUMMARY

- This report looks to highlight the major sectors in the Netherlands, and attempts to identify the best opportunities for Canadian exports.
- Specifically, the data analysis that follows focuses on the top ten Dutch imports by major aggregate sector, of which Canada is a supplier or has the capacity to supply. It identifies the gap between the Netherlands' imports from the world and the proportion provided by Canada, and then outlines top international competitors.
- Unless otherwise specified, all figures in this document are based on import data as reported by Eurostat, and were sourced from Global Trade Atlas (2015).

### NETHERLANDS MARKET SUMMARY

- The Netherlands is the sixth-largest importer of agri-food and seafood products in the world, and the third-largest among members of the European Union (EU) with C\$76.9 billion in 2014. The Netherlands is also the world's second-largest agri-food and seafood exporter (first among EU members) with C\$120.0 billion in the same year. They also recorded a trade surplus of C\$43.1 billion in 2014.
- Top agri-food and seafood suppliers include Germany with 17.9% of total import value, Belgium (12.1%), and Brazil (6.8%). Canada was the Netherlands' 45<sup>th</sup>-largest import provider in 2014, representing C\$324.5 million, or just 0.4% of the market.

## TRADE OVERVIEW

The Netherlands is the sixth-largest importer of agri-food and seafood products in the world and the second-largest exporter. It also ranks as the third-largest importer and first-largest exporter among EU member states. The country recorded an agri-food and seafood trade surplus of C\$43.1 billion in 2014, with imports valued at just over C\$76.9 billion and C\$120.0 billion in exports. Sourcing a diverse range of agri-food and seafood products from international suppliers, key import commodities include edible fruit and nuts (9.7% of total imports), food waste and animal feed (7.5%) and meat and edible offal (7.3%). The top three supplying countries of overall agri-food and seafood imports are Germany, Belgium and Brazil. Canada is ranked 45<sup>th</sup> among supplying countries to the Netherlands with imports values at C\$324.5 million in 2014.

Canada has a substantial supply gap with the Netherlands that has been increasing at rate identical to the Netherlands' agri-food and seafood import growth. Canada holds just marginal market share in each of the Netherlands' top ten import commodities, presenting opportunities to further supply the country's growing demand. This may prove particularly true in light of the Canada-European Union Comprehensive Economic and Trade Agreement (CETA). In particular, since the port of Rotterdam is an important entry point into the European Union, the CETA deal may lead to substantially higher imports for further transit. However, while the Netherlands has a diverse supplier list, totalling 205 countries in 2014, their primary trading partners are fellow members of the European Union (representing seven of the top ten suppliers, or 48.6% of the market), signalling a very concentrated supply environment.

Edible fruit and nuts represented the Netherlands' top-grossing import commodity in 2014, with a value of over C\$7.4 billion, or 9.7% of overall agri-food and seafood imports. Across the 2010 to 2014 period, edible fruit and nuts was an average performer in terms of value sales growth, with a compound annual growth rate (CAGR) of 7.8%. The tenth-largest category of fish and crustaceans registered sales of C\$3.4 billion in 2014, and was the strongest-growing commodity over the review period with a CAGR of 9.4%.

## CONCLUSION

The Netherlands is a mature market, and the world's sixth-largest importer of agri-food and seafood products. Canada ranked as its 45<sup>th</sup>-largest supplier in 2014, having registered a small increase in import value since 2010. While the Netherlands' imports from Canada have been growing at a similar rate to their imports from the world, they remain fairly marginal compared to other partners. This has allowed for a significant supply gap between the Netherlands and Canada that has been widening at a rate identical to the Netherlands' overall import growth in recent years. While the Netherlands sources agri-food and seafood products from a large number of countries, among many commodities the vast majority of imports come from the top one or two suppliers. As well, in many cases the primary trading partners are other European Union members, leaving just marginal market share for others.

Among the Netherlands' top ten import commodities, Canada's highest supplier ranking was in cereals, where it occupied the seventh spot with 2.8% of the market, and posted the fourth-strongest growth rates of all supplier countries over the 2010-2014 period. In contrast, Canada holds less than 1.0% market share in eight of the Netherlands' top ten import commodities, and falls outside of not only the top ten, but the top twenty suppliers among eight of these commodities. Despite this, over the last five years, Dutch imports from Canada have posted growth within eight of the top commodities (edible fruit and nuts; food waste and animal feed; cocoa and cocoa preparations; beverages; prepared vegetables, fruit, and nuts; cereals; and fish and crustaceans). This may present further opportunities to lessen the gap, particularly in the aforementioned categories where value growth in imports from Canada outpaced growth in imports from the world. Furthermore, Canada's performance relative to non-European Union suppliers is expected to improve as a result of CETA.
