### **FPCC Business**

The Farm Products Council of Canada's (FPCC) Council members met on March 22, 2016, in Ottawa.

During this meeting, members met with executive members and staff of Canada Beef and were introduced to the new General Manager Melinda German. Her first responsibility will be to update the Agency's regulatory framework and the provincial service agreements. At this session, the Agency shared its annual business plan, and touched on some critical issues and challenges facing the beef industry for 2016.

# Industry Complaints—Update

On March 8, 2016, FPCC was informed that a Memorandum of Understanding (MOU) was signed by the Parties of the July 8, 2015, and September 17, 2015, complaints, filed by the Ontario Broiler Hatching Egg & Chick Commission (OBHECC) and the Syndicat des producteurs d'œufs d'incubation du Québec (SPOIQ) respectively, against the Canadian Hatching Egg Producers (CHEP) with regards to CHEP's application of Schedule B of the Federal-Provincial Agreement for Broiler Hatching Eggs.

The Parties reached an agreement in principle during a mediation session. After four months of work, the MOU was drafted to the satisfaction of all parties. Before the MOU is put into effect, CHEP and its member provinces will need to amend their Liquidated Damages Assessment (LDA) Agreement and submit it for FPCC's approval.

FPCC also received a complaint from Turkey Farmers of Ontario (TFO) on July 10, 2015, against Turkey Farmers of Canada's (TFC) decision on June 11, 2015, which imposed penalties on TFO due to overmarketings. FPCC's handling of the complaint was suspended on the request of the parties to undertake binding arbitration. On March 14, 2016, the Turkey Farmers of Canada released a public statement regarding the unanimous decision of the
