Under the authority of the [Pest Control Products Act](#), Health Canada's Pest Management Regulatory Agency (PMRA) has received applications to register technical grade pyriofenone and the end-use product Pyriofenone 300SC Fungicide for use in Canada on cucurbit vegetables (Crop Group 9), grapes, strawberries, caneberries, gooseberries and Saskatoon berries.

The evaluation of these pyriofenone applications indicate that the end-use product has value, and the human health and environmental risks associated with their proposed uses are acceptable. Details regarding these applications can be found in Proposed Registration Decision PRD2016-23, *Pyriofenone*, posted to the Health Canada website on 28 August 2016.

Before registering a pesticide for food use in Canada, the PMRA must determine the quantity of residues that are likely to remain in or on the food when the pesticide is used according to label directions and that such residues will not be a concern to human health. This quantity is then legally specified as a maximum residue limit (MRL). An MRL applies to the identified raw agricultural food commodity as well as to any processed food product that contains it, except where separate MRLs are specified for the raw agricultural commodity and a processed product made from it.

In addition, the PMRA is proposing to specify MRLs for pyriofenone on caneberries (Crop Subgroup 13-07A), bushberries (Crop Subgroup 13-07B), small fruits vine climbing (Crop Subgroup 13-07D) and low growing berries (Crop Subgroup 13-07G) to permit the import and sale of food containing such residues. The PMRA has determined the quantity of residues that are likely to remain in or on the imported commodities when pyriofenone is used according to label directions in the exporting country, and that such residues will not be a concern to human health. Details regarding the proposed MRLs on imported commodities can also be found in PRD2016-23.

Consultation on the proposed MRLs for pyriofenone is being conducted via PRD2016-23. Information regarding the proposed MRLs can be found in Sections 3.5 and 7.1. Supporting field trial residue data are provided in Appendix 1, Tables 1 and 5. The PMRA invites the public to submit written comments on the proposed MRLs for pyriofenone in accordance with the guidance found in PRD2016-23.

To comply with Canada's international trade obligations, consultation on the proposed MRL is also being conducted internationally by notifying the [World Trade Organization](#), as coordinated by [Canada's Notification Authority and Enquiry Point](#).

The proposed MRLs for pyriofenone are as follows.

MRLs are proposed for each commodity included in the listed crop groupings in accordance with the [Residue Chemistry Crop Groups](#) webpage in the Pesticides and Pest Management section of Health Canada's website.

MRLs established in Canada may be found using the [Maximum Residue Limit Database](#) on the [Maximum Residue Limits for Pesticides](#) webpage. The database allows users to search for established MRLs, regulated under the *Pest Control Products Act*, both for pesticides or for food commodities.

International Situation and Trade Implications

Pyriofenone is a new active ingredient that is concurrently being registered in Canada and the United States. The MRLs proposed for pyriofenone in Canada are the same as corresponding tolerances to be promulgated in the United States.

Once established, the American tolerances for pyriofenone will be listed in the [Electronic Code of Federal Regulations](#), 40 CFR Part 180, by pesticide.

Currently, there are no Codex MRLs¹ listed for pyriofenone in or on any commodity on the Codex Alimentarius Pesticide [Residues](#) in Food website.

The PMRA invites the public to submit written comments on the proposed MRLs for pyriofenone up to 75 days from the date of publication of this document. The PMRA will consider all comments received before making a final decision on the proposed MRLs. Comments received will be addressed in a separate document linked to this PMRL. The established MRLs will be legally in effect as of the date that they are entered into the [Maximum Residue Limit Database](#).
