Domestic and Export Controls Seminars

The purpose of these full-day seminars is to review the role of Canadian industry in the protection and safeguarding of strategic and sensitive goods, technology and information. Participants will learn about the provisions of relevant laws, regulations and policies, and will be provided with practical advice on administration, compliance, and enforcement.
