

# **Composite Index**

January 1997

The leading index rose by 0.9% in January, the same as December's revised rate. While a strong indicator of growth in the economy, it is not necessarily a sign of broadly based growth. Growth remained heavily concentrated in the housing and financial components, which have among the longest lead times in foreshadowing changes in the business climate. Excluding these components, growth was steady at 0.4%.





Household demand remained mixed, with gains for goods offset by slack demand for services. Outlays for housing and related items posted their strongest

increases in over four years. These advances pushed existing house sales to their highest level recorded. At the same time, demand for services was flat for the fourth straight month, checked by weak labour market conditions.

The trend in new orders for durable goods continued downwards (-0.2%), despite a boost from the settlement of the auto strike. Export demand for other manufactured goods remained weak. Manufacturers appear to have stayed optimistic, however, as the average number of hours per work week was up sharply, especially in housing-related industries. In the wood industry, for example, the length of the work week rose to 39.3 hours, four more than its trough in December 1990.

The U.S. leading indicator grew slowly again (+0.2%) as manufacturing demand eased. Retail sales moderated at year-end, while the housing market also softened.

The vigour of financial markets continued to outstrip the growth of output and jobs. The stock market took off again early in the new year (+3.1%), while real money supply growth posted its largest monthly increase on record.

# **OTHER RELEASES**

## Sales of natural gas

December 1996 (preliminary)

Natural gas sales totalled 7 829 315 thousand cubic metres in December, up 1.7% from December 1995. The increase was mainly due to a 3.3% jump in sales to the industrial sector (including direct sales). This reflected higher demand for natural gas by electric utilities and the chemical industry.

At the end of December 1996, year-to-date sales were up 5.5% from 1995. Sales to the residential (+10.5%) and commercial (+8.4%) sectors increased largely due to the unseasonably cold weather in the first half of 1996, as well as in both October and November. Sales to the industrial sector (including direct sales) maintained modest growth, posting a 2.3% increase from the same period last year.


