

Help-wanted Index

September 1998

The index that measures the number of help-wanted newspaper advertisements remained unchanged at 144 in September (1996=100). In the last five months, the index has leveled off following steady increases that began in July 1996.

The increases in Prince Edward Island (+3.7%), Quebec (+1.4%) and Manitoba (+1.3%) indices were somewhat offset by a decline in British Columbia (-1.6%). All other provincial indices remained relatively unchanged, fluctuating between -0.7% and 0.7%.

Note: The Help-wanted Index is compiled from the number of help-wanted ads published in 22 newspapers in 20 major metropolitan areas. The index is a measure of companies' intentions to hire new workers. The index has been seasonally adjusted and smoothed to ease month-to-month comparisons.

Short-term Expectations Survey

The short-term expectations survey results of the third quarter show that little change is expected in the economy. However, analysts are beginning to revise some of their forecasts downwards, which is consistent with business cycle theory of a slowing economy.

The mean GDP monthly growth rate forecasts show that, even though economists are making downwards adjustments, they continue to overshoot the monthly changes. In July, the mean forecast was 0.1% compared with the actual decline of 0.3%. On average, forecasts for the mean monthly growth rates for August (+0.2%) and September (+0.1%) remain positive.

Forecasts for international trade show that expectations are for stability between August and October, with a forecast mean trade surplus of \$1.4 billion — slightly lower than the actual figure for July (\$1.5 billion). The forecasts for both exports and imports were slightly higher than the actual figures for July.

Forecasters are also expecting little change in the Consumer Price Index between September and November, but the forecasts have been adjusted downwards, albeit only slightly each month. Actual inflation has been lower than expected — the forecast average for August was 1.1% with an actual outcome of 0.8%.

While the economy has slowed, the labor market has held steady with even a slight decline in the unemployment rate in August to 8.3%. The participation rate has remained steady at 64.9%. Forecasters have been closer in predicting labour market indicators than the other economic indicators, with the mean forecast for the unemployment rate for July matching the outcome.

Railway carloadings

Seven-day period ending September 21, 1998

Carloadings of freight (excluding intermodal traffic) during the seven-day period ending September 21, 1998, increased 2.4% to 5.2 million tonnes from the

same period last year. The number of cars loaded also increased 1.9%.

Intermodal traffic (piggyback) tonnage totaled 346 000 tonnes, down 7.2% from the same period last year. The year-to-date figures show a decline of 2.8%.

Total traffic (carloadings of freight and intermodal traffic) increased 1.7% during the period. This brought the year-to-date total to 185.0 million tonnes, a decrease of 2.1% from the previous year.

All year-to-date figures have been revised.

Steel pipe and tubing

August 1998

Steel pipe and tubing production for August totalled 183 170 tonnes, a 15.6% decrease from 216 980 tonnes a year earlier.

Year-to-date production to the end of August totalled 1 643 736 tonnes, up 7.3% from 1 532 356 tonnes during the same period in 1997.


