
Department store sales and stocks

1997 and December 1997

Annual 1997 department store sales jumped 10.3% over 1996 to \$15,929.3 million. The advance was more than double those of each of the previous three years. Provincially, the annual increase in department store sales over 1996 was broadly based. Alberta (+14.0%) experienced the greatest improvement, followed by Saskatchewan (+11.6%) and Ontario (+11.2%). Manitoba (+7.8%), Nova Scotia (+7.7%) and New Brunswick (+7.6%) recorded the lowest annual increases in department store sales.

The department store sector underwent a period of restructuring between 1993 and 1994. To ensure consistent analysis, all commodity references will be based on the structure of the sector as it stood in 1994.

Sales levelled off in latter part of 1997



Women's clothing and accessories, considered as a percentage of annual sales for all departments, maintained the largest share (14.3%) despite its steady decline from 16.4% in 1994. The share of men's clothing (9.1%), on the other hand, has not changed appreciably since 1994. Boys', girls', children's and infants' wear (a 5.8% share) declined 0.5 of a percentage point.

In shares of other departments, home entertainment equipment (6.0%) increased in share by 1.0 percentage point from 1994. In contrast, furniture and major appliances (6.2%) fell 1.1 percentage

Note to readers

This is the last release of the Department store sales and stocks in its current form. Sales by province and seasonally adjusted department store sales will continue to be released. However, with the January 1998 reference month, sales by commodity will be included as part of a new Monthly Survey of Large Retailers.

points. Gains were also posted in housewares and small electrical appliances (5.5%), with a share increase of 1.1 percentage points, and toys and games (4.3%), up 0.5 of a percentage point from 1994.

Sales flat in December

Department store sales in December 1997 remained relatively unchanged from November. December sales (\$1,369.2 million seasonally adjusted) were 0.1% higher than in the previous month, the fourth consecutive month of marginal increases. Sales were 9.4% higher than in December 1996 due to strong sales increases during the first eight months of the year. Prior to the recent slowdown, sales had been generally increasing since the 1993/94 restructuring, except for a pause in the last half of 1995.

All provinces posted year-over-year sales increases (unadjusted) in December, led by Alberta (+16.0%), Saskatchewan (+12.9%), and Manitoba (+11.8%). Department stores in New Brunswick (+9.2%) and Nova Scotia (+8.7%) posted the smallest year-over-year gains.

Seasonally adjusted sales, inventory and accounts receivable data have been revised back to January 1994. Unadjusted sales for 1997 have also been revised. These revisions are now available on CANSIM, or upon request from the Retail Commodity Section, Distributive Trades Division.

Railway carloadings

Seven-day period ending January 21, 1998

Carloadings of freight (excluding intermodal traffic) during the seven-day period ending January 21, 1998, increased 7.3% to 4.4 million tonnes from the same period of last year. The number of cars loaded increased 5.7%.

Intermodal traffic (piggyback) tonnage totalled 284 000 tonnes, down 7.3% from the same period of last year. The year-to-date figures show a decrease of 17.9%.

Total traffic (carloadings of freight and intermodal traffic) increased 6.3% during the period. This brought the year-to-date total to 12.8 million tonnes, up 9.1% from the previous year.

All year-to-date figures have been revised.

Steel pipe and tubing

December 1997

Steel pipe and tubing production for December totalled 197 461 tonnes, a 27.9% increase from 154 424 tonnes a year earlier.

Year-to-date production to the end of December 1997 totalled 2 443 975 tonnes, up 14.2% from 2 140 739 tonnes during the same period in 1996.

Footwear statistics

Fourth quarter 1997

Manufacturers produced 4,708,692 pairs of footwear in the fourth quarter of 1997, up 13.3% from the 4,154,500 pairs produced in the same quarter a year earlier.

January-to-December 1997 production totalled 18,911,294 (revised) pairs of footwear, up 8.7% from

the 17,392,230 pairs produced during the same period in 1996.

Apartment building construction price indexes

Fourth quarter 1997

The price index for apartment building construction rose 0.3% to 127.9 (1986=100) in the fourth quarter of 1997 over the previous quarter, and 2.1% over the fourth quarter of 1996.

Ottawa registered the highest quarterly change (+0.7%), followed by Calgary (+0.6%), Toronto and Edmonton (+0.3%), Montréal and Vancouver (+0.2%), and Halifax (+0.1%).

Note: The apartment building construction price indexes provide an indication of new construction cost changes in seven major urban areas across Canada (Halifax, Montréal, Ottawa, Toronto, Calgary, Edmonton and Vancouver). Besides the city indexes and seven city composites there are further breakdowns of cost changes by trade groups within the building (structural, architectural, mechanical and electrical). These price indexes are derived from surveys of general and special trade group contractors who report on the categories of costs (material, labour, equipment, taxes, overhead and profits) relevant to the detailed construction specifications included in the surveys.


