### Railway carloadings

Nine-day period ending June 30, 1998

Carloadings of freight (excluding intermodal traffic) during the nine-day period ending June 30, 1998, increased 3.1% to 6.1 million metric tonnes from the same period last year. The number of cars loaded increased 1.9%.

Intermodal traffic (piggyback) tonnage totalled 447 000 metric tonnes, up 14.5% from the same period last year. The year-to-date figures show a decline of 4.2%.

Total traffic (carloadings of freight and intermodal traffic) increased 3.8% during the period. This brought the year-to-date total to 129.2 million metric tonnes, an increase of 1.3% from the same period in 1997.

All year-to-date figures have been revised.

#### Oils and fats

May 1998

Production of all types of deodorized oils in May totalled 95 317 tonnes, down 13.2% from 109 818 (revised) tonnes in April. At the end of May 1998, year-to-date production totalled 524 349 (revised) tonnes, up 5.6% from 496 582 tonnes a year earlier.

The domestic sales of deodorized margarine oil totalled 8 223 tonnes, deodorized shortening oil totalled 28 613 tonnes, and deodorized salad oil totalled 29 383 tonnes in May 1998.

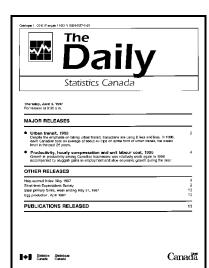
