Department store sales and stocks June 1998

Department store sales were down 4.9% in June (\$1,348.9 million seasonally adjusted) compared with May (\$1,419.0 million). This follows a 1.3% (revised) decline in May 1998. Part of the sales decline can be attributed to the closure of a number of department store locations in June. June was the third consecutive month of decreasing department store sales — the first time this has occurred since the first quarter of 1993.

On a year-over-year basis, seasonally adjusted sales were 1.8% higher in June compared with the same month a year earlier. This compares with double-digit year-over-year increases for most of 1997 and the first four months of 1998.

Unadjusted for seasonality, department store sales were 0.8% higher in June compared with June 1997. Alberta (+6.7%) and Saskatchewan (+2.7%) led the provinces in year-over-year sales gains. British Columbia, the Yukon and the Northwest Territories (-1.4%), Quebec (-0.8%) and New Brunswick (-0.1%)

saw sales decline in June 1998 compared with the same month a year earlier.

Note: The procedure for revising previously released department store data is being changed, effective with this release. The raw data will be revised for the previous month, when new information is made available to Statistics Canada. The seasonally adjusted data will be revised for the previous three months (i.e., seasonally adjusted data have been revised for March, April and May, as part of the June data release). This change, which is being implemented for all data previously released for 1998, will bring department store revision practices in line with other monthly retail trade surveys.

Domestic sales of refined petroleum products

June 1998 (preliminary)

Sales of refined petroleum products totalled 7 734 900 cubic metres in June, up 1.8% from the same month a year earlier. Sales increased for four of the seven major product groups over the same period in 1997. The largest increases were recorded for heavy fuel oil (+70 700 cubic metres or +12.9%), diesel fuel oil (+55 500 cubic metres or +3.1%) and motor gasoline (+54 400 cubic metres or +1.7%). The sales of "other refined products" declined in June (-47 100 cubic metres or -4.9%). This product group contains products such as asphalt, stove oil, petroleum coke and lube oils.

Year-to-date sales of refined petroleum products were up 1 152 000 cubic metres or 2.6% over the same period in 1997. Sales increased for five of the seven major product groups. The advance for heavy fuel oil (+633 500 cubic metres or +18.2%) was mainly due to greater use of the product for electricity generation. Favorable retail prices contributed to increased consumption of motor gasoline (+563 900 cubic metres or +3.2%). As a result of milder temperatures since the beginning of 1998, sales of light fuel oil, usually in demand during the heating period, fell 16.7% (-554 200 cubic metres).

Steel primary forms

Week ending July 25, 1998 (preliminary)

Steel primary forms production for the week ending July 25, 1998 totalled 279 378 metric tonnes, down 4.8% from the week-earlier 293 416 tonnes and down 4.9% from the year-earlier 293 678 tonnes. The cumulative total at the end of the week was

9 252 407 metric tonnes, a 7.1% increase compared with 8 637 187 tonnes for the same period in 1997.


